	<p>5. Jersey Gas Works site; development by Andium Homes Limited (P.144/2017)</p> <p>Noting that P.114/2017 had been lodged on 21st November 2017, the Panel asked for further information to be requested from the Minister for Treasury and Resources on the financial implications of the proposals.</p>	

	<p>6. Strengthening Accountability</p> <p>The Panel noted receipt of a letter from the Chief Minister dated 24th November 2017 enclosing a confidential Council of Ministers paper on this matter.</p> <p>The Panel agreed to accept an offer from the Chief Minister to brief it on the proposals and asked the Officer to communicate its preferred date to the Chief Minister.</p>
