Explanatory Note regarding subordinate legislation tabled at this meeting.

R&O.137/2013.

This Order gives effect to Commission Implementing Regulation (EU) No. 915/2013 of 23 September 2013 (OJ L 252, 24.9.2013, p. 23). That Regulation amends Council Regulation (EC) No. 314/2004 concerning certain restrictive measures in respect of Zimbabwe, by removing the Zimbabwe Mining Development Corporation from the list in Annex III of entities whose funds are frozen.

The Order also gives effect to Council Regulation (EU) No. 517/2013 (OJ L 158, 10.6.2013, p. 1), which added a website for Croatia to the list of websites of competent authorities in Annex II to Regulation (EC) No. 314/2004.

The Order was made on 23rd October 2013 and came into force on 24th October 2013.

R&O.138/2013.

This Order increases the fee payable on an application to register or renew the registration of a lodging house. From 1st December 2013 the fee will be $\pounds 13.00$ multiplied by the maximum number of persons proposed to be lodged, except for children under the age of 5 years, where the fee does not apply.

The fee was last increased on 1st December 2012, when the amount to be multiplied was set at £12.67. The fee of \pounds 13.00 represents a 2.5% increase on the fee set for 2012.

The Order was made on 24th October 2013 and will come into force on 1st December 2013.

R&O.139/2013.

This Order increases, with effect from 1st April 2014, the hourly rate of the minimum wage. *Article 1* amends Article 2 of the Employment (Minimum Wage) (Jersey) Order 2007 to substitute the amounts of the hourly rates which may be paid to (respectively) an employee, a trainee, or a trainee who has completed 12 months' approved training. *Article 2* provides for the citation of this Order, and for its commencement.

The Order was made on 25th October 2013 and comes into force on 1st April 2014.

R&O.140/2013.

Article 1 amends the Schedule to the Taxation (Exchange of Information with Third Countries) (Jersey) Regulations 2008 by amending the date upon which the tax information exchange agreement between Jersey and France came into force, this date being 11th October 2010.

Article 2 sets out the title of this Order and provides that it will come into force forthwith.

- 8. The Minister for Transport and Technical Services will answer the following question asked by Senator A. Breckon –

"Can the Minister identify who received grants from the Community Safety Fund in the years 2007 to 2010 (inclusive) and for what purposes?"

9. The Minister for Treasury and Resources will answer the following question asked by Senator A. Breckon –

"Given that the Chairman of the Jersey Development Company mentions in the Annual Report for 2012 (R.29/2013 refers) that the Jersey College for Girls site "has been derelict for over 12 years" and that "a planning application will be made early in 2013, with construction likely to begin following the granting of a planning consent", can the Minister provide details of the progress of this development and explain the cause of the delay of approximately 150 homes on this site?"

10. The Chief Minister will answer the following question asked by Deputy R. G. Le Hérissier of St. Saviour –

"Would the Chief Minister identify the departments who do not have an effective succession planning policy in place and would he elaborate on how "effectiveness" is measured and/or assessed?"

11. The Chief Minister will answer the following question asked by Deputy R. G. Le Hérissier of St. Saviour –

"Would the Chief Minister state the number of employment licences still in use, by economic sector, and clarify whether such licences can be withdrawn before their expiry date and, if not, can he identify what steps he is proposing to prevent such licences exacerbating the unemployment situation?"

12. The Minister for Planning and Environment will answer the following question asked by Deputy J.H. Young of St. Brelade –

"Will the Minister inform the Assembly of the number of additional dwelling units in the Island which have been given planning approval and building construction completed for each of the last three decades since population targets and projections were first considered by the States in the early 1980's?"



- 13. The Chief Minister will answer the following question asked by Deputy J.A. Hilton of St. Helier -
 - (a) Would the Chief Minister provide members with a table showing the number of licences held by companies and the type of licences held for the period January 2010 until July 2013 inclusive?
 - (b) Comparing statistics for the period January 2010 until July 2013 would the Chief Minister show by year the number of licences which came up for renewal where the number of non-local licences has been reduced?
 - (c) Does the Chief Minister have evidence that companies inflated the number of non-local licences originally applied for but never used and, if so, how many have had their non local licences reduced and by how many?
 - (d) Of the new applications received during the period January 2010 until July 2013, how many applied for non local licences, how many were granted and for what type of businesses?
 - (e) How many companies hold registered licences? How many of those companies have been reviewed in the past three years and how many non local/registered licences have been removed, if any?
 - (f) Since the Control of Housing and Work Law came into force, how many licences have been reviewed? How many licences have had their Registered category reduced and, if none, the reason why?
- 14. The Minister for Treasury and Resources will answer the following question asked by Deputy G.C.L. Baudains of St. Clement –

"Would the Minister, as representative of the shareholder, advise the number of JT customers who have usually paid their 'phone bill by cheque and who will need to seek alternatives when JT removes this option? Would the Minister further explain why this payment option is being removed?"

15. The Minister for Treasury and Resources will answer the following question asked by Deputy M.R. Higgins of St. Helier –

"Will the Minister advise members of -

- (a) the commencement date for the Danwood Managed Print Contract and the date at which it will end;
- (b) details of any break clauses;
- (c) details of what will happen if Danwood or Sharp are unable to continue with the contract due to company failure;
- (d) the States liability under the contract, if any, with SG Finance?

Will the Minister agree to release the part of the BDO Report that was redacted relating to the Standstill Clauses?"

16. The Minister for Treasury and Resources will answer the following question asked by Deputy M.R. Higgins of St. Helier –

"Will the Minister advise members of the total number of print copies made internally by each States Department during the calendar year 2012, broken down into department and the cost of these copies against each department?"
