Intellectual Property (Unregistered Rights) (Works of Foreign Provenance) (Amendment No. 2) (Jersey) Order 2020.

This Order amends the Intellectual Property (Unregistered Rights) (Works of Foreign Provenance) (Jersey) Order 2012 which makes provision in relation to the application of the Intellectual Property (Unregistered Rights) (Jersey) Law 2011.

The amendments flow from the consequences of the United Kingdom leaving the European Union with a relevant deal, and the need to make updated provision about certain unregistered intellectual property rights in view of the ramifications of the deal.

The amendments come into force only when (and if) the European Union (United Kingdom Exit – Miscellaneous Amendments) (Jersey) Regulations 2019 are commenced by an Order which would bring into force other provisions for an exit with a deal. The Order also repeals the Intellectual Property (Unregistered Rights) (Works of Foreign Provenance) (Amendment) (Jersey) Order 2019, which would have been brought into force if the United Kingdom had left the European Union without a relevant deal (and is therefore no longer needed).

The main effect of the amendments is to ensure that the UK continues to be treated appropriately in Jersey if it is not an EU Member State or an EEA State. So, whilst EEA States will continue to be qualifying countries for the purposes of the Intellectual Property (Unregistered Rights) (Jersey) Law 2011 and their nationals will continue to be qualifying persons, the amendments ensure that the UK will also continue to be a qualifying country and British citizens will continue to be qualifying persons.

The Order was made on 22nd January 2020 and comes into force in accordance with Article 17.

"Will the Minister provide an update on the work being done in respect of policy on assisted dying, including what further work is anticipated for this year, and state when it is expected the work will be completed?"

16. The Minister for Children and Housing will table an answer to the following question asked by Deputy K.G. Pamplin of St. Saviour –

"Will the Minister advise members what improvements have been made to the delivery of services by the Child and Adolescent Mental Health Services (C.A.M.H.S.) since the completion of the Scrutiny Review of mental health services by the Health and Social Security Scrutiny Panel, particularly any improvements arising as a result of the Target Operating Model and the transfer from the Department of Health and Community Services to the Department of Children, Young People, Education and Skills?"

17. H.M. Attorney General will table an answer to the following question asked by Deputy K.G. Pamplin of St. Saviour –

"Will H.M. Attorney General advise what legal provision, if any, there is in Jersey for 'bereavement leave' of any kind; and, if there exists such provision, is he aware of how it compares with the corresponding situation in the U.K.?"

18. The Minister for Economic Development, Tourism, Sport and Culture will table an answer to the following question asked by Deputy K.G. Pamplin of St. Saviour –

"Will the Minister provide an update on the work undertaken in relation to changing the arrangements for the distribution of charity grants from Channel Islands Lottery funding, since the proposals to contract a company to administer the distribution of funds were withdrawn last year; and will he state when this work will be completed?"



19. The Chair of the Privileges and Procedures Committee will table an answer to the following question asked by Deputy K.G. Pamplin of St. Saviour –

"What work will be required to ensure the implementation of all of the aspects of 'Electoral Reform 2020' (P.126/2019), subject to the Assembly's approval; and will this work include a proposal to move the next election from May to October?"

20. The Minister for Economic Development, Tourism, Sport and Culture will table an answer to the following question asked by Deputy S.M. Ahier of St. Helier –

"Will the Minister advise the Assembly of –

- (a) the total number of scratch cards sold by the Channel Islands Lottery for each of the last five years;
- (b) the total value of these scratch cards; and
- (c) the number of Christmas Lottery tickets sold during the same period?"
