## **DRAFT BOATS AND SURF-RIDING (CONTROL) (AMENDMENT No. 27) (JERSEY) REGULATIONS 200**

### **REPORT**

---

These Regulations are intended as a means of maintaining information for sea rescue purposes, organising mooring space, checking insurance and promoting safety at sea depending upon the type of craft.

The Committee's policy remains as that placed before the States over the last 3 years, namely an increase in line with the retail price index. This is in order to ensure that the cost of administering registration is covered and that no cross subsidisation occurs from Harbour dues and other areas of harbour trading. The vast majority of craft dealt with under the Boats and Surf-riding regulations are used for leisure. The increase is estimated to be £1,440.

For inspection duties it is proposed that the hourly staff cost be applied.

The proposed fee amendments concern the following –

Regulation 2: annual registration of surfboards ('things' used in the surf).

Regulation 3B: annual registration of sailboards.

(Note: the agreement with Surf and sailboard Clubs and Associations demonstrating satisfactory third party insurance cover for members continues so as to waive the registration fee).

Regulation 5: once only registration of owners of boats over 8 feet in length.

Regulation 10: annual fee for survey and inspection of boats for hire.

Regulation 11: annual fee for issue and granting of a licence to boats for hire.

Regulation 22: annual fee for issue and granting of a licence to passenger boat for hire.

Regulation 28: annual fee for speedboat registration.

## **Explanatory Note**

---

These Regulations increase by 4.8% (rounded up to the nearest 50p) the fees for registering and issuing certificates and licences for surf boards, sail boards, boats, speedboats and other craft. The fees were last increased on 1st January 2004. If made, these Regulations shall come into force on 1st January 2005.

**THE STATES**, in pursuance of Article 4 of the Harbours (Administration) (Jersey) Law 1961, <sup>[1]</sup> have made the following Regulations –

---

### **1 Interpretation**

In these Regulations, “principal Regulations” means the Boats and Surf-Riding (Control) (Jersey) Regulations 1969. <sup>[2]</sup>

### **2 Regulation 2 amended**

In Regulation 2(4) of the principal Regulations for the amount “£14.50” there shall be substituted the amount “£15.00”.

### **3 Regulation 3B amended**

In Regulation 3B(2) of the principal Regulations for the amount “£14.50” there shall be substituted the amount “£15.00”.

### **4 Regulation 5 amended**

In Regulation 5(2) of the principal Regulations for the amount “£14.50” there shall be substituted the amount “£15.00”.

### **5 Regulation 10 amended**

In Regulation 10(2)(a) of the principal Regulations for the amount “£39.06” there shall be substituted the amount “£40.00”.

### **6 Regulation 11 amended**

In Regulation 11(2) of the principal Regulations for the amount “£16.75” there shall be substituted the amount “£17.00”.

### **7 Regulation 22 amended**



In Regulation 22(2) of the principal Regulations for the amount “£16.75” there shall be substituted the amount “£17.00”.

**8 Regulation 28 amended**

In Regulation 28(1) of the principal Regulations for the amount “£14.50” there shall be substituted the amount “£15.00”.

**9 Citation and commencement**

These Regulations may be cited as the Boats and Surf-Riding (Control) (Amendment No. 27) (Jersey) Regulations 200- and shall come into force on 1st January 2005.
