## Explanatory Note regarding subordinate legislation tabled at this meeting.

#### R&O.65/2010.

This Order amends the Bee Diseases Control (Jersey) Order 1992 with the effect that Varroasis ceases to be a notifiable disease.

The Order was made on 6th July 2010 and came into force on 7th July 2010

#### R&O.66/2010.

This Order amends the Taxation (Double Taxation) (Jersey) Regulations 2010 so as to insert the date that the Double Taxation Agreement with Malta enters into force (19th July 2010).

The Order was made on 7th July 2010 and came into force on 14th July 2010.

#### R&O.67/2010.

This Order amends the Social Security (Determination of Claims and Questions) (Jersey) Order 1974 with the effect that the administrative functions of the Registrar of Appeals to the Social Security Tribunal are discharged by the Judicial Greffier instead of by a States' employee appointed by the Minister for Social Security.

The Order was made on 9th July 2010 and came into force on 16th July 2010.

#### R&O.68/2010.

Under this Order, the Jersey Battle of Flowers Association –

- (a) may close public roads, and use them, for the purpose of holding the Battle of Flowers on Thursday 12th August 2010 and the Moonlight Parade on Friday 13th August 2010;
- (b) may restrict traffic on public roads for the same purpose;
- (c) has to give public notice of the closures and restrictions; and
- (d) has to take out public liability insurance.

The Order was made on 9th July 2010 and came into force on being made.

## R&O.69/2010.

The object of this Order is to allow certain roads to be closed and used on, before and after Thursday, 19th August 2010 for holding the annual Gorey Fête, and to set out certain conditions to be respected, and certain powers that may be exercised, in relation to the event.

The Order was made on 9th July 2010 and came into force on being made.

*Article 1* defines the "principal Order" as the Community Provisions (Restrictive Measures – North Korea) (Jersey) Order 2007.

Article 2 amends the interpretation provisions in the principal Order. It inserts a reference to Council Regulation (EU) No. 1283/2009. It updates references to the EU Common List of Military Equipment to the 2010 edition of that list and points readers to the source of list (the current reference to the list is deleted by Article 3(b) while Article 15 revokes Annex 3 which reproduced the 2007 version of the list). It also inserts "targeted programmes" as a term to cover North Korea's nuclear and other programmes.

Article 3(with Articles 13 and 14) extends the prohibited items to include all dual-use and military items, as well as those related to North Korea's nuclear and related programmes.

Article 4prohibits the obtaining, as well as providing, of technical assistance and financing.

Article 5 allows information to be required on items carried by aircraft and vessels related to North Korea, and prohibits servicing of vessels believed to be carrying prohibited items.

Article 6updates cross-references to include new provisions.

Article 7(with Articles 16 and 17) updates the persons and bodies whose funds are frozen.

Article 8updates cross-references and substitutes references to dates of designation.

Article 9 requires reporting by credit and financial institutions of suspicious transactions with institutions domiciled in North Korea.

Article 10 protects from liability those who did not know, and had no reasonable cause to suspect, that their actions would infringe the prohibitions on provision of finance.

Article 11updates cross-references to include new provisions.

Article 12extends the scope of the Order to any business done in whole or in part in Jersey.

Article 13 and Schedule 1 substitute Annex 1 to the principal Order – see Article 3

Article 14and Schedule 2add a new Annex 1A to the principal Order- see Article 3

Article 15revokes Annex 3 to the principal Order- see Article 2

Article 16and Schedule 3substitute Annex 4 to the principal Order– see Article 7.

Article 17 and Schedule 4 add a new Annex 4A to the principal Order- see Article 7.

Article 18 names the Order and brings it into force 7 days after it is made.

The Order was made on 12th July 2010 and comes into force on 19th July 2010.

#### R&O.70/2010.

This Order imposes restrictive measures on dealings in respect of the Republic of Guinea, having regard to Council Regulation (EU) No. 1284/2009 of 22 December 2009, as amended to 2 April 2010.

Article 1contains definitions, including "brokering services", "funds" and "technical assistance".

Part 2 imposes restrictions in relation to military goods and to equipment usable for internal repression.

Article 2 imposes restrictions on export, technical assistance, brokering services and financing in relation to equipment that could be used for internal repression. The equipment is listed in *Schedule 1*, which follows a standard content for a number of Council Regulations.

Article 3 imposes similar restrictions on services related to military goods and technology listed in the Common Military List of the European Union (as updated on 15 February 2010).

Article 4 allows the Chief Minister to give authorizations derogating from the restrictions in the previous 2 Articles, mainly in relation to European Union and United Nations operations.

Article 5 exempts protective clothing for use by personnel of the European Union, United Nations and similar bodies.

Part 3imposes restrictions, subject to derogations, on funds related to the "National Council for Democracy and Development".

Article 6 freezes the funds and economic resources of members of the "National Council for Democracy and Development", and related persons and bodies, listed in *Schedule 2* which reproduces the list provided by the Council of the European Union.

*Article* 7allows the Chief Minister to give authorizations derogating from the freezing of funds for the purpose of basic and related needs.

Article 8 allows the Chief Minister to give authorizations derogating from the freezing of funds subject to prior liens or judgments.

Article 9allows some credits to be made to frozen accounts, if they are reported to the Chief Minister (and they are then frozen).

Article 10 protects those who freeze funds under this Part in good faith and without negligence.

Part 4imposes duties to provide relevant information to the Chief Minister.

Article 11 imposes a duty to supply information to facilitate compliance with the Order, particularly when funds are frozen.

Article 12allows the Chief Minister (or those authorized by him or her) to request information, documents, copies and explanations for facilitating compliance. The request must be complied with (but cannot cover privileged communications with legal advisers).

Article 13 restricts the Chief Minister's use of information provided, but allows co-operation with European bodies.

Part 5 contains offences and minor provisions.

Article 14 creates offences. Breach of the provisions on internal repression equipment, military goods and information, and intentionally providing false documents or destroying documents, are punishable with an unlimited fine, up to 2 years imprisonment, or both. Failure, without reasonable excuse, to comply with a request for information under *Article 12* is punishable with an unlimited fine, up to 3 months imprisonment, or both.

Article 15allows the Chief Minister to delegate functions.

Article 16 limits the application of the Order to cases with connections with Jersey.

Article 17 gives the short title of the Order and provides for it to come into force the day after it is made.

The Order was made on 12th July 2010 and came into force on 13th July 2010.

## WRITTEN QUESTIONS

1. The Minister for Housing will table an answer to the following question asked by Senator F. du H. Le Gresley-

"Would the Minister advise why he has chosen to delegate to his Chief Officer the power to agree to the eviction of States tenants due to rent arrears or other breaches of the tenancy agreement?

Will the Minister give exact details of how many tenants currently have rent arrears and the total amount of rent arrears outstanding?

Can the Minister advise whether his Department is on course to achieving the 2010 Business Plan target of reducing the percentage of rent arrears to 1.6 percent of gross rental income and, if not, whether he intends to use the power of eviction more frequently in the future or whether, in the current economic climate, he will exercise a more sympathetic stance?"

2. The Minister for Economic Development will table an answer to the following question asked by the Deputy of St. John–

"Following the announcement that a Board is proposed for the Airport and Harbours, will the Minister advise whether any meetings have been held with a Shadow Board/group of people to discuss the setting up of an interim Board, and if so would he provide details, including who was present, and advise whether any politicians (current or former) were also present?"

3. The Minister for Planning and Environment will table an answer to the following question asked by Senator B.E. Shenton –

"Given that Page 53 of the Annex to Financial Reports and Accounts 2009 states that £625,618 was transferred from the contingency vote to settle a planning appeal claim, can the Minister please give full details of this claim, and the total cost?"

4. The Minister for Economic Development will table an answer to the following question asked by the Deputy of Grouville –

"Would the Minister advise what has happened to the sculpture known as 'Flight' that was in the Airport Departure Hall and included a wishing well which was used by visitors and residents, the monies from which was then given to charities.

Would he also advise whether all other charity boxes have been removed from the Airport and, if so, explain why and confirm when they might be returned?"

5. The Minister for Economic Development will table an answer to the following question asked by the Deputy of Grouville –

"What measures and conditions, if any, is the Minister planning to lay down when Waitrose takes over certain outlets from Sandpiper, that they should support local produce?"

6. The Minister for Housing will table an answer to the following question asked by the Deputy of Grouville –

"Would the Minister advise whether persons arrested on arrival in the Island, who are then sentenced to more than 11 years at H.M.P. La Moye, can actually gain their Housing Qualifications whilst in Prison whilst never having worked in the Island or had any real connection to it?"

7. The Chief Minister will table an answer to the following question asked by the Deputy of St. Mary–

"Can the Chief Minister outline what has been done since the approval of the Strategic Plan in respect of the three commitments in section 8 (to encourage community involvement and voluntary service, work with the Parishes to develop community initiatives and preserve, enhance and promote community values)?"

8. The Chief Minister will table an answer to the following question asked by the Deputy of St. Mary–

"Following on from the comments to P.71 from the Chief Minister, will be formally undertake to publish, by department, salaries in bands of £5000?

Further, to aid States members as they consider efficiency savings in the public sector, and to help the public to understand "where the money goes", will the Minister also undertake to publish, by department, organisation charts which show, in outline, who does what within each department?"

9. The Minister for Planning and Environment will table an answer to the following question asked by the Deputy of St. Mary-

"Further to his answer to written question 5517 on 6th July 2010, would the Minister confirm that the report, when published, will include the latest research/findings/consensus on peak oil and its likely social and economic effects and that it will give references to the documents and reports it cites?"

10. The Minister for Treasury and Resources will table an answer to the following question asked by the Deputy of St. Mary–

"Given that in his written answer 5520 on 6th July 2010, the Minister claimed that 64% of the 2% cuts were efficiency savings and 36% were service reductions, would the Minister provide for members a listing of the 2% reductions in expenditure, classified under these two headings?"

11. The Minister for Transport and Technical Services will table an answer to the following question asked by the Deputy of St. Mary-

"Following his written answer 5515 on 6th July 2010, in which the Minister advised that 11km of highway was of high priority for maintenance, can he explain what that means and advise whether there are cost implications and/or implications for the safety of road users if the work is not undertaken. Furthermore would he advise what the statutory position is regarding the Department's task to maintain the Island's roads in a safe condition?"

12. The Chairman of the Comité des Connétables will table an answer to the following question asked by Deputy M. Tadier of St. Brelade–

"Will the Chairman advise how many formal complaints there have been against honorary officers (with a breakdown by parish) in the last two years (2008 and 2009) and how many were upheld, and what the rank of officer against whom the complaint was brought was?

Will the Chairman advise if the Constable is involved in anyway in the complaints/disciplinary process of any complaints of misconduct or other wrong doing of honorary police officers, and if so how?

If there is involvement, will the Chairman explain in what capacity and under what authority this involvement takes place?

Will the Chairman give the names of the six Connétables who still hold warrant cards and if there has been any discussion on the Comité of the appropriateness of Connétables having these?"

13. The Chairman of Privileges and Procedures Committee will table an answer to the following question asked by Deputy M. Tadier of St. Brelade–

"Will the Chairman advise if she is aware of any other national assembly, other than Jersey's, which has representatives who are police officers, and, if so, will she list them?

Will the Chairman advise if the Privileges and Procedures Committee will investigate whether it is best practice for police officers to be permitted to sit in the States Assembly as voting members?"

14. The Chairman of the Privileges and Procedures Committee will table an answer to the following question asked by Deputy M. Tadier of St. Brelade–

"Following the recommendation in the recent report of the Public Election Working Group to change the opening hours of the polls from 8am to 9am, will the Chairman advise whether any analysis was undertaken on the potential reduction this would have on voter turn out before this recommendation was made and can she advise whether this is something the Committee unanimously supports?"

15. The Minister for Economic Development will table an answer to the following question asked by Deputy M. Tadier of St. Brelade–

"Will the Minster advise if there are any remaining creditors of Woolworths Plc yet to be paid?

How many creditors were there in total and how many of the creditors who made claims were paid and how many were not?

What proportion of these were Jersey creditors and what proportion were not?

Can the Minister confirm that local creditors are not being given preference over non local creditors?"

16. The Minister for Economic Development will table an answer to the following question asked by Deputy M. Tadier of St. Brelade–

"Given the Assembly's commitment to the diversification of the Island's industries in the Strategic Plan, and the need for new growth areas in these times of economic uncertainty, will the Minister advise if he would support the idea of Vodka production in the Island and, if so, what steps he will take to bring this about?

17. The Minister for Home Affairs will table an answer to the following question asked by the Deputy of St. John-

"Would the Minister advise on whose instructions it was that Operation Blast was instigated and whether the instructions came from outside or within the Island?

If from off-Island was it from UK Security Services or elsewhere?

What action, if any, is to be taken to notify a member of the content of any file held on them?

What action, if any, will the Minister take against the instigator and can he confirm that the files are now closed?"

18. The Minister for Economic Development will table an answer to the following question asked by the Deputy of St. John–

"Given that berth holders were told the Marina would be closed from January 2010 for alterations, has the income for winter contracts dropped in comparison to last winter and, if so, by how much?

When will the proposed works be undertaken or has the work been abandoned?

Is the Minister satisfied with the take up of large super yacht moorings, and, if so, could he share with members what progress, if any, has been made in accommodating such vessels 12 months of the year?"

19. The Chief Minister will table an answer to the following question asked by Deputy T.M.. Pitman of St. Helier–

"Will the Chief Minister clarify the full reasons as to why the report into the issues surrounding the suspension process of the Chief Officer of the States of Jersey Police – promised to the Assembly to be completed in six weeks – has instead not been completed prior to the announcement that all disciplinary measures were to be dropped; further still, when will this report be completed and made available in full to all States Members?"

20. The Minister for Home Affairs will table an answer to the following question asked by Deputy T.M. Pitman of St. Helier—

"Would the Minister confirm whether he has allowed the development and disseminating of information to the public of only critical evidence against the suspended Chief Officer of the States of Jersey Police whilst simultaneously accepting and supporting an investigation process that refused to receive or include evidence and witnesses that could contradict such evidence and, if so, does the Minister feel this to be congruent to the fundamental principles of natural justice?

Would the Minister further inform members whether he considers it correct in terms of natural justice that, having announced the abandonment of disciplinary action against the Chief Officer of the States of Jersey Police, he subsequently sought to use evidence from these inquiries to justify the suspension when the Chief Officer of the States of Jersey Police will himself have no right of reply?"

21. The Minister for Economic Development will table an answer to the following question asked by Deputy T.M. Pitman of St. Helier–

"Given that anti-social behaviour late at night by young car drivers and motorcyclists has been a problem since at least August 2006 and continues to impact on residents of the Albert Quay Apartments, will the Minister advise whether there is any obstacle preventing the designation and sign posting of the area approaching the Lifeboat Café as a 'restricted access' area between the hours of 9.00pm to 6.00am; further still, will he support such a move and ensure that it is implemented over the course of the summer?"

22. The Minister for Treasury and Resources will table an answer to the following question asked by Deputy

#### T.A. Vallois of St. Saviour-

"Could the Minister advise the exact amounts of income received per year from the taxes that were introduced as a result of the 2004 Fiscal Strategy Review?"

23. The Minister for Economic Development will table an answer to the following question asked by Deputy T.A. Vallois of St. Saviour—

"Given that a structural deficit cannot be met with spending cuts and increases in taxation alone, could the Minister advise what strategy he will be putting in place to achieve sustainable economic growth?"

24. The Minister for Treasury and Resources will table an answer to the following question asked by Deputy T.A. Vallois of St. Saviour—

"Given that under Priority 4 of the Strategic Plan 2009-2014, it was agreed that the Treasury and Resources department would "examine whether borrowing is an alternative and optional way forward for long-term capital projects", could the Minister explain the current status of this examination and whether this has been considered throughout the spending review?"

25. The Minister for Health and Social Services will table an answer to the following question asked by Deputy R.G. Le Hérissier of St. Saviour-

"Would the Minister advise what the weekly cost of employing the interim Hospital Director is, showing a distinction between salary and other costs?"
