DRAFT INCOME SUPPORT (AMENDMENT No. 12) (JERSEY) REGULATIONS 201-

REPORT

1. Summary

The proposed amendments to the Income Support (Jersey) Regulations 2007 facilitate the introduction of the Income Support (Special Payments) (Child Personal Care) (Jersey) Regulations 201- (P.135/2014). This separate proposition creates a mechanism whereby the parents of children that meet the requirements for the highest levels of the Income Support personal care impairment award can always receive a payment in respect of the care needs of the child, independently of parental income. These Regulations are also supported by a related Order that makes changes to the Income Support (General Provisions) (Jersey) Order 2008.

2. Function of Regulations

In order for the Income Support (Special Payments) (Child Personal Care) (Jersey) Regulations 201- to make a payment independent of household income, the proposed amendments change paragraph 6 of Schedule 1 of the Income Support (Jersey) Regulations 2007 so that only adults are eligible to receive the Personal Care level 2 and Personal Care level 3 components.

The Income Support (Special Payments) (Child Personal Care) (Jersey) Regulations 201- replace this entitlement in respect of children with an independent Special Payment that is set to the value of Personal Care level 2 or, where applicable, Personal Care level 3. Apart from income, they maintain the same qualifying criteria as specified in the Income Support Regulations.

3. Financial and manpower implications

The Department has £22,000 (full year cost) of funding available to meet the additional cost of providing PC3 on a consistent basis to all children that qualify for this highest level of support. This funding has been identified as part of the overall project to create £3 million savings within the income support budget in 2014.

The Department will submit a growth bid to MTFP2 in respect of funding for a PC2 benefit and associated administration from 2016 onwards. The estimated cost of this is $\pounds 470,000$ per annum.

Funding for 2015 lies outside the current MTFP budget and will need to be identified from departmental underspends or from the use of a contingency budget. In addition to the ongoing annual cost of £470,000 for 2015 an estimated £100,000 of additional implementation costs will need to be met, a total of £570,000.

One additional FTE will be required to maintain these claims.

Explanatory Note

These Regulations amend paragraph 6 of Schedule 1 to the Income Support (Jersey) Regulations 2007. Paragraph 6 specifies when a member of a household is entitled to the personal care element of income support, and the rate at which it is payable.

Regulation 1 is an interpretation provision.

Regulation 2 removes the entitlement to the personal care element in the case of a child who is assessed as having a score of 56 or more. In accordance with *Regulation 4(2)*, this amendment will come into force on the same day as the Income Support (Special Payments) (Child Personal Care) (Jersey) Regulations 201-(P.135/2014).

Regulation 3 removes the entitlement to the personal care element in the case of a child who is assessed as having a score of at least 36 but less than 56. In accordance with *Regulation 4(3)*, this amendment will come into force on 1st January 2015.

Regulation 2 provides for the citation and commencement of these Regulations.

THE STATES, in pursuance of Articles 5 and 18 of the Income Support (Jersey) Law 2007¹, have made the following Regulations –

1 Interpretation

In these Regulations, a reference to a paragraph 6 is a reference to paragraph 6 of Schedule 1 to the Income Support (Jersey) Regulations 2007².

2 Removal of personal care element for child having score of at least 56

(1) In paragraph 6(1), for the words "who qualifies in accordance with this paragraph." there shall be substituted the words –

"if he or she is -

- (a) an adult or child who has the score described in subparagraph (3)(a);
- (b) an adult or child who has the score described in subparagraph (3)(b); or
- (c) an adult who has the score described in sub-paragraph (3)(c) and who is not receiving long-term care.".
- (2) In paragraph 6(3)(c) delete the words "where the member of the household is not receiving long-term care".

3 Removal of personal care element for child having score of at least 36 but less than 56

In paragraph 6(1)(b) delete the words "or child".

4 Citation and commencement

(1) These Regulations may be cited as the Income Support (Amendment No. 12) (Jersey) Regulations 201- .

- (2) Regulations 1 and 2 and this Regulation shall come into force on the same day as Regulation 3 of the Income Support (Special Payments) (Child Personal Care) (Jersey) Regulations 201-³.
- (3) Regulation 3 shall come into force on 1st January 2015.
