### **Explanatory Note**

These Regulations would have the following effect -

- (a) to increase the registration fee for a surf or sail board from £3.00 to £3.50;
- (b) to increase to £12.00 the fee payable for the registration of a boat or a speedboat;
- (c) to increase the fees payable for the inspection, for survey purposes, of boats plying for hire, to £11.40 per half hour (to the nearest half hour) for each person engaged on the inspection;
- (d) to increase the licence fee for a boat plying for hire to £13.70.

The Regulations would come into effect on 1st January 1999.

**THE STATES**, in exercise of the powers conferred on them by Article 4 of the Harbours (Administration) (Jersey) Law 1961,<sup>1</sup> as amended, have made the following Regulations -

1. In paragraph (4) of Regulation 2 of the Boats and Surf-Riding (Control) (Jersey) Regulations 1969,<sup>2</sup> as amended<sup>3</sup> (hereinafter referred to as “the principal Regulations”) for the words “three pounds” there shall be substituted the words “three pounds fifty pence”.

2. In paragraph (2) of Regulation 3B of the principal Regulations for the words “three pounds” there shall be substituted the words “three pounds fifty pence”.

3. In paragraph (2) of Regulation 5 of the principal Regulations for the words “eleven pounds and seventy pence” there shall be substituted the words “twelve pounds”.

4. In sub-paragraph (a) of paragraph (2) of Regulation 10 of the principal Regulations for the words “ten pounds ninety pence” there shall be substituted the words “eleven pounds forty pence”.

5. In paragraph (2) of Regulation 11 of the principal Regulations for the words “thirteen pounds ten pence” there shall be substituted the words “thirteen pounds seventy pence”.

6. In paragraph (1) of Regulation 28 of the principal Regulations for the words “eleven pounds and seventy pence” there shall be substituted the words “twelve pounds”.

7. These Regulations may be cited as the Boats and Surf-Riding (Control) (Amendment No. 17) (Jersey) Regulations 1998 and shall come into force on the first day of January 1999.
