REPORT

The Connétables (Miscellaneous Provisions) (Jersey) Law 2012 (“the Law”) was adopted by the States on 16th May 2012, sanctioned by Order of Her Majesty in Council on 17th October 2012 and registered by the Royal Court on 26th October 2012. As the Law was adopted by the States 2 years ago, members may wish to refer to the covering Report at [P.36/2012](#) which explains its purpose and provisions.

The Law provides, *inter alia*, for the repeal of the policing functions of the Connétables, empowers a Procureur du Bien Public to deputise for a Connétable in certain circumstances, removes certain other functions from the Connétables, and makes ancillary and consequential amendments. The Law was adopted with a view to implementing an earlier decision of the States taken in the light of recommendations made in the Report arising from the review carried out under the Chairmanship of Sir Cecil Clothier K.C.B., Q.C., presented to the States on 23rd July 1996.

Article 7 of the Law confers wide powers on the States to make Regulations to repeal or amend legislation, including Laws sanctioned by Her Majesty in Council, which confer any policing function on a Connétable. The Draft Connétables (Miscellaneous Provisions – Consequential Amendments) (Jersey) Regulations 201- (lodged as P.78/2014) contain the repeals and amendments contemplated by Article 7 of the 2012 Law. The report accompanying those draft Regulations also sets out the background to the 2012 Law.

It is proposed that the Law be brought into force on 1st August 2014.

Financial and manpower implications

There are no financial or manpower implications for the States or the parishes arising from the adoption of this draft Act.

Explanatory Note

This Act brings the Connétables (Miscellaneous Provisions) (Jersey) Law 2012 into force on 1st August 2014.
