Telecommunications Law Amendment (Jersey) Commencement Order 2024.

Minister for Sustainable Economic Development.

This Order brings the Telecommunications Law (Jersey) Amendment Regulations 2024 (the "Regulations") partially into force on 1 October 2024.

The Regulations insert new Part 5A (Articles 24A to 24ZI and Schedules 1-3) into the Telecommunications (Jersey) Law 2002 (the "Law").

In brief -

- Articles 24A to 24J relate to designated vendor directions. They enable the Minister for Sustainable Economic Development (the "Minister") to designate vendors who supply goods, services or facilities to providers of public electronic communications networks ("PECN") and providers of public electronic communications services ("PECS"), if the Minister considers the designation is necessary in the interests of the security of Jersey. The Minister may then issue a designated vendor direction to providers of PECN, providers of PECS and any person who makes associated facilities available for use in an electronic communications network or service, imposing requirements on them with respect to their use of the designated vendor's goods, services or facilities.
- Schedule 1 contains compliance and enforcement provisions relating to designated vendor directions.
- Articles 24K to 24Z relate to security duties. They impose duties on the providers of PECN and PECS, requiring them to take steps to identify and mitigate the risks of security compromises occurring in relation to their PECN or PECS, and to take steps in response to any security compromise that occurs.
- Schedule 2 contains compliance and enforcement provisions relating to the security duties.
- Articles 24ZA to 24ZI are general provisions and provisions relating to both designated vendor directions and security duties. They include, for example, provisions about appeals and a provision enabling the Jersey Competition Regulatory Authority (the "JCRA") to require information for the purposes of carrying out its functions under the Law.
- Schedule 3 contains compliance and enforcement provisions relating to the JCRA's power to require information.

This Order commences provisions in the Regulations that –

- insert Articles 24A to 24J (the designated vendor provisions) and Schedule 1;
- insert Articles 24ZA to 24ZI (the general provisions) and Schedule 3; and
- make consequential amendments to the Law.

But this Order does not commence provisions in the Regulations that insert Articles 24K to 24Z (the security duties provisions), Schedule 2, or provisions in Articles 24A, 24ZA, 24ZC, 24ZF and 24ZI that only relate to the security duties provisions.

The Order was made on 16 September 2024 and came into force on the same day.

  - (c) at what threshold a reduction in the grant to the Social Security fund would have a long-term impact on the ability of the Social Security fund to provide the support it is set up to deliver?"
- 26. The Minister for the Environment tabled an answer on 23rd September 2024 to the following question asked by Deputy J. Renouf of St. Brelade –

"Further to the response to Oral Question 155/2024, will the Minister advise –

- (a) when and why work on the West of Island Master plan was removed from the work programme;
- (b) what, if anything, has replaced it;
- (c) when he considers work on the West of Island Master plan will commence, further to the response to Written Question 40/2024;
- (d) the reasons behind the delay in the St. Brelade's Bay Improvement Plan and when it will now be delivered; and
- (e) the basis for the lack of communication to the elected representatives of St. Brelade for the aforementioned delay?"

- (b) how many pupils are expected to receive funding this year;

- (e) what plans, if any, he has to uplift the Jersey Premium allocation in 2025, in addition to any inflation increase.

Will he further advise how many pupils in receipt of Jersey Premium are eligible for free school meals and how many receive free school meals?"

- (e) whether there is any reporting on where and how funds are spent?"

- (c) the total budget allocated in 2025 and 2026 to manage the consequences of the move to a living wage?"

  - "Will the Minister provide

      - ii. Secondary school students pre GCSE selection;
      - iii. Secondary school student at GCSE;
      - iv. A-level French students:
    - (b) the number of hours of French language tuition each student receives per term, broken down by each group in (a) above;
    - (c) the grades achieved by Jersey students in GCSE and A-level French language examinations for each of the last ten years; and
    - (d) details of all other languages available to students, including Jersey-French, the level up to which these can be studied, and the amount of time allocated to non-French language tuition in schools?"

- (d) whether there is a policy or guidance in place which sets any limits on the type of role or work which can be undertaken for the Government by an individual who does not reside in Jersey; and
- (e) whether he is considering a review as to whether the current arrangements where individuals are employed by the Government of Jersey, through any structure, whilst not being resident or ordinarily resident in Jersey are appropriate, and if not, why not?"
- 47. The Minister for the Environment tabled an answer on 30th September 2024 to the following question asked by Deputy D.J. Warr of St. Helier South
  - "Further to the response to a Freedom of Information request which reported that as of the 1st of August 2024, of the 8,817 rented dwelling licences that had been issued, none had been to any of the social housing providers, will the Minister confirm whether all social housing providers have now had licences issued, and if not, why not?"
- 48. The Minister for Children and Families tabled an answer on 30th September 2024 to the following question asked by Deputy D.J. Warr of St. Helier South
  - "Will the Minister advise the level of funding included within the proposed Budget (Government Plan) 2025-2028 for the provision of a new youth facility on the Ann Street Brewery site, whether this funding has changed and when he anticipates delivery of the facility?"

Discretion is exercised by the Presiding Officer in accordance with guidance issued by the Bailiff, following consultation with the Privileges and Procedures Committee. The current guidance was presented to the States in the report 'Time Limits on Speeches in Debates: Guidance on the Exercise of Discretion' (R.3/2021). The report states that discretion may be exercised to allow for a longer speech than 15 minutes where the member speaking is designated as the 'main respondent' to the debate.
