Deputy Imogen Stephanie Nicholls of Grouville asked Senator Reginald Robert Jeune, President of the Policy Resources Committee, the following questions -

- ``1. Would the President confirm whether -
  - (a) the United Nations Covenant on

Civil and Political Rights has been ratified for Jersey? and

- (b) the United Nations International Covenant on Economic, Social and Cultural Rights has been ratified for Jersey?
- 2. Would the President clarify when and by whom the decisions whether these Covenants should be ratified for Jersey were made?
- 3. Would the President confirm whether Jersey has accepted the equal pay for equal work provision (that is equal pay for men and women) contained under Article 7 of the International Covenant on Economic, Social and Cultural Rights?
- 4. Would the President clarify when and by whom the decision to accept, or derogate from, Article 7 was taken?
- 5. Would the President -
  - (a) confirm whether Jersey has been included in the ratification of the United Nations Convention on the Elimination of All Forms of Discrimination against Women? and
  - (b) clarify when and by whom the decision whether or not to include Jersey in the ratification was made?
- 6. Having indicated in the 1994 Strategic Policy Report and Action Plan that a comprehensive list will be compiled of all international conventions and treaties that apply to Jersey, would the President think it appropriate in view of the approaching 50th Anniversary of the Liberation to produce this information in booklet form for the use of the general public?"

The President of the Policy and Resources Committee replied as follows -

``1. The United Kingdom deposited its Instrument of Ratification to both Covenants on 20th May 1976. At

this time, both Covenants were extended to the Island.

- 2. The two Covenants were considered by the Legislation Committee during the period 6th September 1974 to 20th February 1976. (For your information, that Committee had responsibility for such matters until the creation of the Policy and Resources Committee in 1989). The Legislation Committee was advised by the Law Officers of the Crown that neither Covenant had a territorial application clause. Consequently, the Covenant applied ipso facto to Jersey on ratification by H.M. Government.
- 3. Jersey accepted Article 7 of the International Covenant on Economic, Social and Cultural Rights. At the time of ratification the United Kingdom submitted, on behalf of the Jersey and the other dependent territories, a reservation to the effect that the United Kingdom Government reserved the right to postpone the application of sub-paragraph (i) of paragraph (a) of Article 7, in so far as it concerns the provision of equal pay to men and women for equal work in the private sector.
- 4. The decision to request the reservation was taken by the Legislation Committee at a meeting on 20th February 1976 after consultation with Her Majesty's Law Officers.
- 5. (a) Jersey has requested that the United Nations Convention on the Elimination of All Forms of Discrimination Against Women should not be extended to the Island;
  - (b) the above decision was made by the Legislation Committee on 19th May 1986, the matter having originally been referred to it by the Bailiff on 31st October 1985. An Act of the Legislation Committee dated 16th December 1985 comments on the fact that it had spent a considerable amount of time on this subject, the Act also stating that -

'Having noted that acceptance of the Convention would require the enactment of legislation and the establishment of tribunals etc., the Committee decided it would not wish to commit the Island to enacting lengthy complex legislation on the lines of the United Kingdom Sex Discrimination and Equal Pay Acts, with the resultant administrative costs to the Island'.

6. As indicated in paragraph 9.28 of the 1994 Strategic Policy Review and Action Plan the task of compiling a list of international conventions and agreements to which the Island is party is currently under way. Indeed, the Committee is financing the employment of a temporary member of staff within the States Greffe to undertake this work.

The compilation of a single comprehensive database on international agreements and conventions in so far as they affect Jersey is the Committee's firm intention. There are still gaps in our information which need to be filled (with the assistance of Her Majesty's Government).

Certain information on conventions and agreements is already available to the public by enquiring at the States Greffe. With regard to the future, the Committee will in due course be looking at the various options available on how to publish this information, so that it can be freely and easily accessed by the general public."
