- (i) the cash limit for the Overseas Aid Committee shall be increased from £2,700,000 to £2,835,000, and to request the Finance and Economics Committee to reduce the amount to be allocated to the general reserve in the 1998 Budget accordingly;
- (ii) consideration be given to making a further increase once the Overseas Aid Committee has completed its present review and has submitted a 3 year Business Plan as part of its 5 year Strategic Plan to the States during 1998."

THE STATES, adopting sub-paragraph (b) of paragraph (2), as amended -

(b) approved the cash limits for each of the non-trading committees for 1998 as set out in Appendix 4.2, except that -

- (i) the cash limit for the Overseas
 Aid Committee should be
 increased from £2,700,000 to
 £2,835,000, and the Finance and
 Economics Committee requested to
 reduce the amount to be
 allocated to the general reserve
 in the 1998 Budget accordingly;
- (ii) consideration be given to making a further increase once the Overseas Aid Committee had completed its present review and had submitted a 3 year Business Plan as part of its 5 year Strategic Plan to the States during 1998.

Adjournment

THE STATES then adjourned, having agreed that consideration of the remaining paragraphs of the proposition on the Strategic Policy Review and Action Plan 1997 (P.149/97) should stand over until after the public business set down for Tuesday 18th November 1997 and that, if necessary, the States would also meet on Wednesday, 19th November 1997.
