# Explanatory Note regarding subordinate legislation tabled at this meeting.

#### R&O.89/2014.

This Order amends the Community Provisions (Restrictive Measures – Central African Republic) (Jersey) Order 2014 to give effect in Jersey to Council Implementing Regulation (EU) No 691/2014 of 23 June 2014 (OJ L 183/6, 24.6.2014) implementing Article 17(1) of Regulation (EU) No 224/2014 concerning restrictive measures in view of the situation in the Central African Republic. The effect is to place 3 persons on the list of those whose funds and economic resources are frozen (until this amendment that list was empty).

The Order was made on 2nd July 2014 and came into force forthwith.

#### R&O.90/2014.

This Order further amends the Community Provisions (Restrictive Measures – Syria) (Jersey) Order 2012, to give effect in Jersey to Council Implementing Regulation (EU) No 693/2014 of 23 June 2014 (OJ L 183/15, 24.6.2014) implementing Regulation (EU) No 36/2012 concerning restrictive measures in view of the situation in Syria. The effect of the amendment is to add 12 persons to the list of those whose funds and economic resources are frozen (and to update the information relating to one such person).

The Order was made on 2nd July 2014 and came into force forthwith.

#### R&O.91/2014.

This Order gives effect in Jersey to the Council Regulation (EU) No. 692/2014 of 23 June 2014 (O.J. No. L 183/9, 24.6.2014) concerning restrictions on the import into the Union of goods originating in Crimea or Sevastopol, in response to the illegal annexation of Crimea and Sevastopol.

The Council Regulation also prohibits the provision (whether directly or indirectly) of financing or financial assistance as well as insurance and reinsurance related to the import of goods originating in Crimea ad Sevastopol.

The Order was made on 2nd July 2014 and came into force forthwith.

## R&O.92/2014.

This Order further amends the Community Provisions (Restrictive Measures – Libya) (Jersey) Order 2011 ("the 2011 Order") to give effect in Jersey to Council Implementing Regulation (EU) No. 689/2014 of 23 June 2014 (OJ No. L 183, 24.6.2014, p.1) (referred to below in this Note as the "first Council Regulation") and to Council Regulation (EU) No. 690/2014 (OJ No. L 183, 24.6.2014, p.3) (the "second Council Regulation"), both amending Regulation (EU) No. 204/2011 concerning restrictive measures in view of the situation in Libya.

The effect of the first Council Regulation is to substitute the entry in relation to one entity, and to delete entries in relation to two others, in Annex III to Regulation (EU) No. 204/2011. The effect of the second Council Regulation is to create additional offences in connection with the shipping of crude oil from Libya and in particular an offence of financial transactions in relation to crude oil from Libya aboard designated vessels. (A definition of the term "designated vessels" is also inserted by the second Council Regulation.) Article 4 of the 2011 Order is therefore amended to add penalties for these new offences (*Article 2*).

This Order comes into force immediately upon being made (Article 3).



The Order was made on 2nd July 2014 and came into force forthwith.

#### R&O.93/2014.

Article 1 of this Order adds to the list of drugs in Parts 1, 2 and 3 of Schedule 2 to the Misuse of Drugs (Jersey) Law 1978 (the "Law") which specifies drugs which are controlled as Class A, B and C drugs respectively under that Law. Part 4 of that Schedule is amended so as to define the meaning of the expression "Khat" which is now classified as a Class C controlled drug. In addition, Ketamine is reclassified as a Class B drug (formerly Class C).

Article 2 adds to the list of drugs in Part 1 of the Schedule to the Misuse of Drugs (Designation) (Jersey) Order 1989, which designates controlled drugs under the Law which are restricted from production, possession and use.

Article 3 adds to the lists of drugs that are Schedule 1 drugs, Schedule 2 drugs or Schedule 4 drugs under the Misuse of Drugs (General Provisions) (Jersey) Order 2009, which are subject to requirements concerning their supply on prescription and to be recorded in a register.

Article 4 gives the title to this Order and states that it will come into force 7 days after it is made.

The Order was made on 2nd July 2014 and came into force on 9th July 2014.

"Could the Minister explain what action, if any, has been taken to establish a pedestrian crossing at Miladi farm, to include reference to:-

- a) the timeline of expected completion;
- b) any drawings that are currently underway and any consultation with residents or the Parish which has or will be undertaken?"



4. The Chief Minister will table an answer to the following question asked by Deputy M.R. Higgins of St. Helier -

"Will the Chief Minister request the Viscount to publish all of the guidance material relating to the publication of a 'désastre' issued by the Viscount's Office, together with the protocols governing the publication of information about a bankrupt's finances, including when the information can be given out and who can receive this information stating further when this guidance was promulgated and last changed?"

5. The Chief Minister will table an answer to the following question asked by Deputy M.R. Higgins of St. Helier -

"Further to the response given on 17th June 2014, will the Chief Minister set out for members the number of people who have applied for registration cards under the new Control of Housing and Work (Jersey) Law 2012, breaking down the numbers into the nationality and country of origin for all those who have applied during the first full year of its operation?"

6. The Minister for Economic Development will table an answer to the following question asked by Deputy M.R. Higgins of St. Helier -

"Will the Minister provide members with the following information regarding the Jersey Gambling Commission for each year since it was formed:

- a. the number and type of gambling licences issued;
- b. the revenue received from these licences broken down into each category;
- c. the number and type of external gambling licences issued such as those issued to firms outside the Island and the income generated from them;
- d. the amount of money expended on support for problem gamblers and how it is spent;
- e. the salaries of the board, directors and staff of the Gambling Commission; and,
- f. the number, type and cost of conferences attended by Gambling Commission directors and staff?"
- 7. The Minister for Housing will table an answer to the following question asked by Deputy G.P. Southern of St. Helier -

"Will the Minister release to members the policies under which Andium Homes operates to supply affordable housing to the people of Jersey with particular reference to the allocation of housing through the Gateway?

What differences, if any, are there between these policies and those which apply to private sector social landlords?"

8. The Minister for Treasury and Resources will table an answer to the following question asked by Deputy G.C.L. Baudains of St. Clement -

"With regard to the JEC cable laying through St Clement, would the Minister, as the shareholder representative, advise –

- (a) how long Green Road will have been closed by the time the job is completed;
- (b) whether the 8 week partial second closure of Greve d'Azette to enable the cable to be pulled through the conduit will be exceeded;
- (c) why the cable jointing trenches were not created during the conduit-laying part of the exercise;



- (d) why other sections of road are being dug up to reach conduit bends; and,
- (e) what guarantees, if any, can be given that the cables can, in fact, be pulled through the conduits and, if so, when will this happen?"
- 9. The Minister for Planning and Environment will table an answer to the following question asked by Deputy J.H. Young of St. Brelade -

"Further to his answer of 30th June 2014, in respect of the Energy Efficiency grants made by his Department, will the Minister provide the following information:

- the number and total value of grants approved under each of the criteria for eligibility for grants;
- the number and total value of grants made in respect of properties sited within each parish;
- whether details of these improvement grants are reported to the parish authorities for parish rate purposes;
- whether they are reported for income tax purposes;
- how he justifies not requiring repayment of these grants to private property owners in the event of onward sale of the sale of the properties, and
- whether he will agree to review these policies to ensure that in future, taxpayers interests are safeguarded?"
- 10. The Chief Minister will table an answer to the following question asked by Deputy J.H. Young of St. Brelade -

"Will the Chief Minister explain why he has not published a detailed report of the work of the Regeneration Steering Group following the assurances given in his reply to my question of 29th April 2014 that this would be forthcoming by the end of May 2014?

- (a) the number of meetings of the group since his election and attendances by Ministers
- (b) the subjects discussed

  - 2. Can the Minister state exactly what budget is allocated each year to asbestos removal and also indicate how much was spent on asbestos removal in the preceding five years?
  - 3. Does the Minister agree that there is no known level at which asbestos is not a risk and therefore the children are being placed unnecessarily at risk of harm?
  - 4. Given that the "Management Survey" of buildings is non-intrusive visual inspection, what steps, if any, is he taking to remove the potential risk with buildings containing ACMs?
  - 5. Can the Minister state what steps are taken to ensure that any buildings used by the Education Department but not owned by the Department do not expose staff or students to asbestos?
  - 6. Would the Minister provide the inspection reports for the years between 2008 and 2011 for all ESC sites that have asbestos?
  - 7. Can the Minister advise whether he considers that there is no risk to students and staff at Highlands College?"
- 12. H.M. Attorney General will table an answer to the following question asked by Deputy M.R. Higgins of St. Helier -
  - "Will the Attorney General state whether the Viscount is authorised to publish Income Tax information relating to a bankrupt and whether the Viscount's protocols are human rights compliant, especially with regard to Article 8 of the Convention, and, if so, will be explain why?"
- 14. The Chief Minister will table an answer to the following question asked by Deputy J.M. Maçon of St. Saviour -
  - "Will the Chief Minister produce the law drafting list for all departments including the estimated completion dates for each piece?"
