#### **REPORT**

P.52/2014 contains a statement of the purpose of these Regulations.

P.52/2014 is the proposition and report requesting the States to ratify the signed Agreement on the exchange of information relating to tax matters between the Government of Jersey and the Kingdom of Belgium.

These draft Regulations amend the Taxation (Exchange of Information with Third Countries) (Jersey) Regulations 2008 by inserting the name of the country and the taxes covered by the Agreement.

#### Financial and manpower implications

There are no financial or manpower implications for the States arising from the adoption of these Regulations.



#### **Explanatory Note**

These Regulations amend the Taxation (Exchange of Information with Third Countries) (Jersey) Regulations 2008 to give effect to a bilateral tax information exchange agreement between Jersey and Belgium.

*Regulation 1* amends the Schedule to those Regulations by inserting in the relevant place the taxes covered by the agreement with Belgium.

Regulation 2 states the title of these Regulations and would bring them into force forthwith.

#### 1 Interpretation

In the Schedule to the Taxation (Exchange of Information with Third Countries) (Jersey) Regulations  $2008^2$ , after the matter relating to Austria there is inserted the following matter –
