REPORT

The Privileges and Procedures Committee (PPC) established the Machinery of Government Sub-Committee in February 2012 in order to undertake a review of the structures and functions of government in Jersey. The Sub-Committee's final report was presented to the States Assembly by PPC on 9th September 2013 and included a series of recommendations (R.105/2013). An 'in Committee' debate was held on the recommendations contained within the report on 9th October 2013.

Following the debate, PPC agreed that a Steering Group should be formed to take forward those recommendations that had gained broad support during the debate. Following a discussion between the Steering Group and PPC on 6th March 2014, the Chief Minister offered to lodge the necessary draft Law in order to ensure that the States Assembly had an opportunity to express a view on the proposals. The Council of Ministers considered this matter on 12th March 2014, and a majority supported that the draft Law should proceed to lodging in order to ensure that the Assembly could decide upon the recommendations. The Draft States of Jersey (Amendment No. 8) Law 201- was lodged au Greffe on 18th March 2014 by the Chief Minister (P.33/2014). The draft Law and associated amendments were considered by the Assembly and adopted on 20th May 2014 (*Note: the Law was adopted as Amendment No. 7*). This Act would bring the States of Jersey (Amendment No. 7) Law 2014 into force on 15th October 2014.

Financial and manpower implications

There are no financial or manpower implications for the States arising from the adoption of this draft Appointed Day Act.

Explanatory Note

This Act would bring the States of Jersey (Amendment No. 7) Law 2014 into force on 15th October 2014. The Law was lodged as the States of Jersey (Amendment No. 8) Law 201- (P.33/2014) and adopted by the States on 20th May.
