Draft Medium Term Financial Plan Addition for 2017 – 2019 P.68/2016

THE STATES commenced consideration of the proposition of the Council of Ministers entitled 'Draft Medium Term Financial Plan Addition for 2017 – 2019' (P.68/2016).

THE STATES commenced consideration of an amendment of Deputy Geoffrey Peter Southern of St. Helier (P.68/2016) (Amendment 2) that: (1) after the words "in Summary Table B," there should be inserted the words "except that the net revenue expenditure of the Chief Minister's Department shall be increased in 2019 by £84,000 to fund the continued provision of 2 posts within the Statistics Unit."; and (2) after the words "as set out in Summary Table C", there should be inserted the words "except that the total proposed central contingency allocation for 2019 be decreased by £84,000".

THE STATES acceded to a request by Deputy Geoffrey Peter Southern of St. Helier, in accordance with Standing Order 69(4), that his amendment (P.68/2016 Amd.(2)) be withdrawn.

THE STATES, adopting the request of Deputy Geoffrey Peter Southern of St. Helier, in accordance with Standing Order 26(7), agreed to reduce the minimum lodging period in respect of his amendment to paragraph (1) of the amendment of Senator Sarah Craig Ferguson (P.68/2016 Amd.(9)), that after paragraph (ii) there should be inserted the following new paragraph and the remaining paragraphs be renumbered accordingly –

"(iii) assessing the potential additional tax revenue which could be generated from the introduction of progressive rates of tax for those households which fall into the top decile (10%) of equivalised household income;"

(1) after the words "Summary Table B", there should be inserted the words –
