Nursing Homes (2025 Fees) (Jersey) Amendment Order 2024. *Chief Minister.*

This Order amends the Nursing Homes (General Provisions) (Jersey) Order 1995.

The amendments increase by 2.5% –

- the fee payable for an application for registration by a person carrying on, or intending to carry on, a nursing home;
- the fee payable for an application for registration by another person who is, or is intended to be, in charge of a nursing home; and
- the annual fee payable by a person registered to carry on a nursing home.

The fees were last increased with effect from 1 January 2024.

The Order was made on 8 November 2024 and comes into force on 1 January 2025.

- (b) the estimated figures are still likely to be met, despite the report only being updated periodically?"
- 46. The Minister for Justice and Home Affairs tabled an answer on 11th November 2024 to the following question asked by Deputy B.B. De S.V.M. Porée of St. Helier South –

"In relation to the Island's work permit policy, will the Minister provide details of any changes and updates that have been made in the last six months for each category of worker, including the rationale and timing of any such variations?"

47. The Minister for Treasury and Resources tabled an answer on 11th November 2024 to the following question asked by Deputy P.F.C. Ozouf of St. Saviour –

"In relation to stamp duty collections, will the Minister –

- (a) provide an update on recent stamp duty collections on the sale of residential properties;
- (b) state whether the amount collected to date has met the projected target;
- (c) provide a breakdown of the types of properties expected to transact at the time of the Income Tax Forecasting Group's initial estimate; and
- (d) advise whether she considers there will be a need for any adjustments or stimulus measures to support housing transactions and stamp duty income?"

In accordance with Standing Order 104A, a time limit of 15 minutes applies to speeches made during debate, unless discretion has been exercised to allow for a longer, or shorter, time limit. No time limit applies to either speech made by the proposer.

Discretion is exercised by the Presiding Officer in accordance with guidance issued by the Bailiff, following consultation with the Privileges and Procedures Committee. The current guidance was presented to the States in the report 'Time Limits on Speeches in Debates: Guidance on the Exercise of Discretion' (R.3/2021). The report states that discretion may be exercised to allow for a longer speech than 15 minutes where the member speaking is designated as the 'main respondent' to the debate.
