R&O.55/2021.

Sanctions and Asset-Freezing (Implementation of External Sanctions) (Amendment – Corruption) (Jersey) Order 2021.

Minister for External Relations and Financial Services.

This Order amends the Sanctions and Asset-Freezing (Implementation of External Sanctions) (Jersey) Order 2021 to implement the Global Anti-Corruption Sanctions Regulations 2021 of the United Kingdom. Those Regulations revoke the Misappropriation (Sanctions) (EU Exit) Regulations 2020, and impose asset freezes and immigration sanctions on persons designated by the United Kingdom on the basis of suspected involvement in (or association with persons involved in) serious bribery or serious misappropriation of property.

The Order also ensures that, if provisions of UK sanctions Regulations are repealed and re-enacted by subsequent UK sanctions Regulations, then the references in the Sanctions and Asset-Freezing (Implementation of External Sanctions) (Jersey) Order 2021 to the repealed UK provisions are treated as references to the re-enacted UK provisions.

The Order was made on 26th April 2021 and came into force on 27th April 2021.

R&O.56/2021.

Control of Housing and Work (Exemptions) (Amendment No. 5) (Jersey) Order 2021. *Chief Minister.*

This Order amends the Control of Housing and Work (Exemptions) (Jersey) Order 2013 ("the principal Order") to implement obligations under the World Trade Organisation General Agreement on Trade in Services (GATS) relating to business visitors in Jersey for establishment purposes.

Article 1 introduces the amendments to the principal Order.

Article 2 amends Article 1 of the principal Order to add a definition of "business visitor for establishment purposes" and related definitions.

Article 3 amends Article 2 of the principal Order so that a person who is a business visitor for establishment purposes and who is in Jersey for an aggregate period of 90 days or less in any 12 month period does not need a registration card for work.

Article 4 amends Article 3 of the principal Order so that an undertaking is not required to have a business licence in respect of a business visitor for establishment purposes who is in Jersey for an aggregate period of 90 days or less in any 12 month period.

Article 5 amends Article 4 of the principal Order to disregard from the maximum numbers condition in a business licence any business visitor for establishment purposes who is in Jersey for an aggregate period of 90 days or less in any 12 month period.

Article 6 sets out the name by which the Order may be known and that it comes into force 7 days after it is made.

The Order was made on 27th April 2021 and came into force on 4th May 2021.



R&O.57/2021.

Covid-19 (Gathering Control – Sixth Extension) (Jersey) Order 2021.

Minister for Health and Social Services.

This Order amends the Covid-19 (Gathering Control) (Jersey) Order 2020, to extend the gathering control period to end at the end of Monday 31st May 2021.

This Order comes into force on 1st May 2021.

The Order was made on 28th April 2021 and came into force on 1st May 2021.

R&O.58/2021.

Covid-19 (Workplace Restrictions) (Amendment No. 11) (Jersey) Order 2021.

Minister for Health and Social Services.

This Order amends the Covid-19 (Workplace Restrictions) (Jersey) Order 2020 to remove the requirement for food and drink premises to close by 11.30 p.m. It does not remove the requirement that the food and drink (other than to take away) are consumed only while seated at a table, or the requirement for customers to wear masks indoors while not seated at a table. It also does not affect any other legal obligation to close at a certain time, such as for premises holding an alcohol licence.

The Order was made on 28th April 2021 and came into force on 30th April 2021.

R&O.59/2021.

Covid-19 (Workplace – Twenty-Second Extension) (Jersey) Order 2021.

Minister for Health and Social Services.

This Order amends the Covid-19 (Workplace Restrictions) (Jersey) Order 2020, to extend the restriction period to end at the end of Monday 31st May 2021.

This Order comes into force on 1st May 2021.

The Order was made on 28th April 2021 and came into force on 1st May 2021.

R&O.60/2021.

Pedal Cycles (Amendment No. 4) (Jersey) Order 2021.

Minister for Infrastructure.

This Order amends the Pedal Cycles (Jersey) Order 1998 ("1998 Order") by changing the requirements for a bicycle or tricycle to be classed as an "electrically assisted pedal cycle" and not a "motor vehicle" under the Road Traffic (Jersey) Law 1956.

Article 1 is an interpretation provision.

Article 2 amends definitions in the 1998 Order including updating references to technical standards.

Article 3 amends the requirements with which an electrically assisted bicycle or tricycle must comply to enable it to be excluded from the definition of "motor vehicle" in the Road Traffic (Jersey) Law 1956. Article 3 removes the current requirement specifying a maximum weight for the vehicle and increases the maximum speed at which the motor can propel the vehicle from 15 miles per hour to 15.5 miles per hour. The maximum power output of the motor remains unchanged at 250 watts.



Article 4 amends the requirements concerning when an electrically assisted bicycle or tricycle can be ridden on a road or cycle track. Alternative provision is made to the existing requirement for such a cycle to be fitted with a plate showing the battery voltage and continuous motor output as defined in British Standard 1727: 1987. Instead such a pedal cycle may be visibly and durably marked showing the maximum speed at which it can be propelled by a motor and the maximum motor output. Article 4 also updates the requirements for braking systems to refer to the relevant 2014 British Standard in place of the current reference to the relevant 1981 British Standard.

Article 5 sets out the name of this Order and provides for it to come into force 7 days after the day it is made.

The Order was made on 28th April 2021 and came into force on 5th May 2021.

R&O.61/2021.

Sanctions and Asset-Freezing (Implementation of External Sanctions) (Amendment – Myanmar) (Jersey) Order 2021.

Minister for External Relations and Financial Services.

This Order amends the Sanctions and Asset-Freezing (Implementation of External Sanctions) (Jersey) Order 2021 to implement the Myanmar (Sanctions) Regulations 2021 of the United Kingdom, which replace the Burma (Sanctions) (EU Exit) Regulations 2019.

The Order was made on 29th April 2021 and came into force on 30th April 2021.

R&O.62/2021.

Covid-19 (Screening, Assessment and Isolation – Authorised Officers) (Jersey) Order 2021. *Minister for Health and Social Services*.

This Order makes provision for a States' employee who is employed as a Covid Safe Officer, a Senior Covid Safe Officer or a Team Manager Covid Safe to be treated as an authorised officer for the purpose of the Covid-19 (Screening, Assessment and Isolation) (Jersey) Regulations 2020, when the States' employee is carrying an appropriate identification card.

The Order was made on 30th April 2021 and came into force on 1st May 2021.

R&O.63/2021.

Covid-19 (Workplace Restrictions) (Amendment – Enforcement Officers) (Jersey) Order 2021. *Minister for Health and Social Services*.

This Order amends the Covid-19 (Workplace Restrictions) (Jersey) Order 2020 to add provision for a States' employee who is employed as a Covid Safe Officer, a Senior Covid Safe Officer or a Team Manager Covid Safe to be an enforcement officer for the purpose of the Covid-19 (Workplace Restrictions) (Jersey) Regulations 2020, when the States' employee is carrying an appropriate identification card.

The Order was made on 30th April 2021 and came into force on 1st May 2021.



R&O.64/2021.

Planning and Building (General Development) (Amendment No. 7 – Covid-19) (Jersey) Order 2021. *Minister for the Environment*.

This Order amends Part 9 of Schedule 1 to the Planning and Building (General Development) (Jersey) Order 2011, which gives general permission for temporary development in respect of emergency medical and related facilities for government to deal with the Covid-19 pandemic.

The effect of the amendment is to add a further year to the limitation of time for the developments and changes of use of land, allowing the facilities which have been temporarily created to remain in place until May 2022.

The Order was made on 4th May 2021 and came into force on 5th May 2021.

R&O.65/2021.

Covid-19 (Workplace Restrictions and Gathering Control) (Amendment No. 6) (Jersey) Order 2021. *Minister for Health and Social Services*.

This Order makes further relaxations to the restrictions imposed as a consequence of Covid-19.

Article 1 amends the Covid-19 (Workplace Restrictions) (Jersey) Order 2020 to remove the final category of workplace which had to be closed for all purposes, namely jacuzzies, plunge pools, steam rooms, saunas, Turkish baths, and the like. These workplaces are now able to open for all purposes.

Article 2 amends the Covid-19 (Gathering Control) (Jersey) Order 2020. The definition "open air" is amended to include structures open on half of their sides. The restriction on gathering in private gardens is extended to cover 50 people aged 5 and over for outdoor wedding and civil partnership receptions as well as celebrations. There are now no limits on numbers gathering in private gardens previously hired out or booked for hire by non-family members before the Order came into force. These provisions apply to all outdoor spaces associated with homes, including marquees or other temporary structures placed there.

Article 3 provides for how the Order is to be cited and for it to come into force on 10th May 2021.

The Order was made on 7th May 2021 and came into force on 10th May 2021.

"Will the Chair advise the Assembly of the number of Government employees who have been referred for counselling per month over the past 3 years, broken down to show the number referred through the AXA scheme and the number of direct referrals?"

32. The Minister for Health and Social Services tabled an answer on 11th May 2021 to the following question asked by Deputy M.R. Le Hegarat of St. Helier –

"Will the Minister advise members –

- (a) how diabetes services are being refashioned following the grant of £1 million to Diabetes Jersey;
- (b) whether this grant money came from the Jersey Care Model (J.C.M.) funding; and



- (c) why the community diabetes pilot that was instigated before the J.C.M., and that was planned to be the blueprint for future chronic disease monitoring in the community, has not been developed further and expanded to include other long-term conditions?"
- 33. The Minister for Health and Social Services tabled an answer on 11th May 2021 to the following question asked by Deputy M.R. Le Hegarat of St. Helier –

"Will the Minister advise -

- (a) how much money from the Health Insurance Fund has been allocated directly to existing community services since the inception of the Jersey Care Model; and
- (b) what proportion of this funding has actually been spent?"
- 34. The Assistant Chief Minister tabled an answer on 11th May 2021 to the following question asked by the Connétable of St. John –

"Will the Minister update members on the position of a permanent Project Director for the Our Hospital project, advising in particular –

- (a) whether a permanent appointment has been made;
- (b) what difference, if any, there is between the cost (including salary) of employing a permanent Director and that of engaging an Interim Director;
- (c) what companies have been used for the recruitment process;
- (d) the timeline for the latest recruitment process; and
- (e) if no such appointment has been made to date, how this features on the Project's Risk Register?"
- 35. The Minister for Health and Social Services tabled an answer on 11th May 2021 to the following question asked by the Connétable of St. John –

Will the Minister inform members of –

- (a) the status of the Scientific and Technical Advisory Cell (S.T.A.C.) minutes from the 19th Meeting, held between 7th and 16th September 2020;
- (b) the reason for the delay in publication of these minutes;
- (c) the date by which the minutes will be published;
- (d) the dates upon which the Emergencies Council, Competent Authorities Ministers and Council of Ministers each received a copy of these minutes; and
- (e) whether or not other States Members have received these minutes?
- 36. The Assistant Chief Minister tabled an answer on 11th May 2021 to the following question asked by Deputy S.M. Ahier of St. Helier –

"Will the Minister inform the Assembly of the total cost to date of advertising the Our Hospital Project across print, broadcast and online media channels, and the available budget allocated to such advertising?"

37. The Chair of the States Employment Board tabled an answer on 11th May 2021 to the following question asked by Senator S.C. Ferguson –



"Will the Chair inform members of –

- (a) the total number of civil servants currently employed in the civil service;
- (b) the number of staff equivalent to civil servants currently employed in the States whollyowned subsidiaries:
- (c) the number of new posts created in the past 6 months within both the civil service and wholly-owned subsidiaries;
- (d) the job descriptions of any such new posts;
- (e) the number of civil service employees who have left the service in the past 6 months; and
- (f) the number of civil service equivalent employees in the wholly-owned subsidiaries who have left in the past 6 months?"
- 38. The Minister for Home Affairs tabled an answer on 11th May 2021 to the following question asked by Deputy M. Tadier of St. Brelade –

"Will the Minister advise whether or not the Independent Monitoring Board for H.M.P. La Moye has the ability to perform unannounced visits, and if so, will he provide a list of dates upon which unannounced inspections have been made since the Board's inception; and if no such unannounced inspections have been made, is the Minister in a position to explain why not?"

"Will the Minister provide details of the I.T. budget for the Jersey Care Model; and provide a breakdown of how it is being spent on verifiable, community-related activity?"



43. The Chair Of the Comité Des Connétables tabled an answer on 11th May 2021 to the following question asked by Deputy M. Tadier of St. Brelade –

"Will the Chair advise how many dog licences have been issued this year and how many had been issued by this time last year, providing this information broken down by Parish?"

44. The Minister for Housing and Communities tabled an answer on 11th May 2021 to the following question asked by Deputy M.R. Higgins of St. Helier –

"Will the Minister state what actions have been taken to date, and what further action he proposes to take, to ensure that a Digital Register of Commercial and Residential Properties will be introduced in the Island before the end of 2021, in accordance with what was agreed by the Assembly in adopting P.93/2020?"

45. The Minister for Treasury and Resources tabled an answer on 11th May 2021 to the following question asked by Deputy M.R. Higgins of St. Helier –

Will the Minister publish a list of all grants and / or loans paid to businesses, companies, not-for-profit organisations and charities to assist with the financial impact of the Covid-19 pandemic to date, broken down by -

- (a) the amount paid;
- (b) the dates on which payment was made; and
- (c) the type of aid provided (e.g. Co-Funded Payroll Scheme);

and, furthermore, will the Minister set out any other forms of indirect financial aid which these organisations received (for example, in the form of delayed G.S.T. payments) during the same time period?

46. The Minister for the Environment tabled an answer on 11th May 2021 to the following question asked by Deputy I. Gardiner of St. Helier –

"Will the Minister advise whether the St. Helier Open Space Survey of 2018 included analysis of access to open spaces in relation to specific areas of St. Helier – for example, by Vingtaine, the Ring Road, the North of Town; and, if so, will he provide a breakdown of the quality standards and access standards in all such areas in relation to the 5 typologies, namely parks, play space, outdoor sports facility, amenity greenspace and natural greenspace?"

47. The Minister for Children and Education tabled an answer on 11th May 2021 to the following question asked by Deputy I. Gardiner of St. Helier –

"Will the Minister advise what standards are currently used for the provision of outdoor space per pupil in primary schools in Jersey; and to what extent do Janvrin, Rouge Bouillon, Springfield and St. Luke's Schools comply with these standards?"

- (b) how many pupils, if any, are unable to attend school in their catchment area because of such capacity issues;
- (c) what criteria are used to determine the catchment area for a school; and
- (d) when the school catchment areas were last reviewed?"
