2. Deputy R.G. Le Hérissier of St. Saviour will ask the following question of the Minister for Home Affairs –

"Given the appointee's chairmanship of Jersey Finance, would the Minister advise whether the issue of any conflict of interest in his appointment as the Chairman of the Police Authority was considered by the Appointments Commission and, if so, why was it decided that the appointment should proceed?"



3. Deputy J.A. Hilton of St. Helier will ask the following question of the Minister for Planning and Environment –

"Has the Minister or any member of his Planning Applications Panel met or spoken with the management team of the Channel Islands Co-operative Society to discuss their planning application for Pitt Street/Dumaresq Street without Planning Officers being present?"

4. Deputy M. Tadier of St. Brelade will ask the following question of the Minister for Treasury and Resources –

"How many Tax Information Exchange Agreement requests, if any, have been received from the French tax authorities since the agreement was set up and how many have we been able to comply with fully?"

5. Deputy G.P. Southern of St. Helier will ask the following question of the Minister for Social Security –

"Will the Minister state how many Household Medical Accounts (HMA) currently exist in Income Support and inform members what progress, if any, he has made, in conjunction with the Minister for Health and Social Services, towards drafting policies to ensure access to primary health care provision for those on low incomes or those with chronic health care needs and, if none, why not?"

6. The Connétable of St. Helier will ask the following question of the Chairman of the Privileges and Procedures Committee –

"Would the Chairman advise whether the Privileges and Procedures Committee is intending to continue its investigation into whether certain recommendations of the Carswell Report should be implemented and, if not, why not?"

7. Deputy G.C.L. Baudains of St. Clement will ask the following question of the Minister for Transport and Technical Services –

"With regard to the closing-off of a section of Snow Hill car park, would the Minister advise whether, despite the area being fenced off for the whole of July, only approximately 2 days' work was undertaken in that time and, if so, given that expensive plant machinery, such as a crane, spent considerable idle time on site, would the Minister confirm that the tender was competitively priced?"

8. Deputy J.H. Young of St. Brelade will ask the following question of the Minister for Planning and Environment –

"Will the Minister explain the reasons for the delay in signing a Planning Obligation agreement following his decision to approve development at Plémont Holiday Village on 23rd November 2012, advise how and by whom the agreement was drafted, whether its terms have been thoroughly reviewed and whether he has personally reviewed and is entirely satisfied that the agreement completely fulfils the environmental promises which were publicly made by the applicant?"

9. The Connétable of St. John will ask the following question of the Minister for Health and Social Services –

"Can the Minister give the number of occasions over the last 24 months that recommendations have been made for Cancer Patients to be given Cabazitaxel, giving details of the numbers approved and declined, and of those declined, the reason for so doing, and whether the patients' General Practitioners were consulted in reaching this decision, and if not, why not?"



10. Deputy J.H. Young of St. Brelade will ask the following question of the Minister for Housing -

"Does the Minister concur with the Planning Inspector's conclusions, in the report published on 27th August 2013 in respect of the refused application for sheltered housing in St. Ouen (MD-PE-2013-0095), that there is no evidence of local need for sheltered housing available and, if not, what action will he take to provide that information to the current Island Plan review in respect of all parish housing needs?"

11. Deputy J.A. Hilton of St. Helier will ask the following question of the Minister for Health and Social Services –

"Can the Minister inform members whether any discussions have taken place with clinicians from the hospital and medical community on the continuing use of the Liverpool Care Pathway and, if so, could she advise members the outcome of those discussions?"

"Why has the UK Justice Minister been requested to intervene regarding Jersey's placement on the French tax 'black list'?"

Explanatory Note regarding subordinate legislation tabled at this meeting.

R&O.121/2013.

This Order amends the Employment (Redundancy – Maximum Weekly Amount) (Jersey) Order 2011 so as to increase from $\pounds 650$ to $\pounds 660$ the weekly amount to be taken into account for calculating a statutory redundancy payment. The increase takes effect from 1st October 2013.

The Order was made on 6th September 2013 and comes into force on 1st October 2013.

R&O.122/2013.

Article 1 amends the Schedule to the Taxation (Double Taxation) (Jersey) Regulations 2010 by inserting the dates upon which the double taxation agreements between Jersey and Guernsey, Jersey and the Hong Kong Special Administrative Region of the People's Republic of China and Jersey and the Isle of Man came into force. These dates are 9th July 2013, 3rd July 2013 and 10th July 2013 respectively.

Article 2 sets out the title of this Order and provides that it will come into force forthwith.

The Order was made on 6th September 2013 and came into force on being made.

R&O.123/2013.

Article 1 amends the Schedule to the Taxation (Exchange of Information with Third Countries) (Jersey) Regulations 2008 by inserting the dates upon which the tax information exchange agreements between Jersey and Japan and Jersey and Turkey came into force. These dates are 30th August 2013 and 11th September 2013 respectively.

Article 2 sets out the title of this Order and provides that it will come into force on 11th September 2013.

The Order was made on 6th September 2013 and comes into force on 11th September 2013.

R&O.124/2013.

This amending Order analogously amends the Teachers' Superannuation (New Members) (Jersey) Order 2007 (the "New Members Order") under Part 1 of this Order, and the Teachers' Superannuation (Existing Members) (Jersey) Order 1986 (the "Existing Members Order") under Part 2, together referred to as the "Superannuation Orders".

The amendments concern the arrangement to convert a teacher's or former teacher's entitlement to a very small pension, into a cash lump sum based on the value of his or her benefits which have accrued in the Teacher's Superannuation Fund (the "Fund"). This arrangement is also known as a "commutation of a trivial pension".

Currently, Article 34 of the New Members Order provides that the Fund's Management Board has the discretion, on a teacher's retirement, to commute for a lump sum payment, 100% of any pension which is a trivial pension, i.e. a sum of not more than £104 per year, or such greater amount as may be specified by the Comptroller of Taxes. And, where a teacher dies (whether in retirement or not), any person entitled to receive contingent benefits under the scheme, may at the discretion of the Management Board, have any trivial pension to which he or she is entitled commuted into a lump sum payment.

Up until 1st January 2009 the amount specified by the Comptroller was £520 per year (instead of £104). Since that date the Comptroller has withdrawn that specified amount and the sum of £104 per year now applies in default.

At present there are no trivial commutation provisions under the Existing Members Order.

The Income Tax (Superannuation Funds) (Jersey) Order 1972 (the "1972 Order") provides for the treatment of commuted pension benefits for income tax purposes in respect of tax approved pension



schemes. The sum of £520 per year that was previously specified by the Comptroller has in effect been superseded by sums prescribed in the 1972 Order. That Order provides for the income tax treatment in certain cases of lump sums representing commuted benefits valued up to £5,000 and £30,000.

The amendments will -

- (1) align the New Members Order with the associated provisions in the 1972 Order so as to provide for the circumstances in which a trivial pension, subject to a maximum amount prescribed in the 1972 Order, can be commuted into a lump sum payment upon retirement or leaving service (if earlier); and
- (2) in respect of the Existing Members Order, introduce new commutation provisions dealing with small pensions analogous to those in the New Members Order, as amended by this Order.

Articles 1 and 5 are the interpretation provisions which identify each of the Superannuation Orders that are respectively amended under Parts 1 and 2 of this Order.

Articles 2 and *6* analogously insert a new definition in Article 1 of the respective Superannuation Orders so that any reference to the "Income Tax Law" is taken to mean the Income Tax (Jersey) Law 1961.

Article 7 makes minor amendments to Articles 44 and 45 of the Existing Members Order which are consequential to the introduction of the definition of the Income Tax Law in Article 1 of that Order.

Article 3 substitutes the provisions of Article 34 of the New Members Order with new provisions which will enable a teacher or former teacher to elect on retirement to commute a small pension for a lump sum payment. The making of an election is subject to the person concerned being age 60 and the value of the person's accrued benefits in the fund aggregated with any other lump sum that the person may have previously elected to receive, must not exceed £30,000. Payment of the commuted lump sum will extinguish the teacher's or former teacher's rights as well as the rights of any person contingently entitled to benefits which might otherwise have been payable under the scheme. Article 8 inserts new Article 59A into the Existing Members Order, which is analogous to substituted Article 34 of the New Members Order.

Article 4 which inserts new Article 34A into the New Members Order and *Article 8* which inserts new Article 59B into the Existing Members Order, will enable a former teacher who has left service other than by reason of retirement, to exchange his or her contingent entitlement to a small deferred pension or to allowances, for receipt of a lump sum subject to certain conditions including the lump sum not exceeding £5,000. The effect of these provisions is that a former teacher will have the choice of whether to receive an immediate lump sum payment representing the value of his or her benefits accrued in the fund at the time he or she leaves service, or of waiting until such time as he or she would ordinarily become entitled under the Order to draw his or her deferred pension (usually on reaching normal retirement age). However, payment of the lump sum will extinguish the former teacher's rights as well as the rights of any person contingently entitled to benefits which might otherwise have been payable under the scheme.

Article 9 provides for the title of this Order and for its coming into force 7 days after it is made.

The Order was made on 6th September 2013 and comes into force on 13th September 2013.

Those Articles of the States of Jersey Police Force Law 2012 ('the Law'), which establish a Police Authority for Jersey came into force on 24th July 2013.

Article 5(1) of the Law provides that the Police Authority shall consist of not less than 5 and not more than 7 members, comprising a membership as follows:

- a Chairman, who is not an elected member of the States, appointed by the Minister;
- up to 4 members, not being elected members of the States, who are appointed by the Minister and the chairman; and
- up to 2 members who are elected members of the States, appointed by the States by secret ballot.

Article 5(6) of the Law stipulates that none of the following may be appointed as a member of the Police Authority –

- (a) a police officer;
- (b) a person who is a member of the Honorary Police;
- (c) an office holder of a Crown appointment;
- (d) the Minister or his or her Assistant Minister;
- (e) a Connétable;
- (f) a States' employee;
- (g) a person who is bankrupt, whether under the law of Jersey or under the law of a country or territory outside Jersey;
- (h) a person who has been a police officer at any time during the previous 5 years; or
- (i) a person who has been a member of the Honorary Police at any time during the previous 5 years.

The Minister for Home Affairs has written to all States Members to remind them of these criteria, which will make some States Members ineligible to be considered for membership of the Authority.

Nominations will be invited from the floor at this meeting and each nomination will need to be seconded (Standing Order 102). If there are more than 2 nominations made, a secret ballot will be held and the 2 members receiving the largest number of votes will be elected as members of the Authority. In the ballot each member will be able to cast up to 2 votes.
