Future Hospital: preferred site P.110/2016

THE STATES resumed consideration of a proposition of the Council of Ministers entitled ‘Future Hospital: preferred site’ (P.110/2016) and rejected an amendment of the Connétable of St. John that –

- (1) After the words “new General Hospital” there should be inserted the words –
“either –
(a) ”.
- (2) For the words “this Proposition,” there should be substituted the words –
“this Proposition; or
(b) the south side of the Waterfront site, not including any part of Les Jardins de la Mer, in accordance with the Map in the Appendix to the Report accompanying this Amendment,”.

- (3) For the words “proposals to be brought back to the Assembly as set out in Section 6.3 of the accompanying Report” there should be substituted the words –

“business cases for both options to be brought back to the Assembly by the summer recess in 2017; and”.

- (4) After paragraph (b), there should be inserted the following paragraph –

“to request the Minister for the Environment to amend the Esplanade Quarter Masterplan to make provision for the potential siting of a new hospital on the south side of the Waterfront.”.
