Government House. Statement.

The President of the Island Development Committee made a statement in the following terms -

"When my Committee met last Thursday a considerable time was spent discussing Government House. I now wish to advise Members that my Committee, after discussion, unanimously decided that it wished to revoke the planning permit issued for the demolition and rebuilding of Government House.

It is a fact that in November of last year my Committee was supportive of the Public Works Committee's proposals, which were subsequently approved by the States on 13th December, 1988 that the house be demolished. At that time we knew that the architects, engineers and quantity surveyors had advised that the cost of refurbishment and our extension to Government House was likely to be much higher than that of building new. There was also the unspecified cost of rehousing the Lieutenant Governor while the work was being carried out.

At the same time work was proceeding on the study of buildings to be designated as sites of special interest and, although on a draft list, not very much information was available about the history and architectural quality of Government

### House.

Following States' approval to demolition my Committee did not further research the historical or architectural content of the buildings, but instead concentrated on the design of the new Government House. After much discussion with outside bodies my Committee gave planning permission.

It is now clear to us that the arguments for choosing the least costly option were not the ones which should have prevailed. We now know much more about Government House and have a better understanding of how greatly it is valued by the Island. We feel that our change of mind is justified.

I am confident that the Public Works Committee will accept this decision as being right for Jersey and will join us in studying alternative proposals. There can be no doubt that, provided we are prepared to pay the price, the old house can be restored and the Lieutenant Governor of Jersey provided with a home, guest suites and reception rooms, which will reflect the high esteem which this Island has for this office."

Having allowed for a balance of #38,581,600 to be brought forward at 1st January, 1990, and taking into account the capital repayments of #14,856,000 the States noted that there would be available in the capital fund the sum of #89,715,300.
