## **DRAFT BOATS AND SURF-RIDING (CONTROL) (AMENDMENT No. 28)(JERSEY) REGULATIONS 200**

### **REPORT**

---

Jersey Harbours provides the Coastguard service for the Island and territorial waters. These Regulations are intended as a means of maintaining information for sea rescue purposes, organising mooring space, checking insurance and promoting safety at sea, depending on the type of craft.

New Inshore Safety Regulations have been drawn up and are at the consultation stage. It is anticipated that these will become effective in early 2009 and will replace the Boats and Surf-Riding Regulations.

It is recommended that the fees should be increased by RPI(Y) of 3.9% with effect from 1st January 2009.

There are no additional financial or manpower implications for the States arising from the adoption of these Draft Regulations.

## **Explanatory Note**

---

These Regulations increase fees.

The fee payable on an application for registration of –

- (a) a boat to ride the surf;
- (b) a sail board;
- (c) a boat 8 feet long or more (other than a speed boat or canoe); and
- (d) a speed boat;

is increased from £16 to £16.62.

The fee payable for each hour, or part of an hour, for which a person is engaged on an inspection of a boat in respect of which an application has been made for a licence to ply for hire is increased from £42 to £44.

The fee payable on the grant of a licence for a boat to ply for hire and on the grant of a licence for a passenger boat plying for hire between places in Jersey is increased from £18 to £19.

In each case, the fee was last increased on 19th March 2008.

**THE STATES**, in pursuance of Article 4 of the Harbours (Administration) (Jersey) Law 1961<sup>[1]</sup>, have made the following Regulations –

---

### **1 Fees under the Boats and Surf-Riding (Control) (Jersey) Regulations 1969**

- (1) In this Regulation, a reference to a Regulation is to the Regulation of that number in the Boats and Surf-Riding (Control) (Jersey) Regulations 1969<sup>[2]</sup>.
- (2) In Regulations 2(7), 5(2), 8(2) and 33(1), for the amount “£16” there shall be substituted the amount “£16.62”.
- (3) In Regulation 13(2)(a), for the amount “£42” there shall be substituted the amount “£44”.
- (4) In Regulations 14(2) and 26(2), for the amount “£18” there shall be substituted the amount “£19”.

### **2 Revocation**

The Boats and Surf-Riding (Control) (Amendment No. 27) (Jersey) Regulations 2008<sup>[3]</sup> are revoked.

### **3 Citation and commencement**

These Regulations may be cited as the Boats and Surf-Riding (Control) (Amendment No. 28) (Jersey) Regulations 200- and shall come into force on 1st January 2009.
