Charities (Reportable Matters) (Jersey) Order 2025.

Minister for External Relations.

The Charities (Reportable Matters) (Jersey) Order 2025 provides that, in addition to the matters listed in Article 19(1)(a) to (g) of the Charities (Jersey) Law 2014 ("the Law"), 2 further matters are "reportable matters" in relation to a person. The Law requires a person who is a governor of a registered charity, or of an entity applying for registration as a charity, to report any reportable matter in relation to the person to the Jersey Charity Commissioner and to the charity or entity. The additional reportable matters are the fact that a person has a conviction, whether or not spent, for an offence against a vulnerable person (as defined in the Order) and the fact that a person has any other unspent convictions (excluding convictions that are already reportable matters under the Law).

The Order comes into force on 1st June 2025.

The Order was made on 14th May 2025 and came into force on 1st June 2025.

Immigration (Fees) (Jersey) Amendment Order 2025.

Minister for Justice and Home Affairs.

This Order amends the Immigration (Fees) (Jersey) Order 2022. This Order increases, by between 5% and 7.2%, the fees payable for applications for limited and unlimited leave to remain and for passports (other than temporary emergency passports). The fees were most recently increased with effect from 1st June 2024.

This Order comes into force on 1st June 2025.

The Order was made on 22nd May 2025 and came into force on 1st June 2025.

Education Law and Order (Jersey) Amendment Order 2025.

Minister for Education and Lifelong Learning.

This Order amends the Education (Jersey) Law 1999 (the "Law") and the Education (Grants and Allowances) (Jersey) Order 2018 (the "2018 Order") to amend the definition of higher education and to alter the provision for students undertaking distance learning courses. This Order also makes other minor and consequential amendments to the 2018 Order.

Article 1 states that Part 1 amends the Law.

Article 2 amends the description of courses of higher education in Schedule 2 to the Law.

Article 3 states that Part 2 amends the 2018 Order.

Article 4 inserts new definitions into Article 1 of the 2018 Order, including the meanings of "credit", "course", "degree programme" and "module". It also amends the definition of "higher education" in the 2018 Order.

Article 5 deletes references to 2 Laws from Article 3A(1)(c) so that benefits paid under those Laws will no longer be included as "income" for the purposes of the 2018 Order.



Article 6 amends Article 6 of the 2018 Order to clarify circumstances in which the income of an independent student's spouse, civil partner or partner is not taken into account when calculating the student's relevant income.

Article 7 amends Article 8 of the 2018 Order to give the Minister for Education and Lifelong Learning discretionary powers to determine whether the education provided by a higher education institute is of a standard that meets the eligibility criteria for a student to be considered for a grant.

Article 8 amends Article 9 of the 2018 Order to clarify that a post-graduate student may be eligible for a grant to undertake a full-time course in preparation for a professional examination only if that examination is of a standard higher than the standard of –

- examinations at advanced level for the General Certificate of Education; or
- the examination for the National Certificate or the National Diploma.

Article 9 amends Article 11 of the 2018 Order to introduce the new Schedule. This Schedule is inserted by Article 14 of this Order and sets out how tuition fees grants and maintenance grants are to be calculated for students undertaking distance learning courses. The Schedule also defines "credit accumulation and transfer" and the relevant income of a student undertaking a distance learning course.

Article 10 inserts new Article 13CB into the 2018 Order. This new Article provides that a student who is detained in prison is not entitled to a maintenance grant during their detention.

Article 11 deletes Article 17 (distance learning course grant) of the 2018 Order. Article 17 is redundant since grants awarded to students undertaking distance learning courses will no longer be calculated in that way.

Article 12 amends Article 20 of the 2018 Order so that a student undertaking a 4-year full-time distance learning course is treated in the same way as a student undertaking a 4-year full-time in-person course. This means that if an equivalent 3-year full-time course could be undertaken instead, the amount of tuition fees grant or maintenance grant awardable to a student are each reduced by 25%.

Article 13 amends Article 29 of the 2018 Order to clarify circumstances in which a student may have their grant or allowance withdrawn and may have to repay all or part of a grant or allowance they have already received.

Article 15 gives the title of the Order and states that it comes into force 7 days after it is made.

The Order was made on 29th May 2025 and comes into force on 5th June 2025.

"Will the Chief Minister detail what progress has been made regarding proposed changes to the Wills and Successions (Jersey) Law 1993, following the consultation which closed in September 2024, and will he advise whether consideration is being given to —

- (a) establishing the legal status of long-term partners who are neither married nor in a civil partnership, and specifically their rights in terms of purchasing property together and accessing assets of the deceased partner, and if not, why not;
- (b) changes to automatic entitlement of estranged relatives; and
- (c) the valuation and disposal of assets following a tragic event, for example a car or motorbike accident, to avoid distress amongst partners and relatives?"
- 23. The Minister for Treasury and Resources tabled an answer on 27th May 2025 to the following question asked by Deputy M.B. Andrews of St. Helier North –

"Will the Minister state the amount of personal income tax collected annually over the last five years as a percentage of Government revenue, including a breakdown of the percentage of personal income tax each income decile has generated?"

24. The Minister for Social Security tabled an answer on 27th May 2025 to the following question asked by Deputy M.B. Andrews of St. Helier North –

"Will the Minister provide the five-year forecast for the balance of the Social Security Fund and advise whether she is considering to propose an increase in Social Security contributions and, if so, when such an increase would come into effect; and if not, why not?"



25. The Minister for Education and Lifelong Learning tabled an answer on 27th May 2025 to the following question asked by Deputy M.B. Andrews of St. Helier North –

"Will the Minister state what impact, if any, the 2024 above inflation pay award for teachers had on school budgets, and advise whether any analysis has been undertaken to ascertain whether the agreed one percent above inflation pay award will lead to school budget overspends in 2025 and 2026?"

26. The Minister for Infrastructure tabled an answer on 27th May 2025 to the following question asked by Deputy H.L. Jeune of St. John, St. Lawrence and Trinity –

"In relation to the letter dated 26th July 2023 from the Minister to the Children, Education and Home Affairs Scrutiny Panel regarding States expenditure on facilities maintenance for secondary schools, will he provide in respect of Victoria College and Victoria College Preparatory School —

- (a) a detailed breakdown of any works undertaken from 2019 to date, including the dates of commencement and completion;
- (b) information on any planned facilities maintenance, including allocated budgets and future budgets; and
- (c) details of any long-term planning regarding facilities maintenance?"
- 27. The Minister for Education and Lifelong Learning tabled an answer on 27th May 2025 to the following question asked by Deputy D.J. Warr of St. Helier South –

"Will the Minister state the average cost of funding a pupil in a States non-fee-paying primary school and of funding a pupil in a States non-fee-paying secondary school; and will he provide information on how this funding is calculated, listing all budget lines included, and where there has been any explicit decision to exclude certain budget lines from the calculation, will he provide the reasons for any such exclusion?"

28. The Minister for Education and Lifelong Learning tabled an answer on 27th May 2025 to the following question asked by Deputy D.J. Warr of St. Helier South –

"Will the Minister state the energy costs, cleaning costs, and grounds maintenance costs for Victoria College and Victoria College Preparatory School, and advise what percentage of these costs is funded centrally by his department?"

29. The Minister for the Environment tabled an answer on 27th May 2025 to the following question asked by Deputy H.L. Jeune of St. John, St. Lawrence and Trinity –

"Further to the response to Written Question 442/2023, will the Minister explain what steps a member of public may follow to seek the protection of a tree and, in relation to those trees granted a 'provisional' listing at St. Joseph's (T/2023/0001), will the Minister explain –

- (a) why the provisional listing expired;
- (b) what a 'provisional' listing means;
- (c) how and when a 'provisional' listing expires;
- (d) what mechanisms are in place to ensure that 'provisional' listings do not expire in the future; and
- (e) whether trees that have received a 'provisional' listing may be listed again?"



30. The Minister for Health and Social Services tabled an answer on 27th May 2025 to the following question asked by Deputy I. Gardiner of St. Helier North –

"Further to his response to Written Question 204/2025 will the Minister advise the timeline of the policy development for the establishment of an independent medicines regulator, what consultation, if any, has been undertaken with relevant key stakeholders, and whether he intends to bring this policy to the States, and if so, what is the expected timeline for this?"

31. The Minister for Treasury and Resources tabled an answer on 27th May 2025 to the following question asked by Deputy I. Gardiner of St. Helier North –

"Regarding the pay award for public sector workers agreed in April 2024, will the Minister state what transfers, if any, from the Central Reserve were required, and if any were required, detail which departments received a transfer and the amount received by each department?"

32. The Minister for Housing tabled an answer on 27th May 2025 to the following question asked by Deputy A.F. Curtis of St. Clement –

"Will the Minister advise what data, if any, he holds on the costs of housing construction in the private sector, including –

- (a) direct construction costs (e.g. structural works, internal fit-outs, electrical installations, landscaping);
- (b) professional service fees (e.g. architecture, structural engineering, legal, ecological, and drainage services);
- (c) total new-build costs per square metre;
- (d) total new-build costs per unit type; and
- (e) total extension or renovation costs per square metre;

and will he further explain how this data is used to inform and shape the Government's housing policy?"

33. The Minister for the Environment tabled an answer on 27th May 2025 to the following question asked by Deputy H.L. Jeune of St. John, St. Lawrence and Trinity –

"For each of the last five years will the Minister advise the number of officers involved in dispute resolution between neighbours and Environmental Health and Enforcement, and the number of officer hours spent, both globally and with specific reference to St. Peter's Technical Park and Northern Leaf's Retreat Farm?"

34. The Minister for Treasury and Resources tabled an answer on 27th May 2025 to the following question asked by Deputy A.F. Curtis of St. Clement –

"Will the Minister advise what data she holds regarding the costs of construction in Jersey, including —

- (a) any direct construction costs (e.g. structural works, internal fit-outs, electrical installations, landscaping);
- (b) any professional service fees (e.g. architecture, structural engineering, legal, ecological, and drainage services);
- (c) total new-build costs per square metre; and



(d) total new-build costs per unit type;

and will she explain how, as shareholder representative, she (including her department and any independent advisors used) uses this data to ensure that developments by Andium Homes Limited represent value for money and are viable for the future?"

35. The Minister for External Relations tabled an answer on 27th May 2025 to the following question asked by Deputy J. Renouf of St. Brelade –

"Further to media reports that Jersey Airport has been placed in "Special Attention" by the Office of the Director of Civil Aviation due to the change in Operational Leadership, will the Minister advise whether there were any other reasons for the Airport being placed in Special Attention, in particular whether it was due to either security lapses or a lack of qualified air traffic control personnel; and if such other situations have impacted the position of the Airport, what actions are being taken to rectify these; and will he further state whether the Airport was at imminent risk of being shut down by the relevant authorities?"

36. The Minister for Sustainable Economic Development tabled an answer on 27th May 2025 to the following question asked by Deputy J. Renouf of St. Brelade –

"Further to his statement to the Assembly on 13th May 2025 in which he advised that Jersey is "attracting businesses in the biotech sector and as a result, we are developing a cluster of firms that operate within this high-value, low-footprint area", will the Minister provide further details regarding the parts of the biotech sector that are being, or it is hoped will be, attracted to the Island, whether any have relocated to the Island, and whether it is expected that they will require regulatory support from the Government?"

37. The Minister for Health and Social Services tabled an answer on 27th May 2025 to the following question asked by Deputy J. Renouf of St. Brelade –

"Given the reported overspends in his department since 2022, will the Minister provide a costed list of where the overspends have occurred in each year, along with the steps being taken to reduce such overspends in the future?"

38. The Minister for Justice and Home Affairs tabled an answer on 27th May 2025 to the following question asked by Deputy K.M. Wilson of St. Clement –

"Will the Minister provide the data collected in relation to knife crime, arson, and the illegal use of firearms for each of the last 3 years, and the number of related prosecutions and sentences for such crimes; and will she further advise –

- (a) whether there have been any changes to policy further to recent reporting in the local press on knife incidents in the community;
- (b) what progress has been made on community safety initiatives and how these initiatives are measured and monitored;
- (c) whether there have been any changes to policy or resources in response to increases in activity in those seeking to import quantities of illegal drugs, substances or weapons into the Island; and
- (d) whether her department is taking any steps to address low-level fire setting in some communities, and if not, why not?"

In accordance with Standing Order 104A, a time limit of 15 minutes applies to speeches made during debate, unless discretion has been exercised to allow for a longer, or shorter, time limit. No time limit applies to either speech made by the proposer.

Discretion is exercised by the Presiding Officer in accordance with guidance issued by the Bailiff, following consultation with the Privileges and Procedures Committee. The current guidance was presented to the States in the report 'Time Limits on Speeches in Debates: Guidance on the Exercise of Discretion' (R.3/2021). The report states that discretion may be exercised to allow for a longer speech than 15 minutes where the member speaking is designated as the 'main respondent' to the debate.
