Committee for Postal Administration: resignation of President and Members

THE STATES accepted the resignation of Senator Corrie Stein as President of the Committee for Postal Administration together with the other members of that Committee.

Committee for Postal Administration: statement

The President of the Committee for Postal Administration made a statement in the following terms -

"Every member in the House knows about the problems that my Committee have been dealing with.

These problems have been going on since 1969 and have accrued over the years. A report on methods and practices was prepared in 1972 for Senator Krichefski's Committee, yet not his Committee, nor any other Committee tackled these problems. Previous presidents of Postal include Deputy Smale, Senator Le Maistre and Senator Shenton.

My Committee set out to tackle a situation which was wrong, unfair and costly. At the same time my Committee had to abide by the States nil growth policy, during a period of tremendous growth in mail.

When the men went on unofficial strike during negotiations, the officers of the Establishment Committee and Postal, and the Postal Committee, believed that this was our opportunity to get the men back on management terms so as to do away with the restrictive practices.

We all know what followed - a court injunction was taken out by the Union of Communication Workers and this was comprehensively defeated in Court on Monday morning, 30th November 1992.

The President of the Establishment Committee then became directly involved. I was invited to meet the U.C.W. at 1 p.m. that afternoon. I had a member of the Postal Committee, Deputy Crespel, with me.

During the course of that afternoon, a provisional agreement was drafted. I asked for several adjournments. I was not happy with this draft, and also believed that my Committee would not be happy with this draft. I made my concerns very clear.

Senator Shenton's reaction was that if we would not agree to what he believed was a good agreement, he would leave us to it and go home.

At this point, Deputy Crespel said that Senator Shenton was a realist, that we had to be realistic, and should accept. I still held out, not wanting to agree.

Let me make it quite clear that the agreement as drafted was divisive, and allowed the men to return on their conditions. The Postal Committee were doing their best to stick to the Establishment Committee edict that pay deals should be 5.8 per cent with no frills, this deal had frills. I still held out.

The President of Establishment then told us that if we would not agree, he would join the other side of the table.

There was nothing left for me to do.

I agreed.

At the full Postal Committee meeting on Wednesday the view was that we had been undermined by the President of Establishment.

Therefore it was no longer sensible for us to remain in office as we had been put in an untenable position.

We decided to resign as a Committee, and we certainly do not intend to come back."

Committee for Postal Administration - vacancy in Presidency

THE BAILIFF acceded to a request from the Connétable of St. John and adjourned the meeting until 10.15 a.m.

Committee for Postal Administration -

appointment of President

THE STATES re-assembled and proceeded to elect a President of the Committee for Postal Administration. Senator Jean Amy Le Maistre was proposed by Senator Reginald Robert Jeune, Senator Dereck André Carter was proposed by Iris Medora Le Feuvre, Connétable of St. Lawrence, and Frank Harrison Walker, Deputy of St. Helier, was proposed by Senator John Stephen Rothwell.

THE STATES, having proceeded to a secret ballot, the Bailiff declared the following results -

The Bailiff accordingly declared that Deputy Walker had been elected as President of the Committee for Postal Administration.

"Members will have read Projet P.179/92 entitled Protection of Employment Opportunities: Revision of Law' which was lodged au Greffe on 17th November 1992 for debate today. Up until late last week it was my intention to proceed with that debate.

However, as a result of meetings held earlier in the week and a subsequent request by the Policy and Resources Committee I have agreed to defer the debate.

The reason for this request is that the Policy and Resources Committee have agreed with the Finance and Economics Committee that the Regulation of Undertakings and Development Law should be applied in such a way as to encourage the creation of additional jobs and to protect the position of local residents taking up employment. It is envisaged that these changes will be ready for States' approval early in the New Year. As the amendments may well overlap or duplicate provisions in any work permit legislation, it seems to me sensible that the amendments should be debated first. This House may at that point decide that the amendments are sufficient to achieve the necessary protection of the local labour force, In that case, there would be no need to proceed further with draft work permit legislation. On the other hand, the House may wish to go further. Then my Committee would proceed with the drafting and consultation process.

In the meantime, I am informing this House that the debate on Projet P.179 is deferred."

THE STATES, acceded to the request of the President of the Defence Committee, that consideration of the proposition regarding a revision of the Law on the Protection of Employment Opportunities (P.179/92 - lodged on 17th November 1992) be deferred from the present Sitting.

Parish welfare assistance. Questions and answers. (Tape No. 165)

Deputy Maurice Clement Buesnel of St. Helier asked the Chairman of the Connétables'
Supervisory Committee the following questions -

- ``1. Would the Connétable, as Chairman of the Connétables' Supervisory Committee, confirm that the Parishes have a co-ordinated policy that details the type and value of welfare assistance disbursed to the unemployed?
- 2. Would the Connétable also say whether rent and mortgage repayments are taken into account when assessing an applicant's request for financial help, and in the latter case, whether full provision is made?
- 3. As the Finance and Economics Committee is responsible for the payment of welfare payments to non-natives, would the Connétable confirm that there is no discrimination in the treatment of applicants for welfare help?"

The Chairman of the Connétables' Supervisory Committee replied as follows -

- `1. There is a published Welfare Grant booklet which all Connétables use in assessing the type and value of welfare assistance to parishioners in need, including that of unemployment.
- 2. Rent is taken into consideration when assessing an applicant's request for financial help, but in the case of mortgage repayments, only the interest charges appertaining to that repayment are accepted. The Deputy will know that part of the mortgage repayment covers capital repayments which is not taken into consideration when considering the Welfare Grant. It should be pointed out that the number of welfare applicants owning their own property, even on mortgage, is relatively small.
- 3. Notwithstanding that the Finance and Economics Committee are responsible for welfare payments to non-natives, I would confirm, that there is no discrimination in the treatment of applicants for welfare providing that the applicant has resided in Jersey for a minimum period of five years."

Industrial relations and employment legislation - Statement

The President of the Industrial Relations Committee made a statement in the following terms -

- ``1. I feel it is my duty to report to the House on a matter of public interest. In a leading article in the Jersey Evening Post on Wednesday, 2nd December 1992, the Industrial Relations Committee was accused of failing in its function in recent years and there was a call for an urgent review of industrial relations legislation. In a further article in the same newspaper, the Jersey official of the Transport and General Workers' Union is alleged to have stated that the current laws were absolutely out of date and that the Industrial Relations Committee was seen as 'an irrelevance' in the modern world.
- 2. I cannot allow such sweeping and derogatory statements to be published without giving my response to the members of this House.
- 3. When the Industrial Relations Committee was appointed by the States in 1969, it was charged with ensuring that there was adequate provision for the airing of workers' grievances and for conciliation and arbitration. The Committee of the day reviewed the laws relating to trade unions in Jersey and the Industrial Disputes Law; it published a Code of Good Industrial Relations Practice and the States appointed an Industrial Relations Advisory Officer. The Committee has always made clear its policy that it must remain neutral insofar as industrial disputes are concerned and neither the Committee nor its officer can act as arbitrators in industrial disputes.
- 4. Nevertheless, the Committee does provide the machinery for conciliation or arbitration in collective industrial disputes at the request of the

disputing parties and that service has been well used over the years. I must add that if we had been asked by any party to the recent dispute at the Post Office for assistance, we would have been only too glad to help. The Industrial Relations Advisory Officer assisted the Deputy Industrial Disputes Officer to resolve a dispute at the Post Office in March 1992 but on this recent occasion no request for assistance was received.

- 5. Since 1969, successive Committees have kept employment and industrial relations legislation under review and introduced a new law on Termination of Employment in 1974 and one on Written Statements of Employment this year. One of my first tasks on becoming President was to review the Industrial Disputes Law of 1956 with the Industrial Disputes Officer but it was decided that no amendment was necessary at that time. Since then, we have had no cause to review it again.
- 6. The Committee has never, at any time, refused to meet representatives of employers' or employees' organisation and, contrary to the report in the press, I met Mr. Kavanagh of the Transport and General Workers' Union officially at his request in October 1991. Reports of the detailed workings of the Industrial Relations Advisory Service have been presented to this House by the Committee annually since 1983. I am sure that members who read these reports will agree that generally the record of industrial relations in Jersey has been a very good one.
- 7. My Committee emphasises in its Code of Practice, that good industrial relations is a joint responsibility of employer and employee, established on a basis of trust and confidence. We acknowledge that to achieve a satisfactory standard of relationship in employment, skill and patience is required. Adaptation, innovation and change will often be necessary. It is not possible to legislate for personal behaviour or reactions in all situations and circumstances.

8. However, in the light of our recent industrial relations problems, my Committee will review, once more, the existing legislation on industrial disputes and employment to ascertain whether or not any change should be recommended in the Island's best interests. The review will be conducted in consultation with interested parties, and I shall report our findings to the States as soon as possible."

Housing land availability - Statement

The President of the Island Development Committee made a statement in the following terms -

"Following a detailed analysis of housing requirements up to the year 2000, and on the basis of the sites currently identified, both Committees agree that it is not necessary to release additional land for housing purposes at this time. The most sensible strategy would be to undertake regular reviews of the overall housing position.

The evidence currently available would suggest that the existing stock of dwellings and the additional supply of new dwellings to be provided on sites already identified (assuming these sites are developed in the required time-frame) should be sufficient to satisfy States loan housing requirements, throughout the 90's.

The situation with regard to true housing need (defined as `those seeking rental accommodation, but who require the benefit of a public or private sector rent rebate to afford accommodation of a sufficient size or standard') is less clear cut.

Clearly, it is not sufficient in the present circumstances to base projections of future rental needs primarily on historical trends. One has to recognise that there are a number of unknown factors in the equation, brought about by a changing economic climate and, by recent measures approved by the States to liberalise the housing market. There is

some evidence that the Housing Committee's new policies are beginning to bear fruit, but it is still early days and it is not possible, at this time, to determine with any certainty the extent to which the existing dwelling stock, together with the Housing Committee's own development programme, will be able to meet needs with the assistance of the private sector rent rebate scheme.

Having regard to the extent of the current rental programme and based on the proviso that sites already identified for housing rental purposes will come forward in good time, both Committee's are in agreement that additional land need not be re-zoned at this time.

It is considered that six monthly reviews will offer the best means of analysing the impact which demographic and economic trends, together with new housing policies, are having on the rental waiting list. It will also offer a sounder basis upon which to forecast housing need up to the year 2000, and will assist in determining the extent to which that need is likely to be met from the existing housing stock and other sites in the pipeline.

The Island Development Committee will continue to identify and review potential housing sites, which can be recommended for re-zoning purposes, should a future requirement emerge to bring forward additional housing land quickly. A more detailed report on housing land availability will be produced in the New Year."

Springfield, St. Helier: rezoning and acquisition. P.185/92

THE STATES commenced consideration of a proposition of the Sport, Leisure and Recreation Committee regarding the rezoning and acquisition of land at Springfield, St. Helier.
