Explanatory Note regarding subordinate legislation tabled at this meeting.

R&O 100/2005

This Order replaces the Post Office (Foreign Parcel Post Provisions) (Jersey) Order 1979 which was found to contain many unnecessary provisions. The substantive amendment is to increase the rates of postage for air and surface parcels for delivery outside the British Islands by between 2.4% and 2.5%. The rates were last increased on 6th April 2004. The revised charges are based on actual delivery costs.

The Order was made on 26th September 2005, and comes into force on 1st January 2006.

R&O 101/2005

This Order increases postal charges on postal packets to places outside the British Islands by up to 4.5% with effect from 4th April 2006. The charges were last increased with effect from 2nd April 2005. The opportunity has been taken to update a cross reference and a minor error.

The Order was made on 26th September 2005, and comes into force on 4th April 2006.

R&O 102/2005

This Order increases the rates of postage for letters posted in Jersey to an address in Jersey and for letters posted in Jersey to an address in any other place in the British Islands. The effect of this Order is to increase the rates for post within Jersey by between 1.39 and 3.03% and the rates for post to the British Islands by between 7.87 and 8.82%. The rates were last increased on 2nd April 2005.

This Order was made on 26th September 2005, and will come into force on the 4th April 2006.

R&O 103/2005

This Order increases the rates of postage for parcels for delivery in Jersey or to another place in the British Islands. The rates were last increased on 6th April 2004. The rates for delivery of parcels within Jersey are between 2.33 and 2.50%. The rates for delivery for parcels in the British Islands are between 2.43 and 2.50%.

This Order was made on 26th September 2005, and comes into force on the 1st January 2006.

R&O 104/2005

The effect of this Order is to increase the charges relating to private day postal boxes and redirection of post. It also increases the charge for temporary retention of postal packets and business reply licences. The increases in the charges are between 2.29 and 2.50%. The charges were last increased on 1st January 2005.

This Order was made on 26th September 2005, and comes into force on 1st January 2006.
