# Health and Social Services: A New Way Forward P.82/2012

- (i) proposals for the priorities for investment in hospital services and detailed plans for a new hospital (either on a new site or a rebuilt and refurbished hospital on the current site) including full details of all manpower and resource implications necessary to implement the proposals, by the end of 2014;
- (ii) proposals to develop a new model of Primary Care (including General Medical Practitioners, Dentists, high street Optometrists and Pharmacists), by the end of 2014;
- (iii) proposals for a sustainable funding mechanism for health and social care, before the end of September 2014.
