R&O.57/2010.

This Order prescribes the way between Les Quennevais Sports Centre in St. Brelad's parish and Rue des Landes as a cycle track and the way from Rue des Landes to La Rue de St. Clement in St. Peter parish as a cycle track. The Order was made on 17th June 2010 and comes into force 24th June 2010.

R&O.58/2010.

This Order revokes the Community Provisions (Uzbekistan Sanctions) (Jersey) Order 2007 consequent on the repeal by Council Regulation (EC) No. 1227/2009 of Council Regulation (EC) No. 1859/2005 of 14 November 2005 (as amended), concerning certain restrictive measures in respect of Uzbekistan.

The Order was made on 18th June 2010 and came into force on 19th June 2010.
