## **DRAFT EMPLOYMENT OF STATES OF JERSEY EMPLOYEES (AMENDMENT) (JERSEY) REGULATIONS 200-**

### **REPORT**

---

The attached amendments add the post of Magistrate (which includes the post of Assistant Magistrate) to the list of posts which are not States' employees within the meaning of the Employment of States of Jersey Employees' Law (2005). This places them in the same category as other Crown and States appointments under the Law.

The amendments also amend the Loi (1864) concernant La charge de Juge d'Instruction so as to permit the States Employment Board to determine the remuneration payable to the Magistrate and Assistant Magistrate.

These amendments do not have any financial or manpower implications for the States.

## **Explanatory Note**

---

These Regulations amend the Schedule to the Employment of States of Jersey Employees (Jersey) Law 2005 by adding the Magistrate to the list of persons who are not States' employees within the meaning of that Law.

The Regulations also amend the Loi (1864) concernant la charge de Juge d'Instruction so as to permit the States Employment Board established under the Employment of States of Jersey Employees (Jersey) Law 2005 to determine the remuneration payable to the Magistrate.

The Regulations shall come into force 7 days after they are made.

**THE STATES**, in pursuance of Article 30 of the Employment of States of Jersey Employees (Jersey) Law 2005<sup>[1]</sup>, have made the following Regulations –

---

### **1 Amendment to Law**

In the Schedule to the Employment of States of Jersey Employees (Jersey) Law 2005<sup>[2]</sup>, at the end, there shall be added the word “Magistrate”.

### **2 Amendment to Loi (1864) concernant la charge de Juge d’Instruction**

In the Loi (1864) concernant la charge de Juge d’Instruction<sup>[3]</sup>, in Article 3, for the words “le Policy and Resources Committee après que le Committee” there shall be substituted the words “le States Employment Board établi par la Loi intitulé ‘Employment of States of Jersey Employees (Jersey) Law 2005’ après que ce Board”.

### **3 Citation and commencement**

- (1) These Regulations may be cited as the Employment of States of Jersey Employees (Amendment) (Jersey) Regulations 200-.
- (2) These Regulations shall come into force 7 days after they are made.
