The Panel identified amendments which it requested that the Scrutiny Officer enact before a revised draft was circulated to the Panel.</p> <p>Consideration was given to whether a statement should be made to the States Assembly, once the Panel's report had been presented. The Panel was advised that the officer-meeting would take place on 24th April 2012 and it was therefore agreed to defer the meeting of the Chairman and Vice-Chairman until after that time.</p>
