MV `Saint-Malo" rescue: recommendations - R.C. 29/95

Deputy John Nicolle Le Fondré, President of the Harbours and Airport Committee, made a statement in the following terms -

"Members of the States will recall the incident involving the MV `Saint-Malo' off Corbière on Monday, 17th April 1995 when the vessel struck rocks at high speed whilst carrying 300 passengers and seven crew. Fortunately as a result of excellent work carried out by the rescue services and other vessels nearby, there was no loss of life. Soon after, my Committee commissioned the Marine Accident Investigation Branch in the United Kingdom to undertake a full inquiry and the results of that inquiry were published in September. Since that time discussions have been held with the Marine Safety Agency of the Department of Transport in the United Kingdom and a number of recommendations have now been agreed which are addressed to the States of Jersey, Channiland, the Secretariat d'Etat a la Mer - Affaires Maritime and the International Maritime Organisation Secretariat.

The matters relating to Jersey are -

- placing a navigation mark on La Frouquie rock to ensure it is clearly visible at all states of tide:
- keeping the main route through the passage clear of fishing marker buoys if the inshore passage at La Corbiere is to continue to be used by high speed craft to reduce passenger discomfort;
- 3. imposing a speed restriction on all craft navigating the passage.

My Committee will do everything in its power to comply with the recommendations addressed to the States. The remainder will be forwarded to the various organisations by the Marine Safety Agency. The full list of recommendations will be made public today."

2 to 10 Halkett Place and 21 and 23 Hill Street, St. Helier: redevelopment - P.161/95 (Revised)

THE STATES, adopting a proposition of the Planning and Environment Committee -

     Committees to obtain the necessary funding for the said redevelopment from private sources; and
  - (ii) the Planning and Environment Committee to enter into such agreements as are necessary for the said redevelopment;
- (e) authorised the Attorney General and the Greffier of the States to pass, on behalf of the public, any contracts which it might be found necessary to pass in connexion with the purchase of 23 Hill Street, St. Helier, and any interest therein, and the Attorney General and the Greffier of the States to pass, and the Greffier of the States to sign, such other contracts and agreements as might be found to be necessary in connexion with the said redevelopment.

Centrepoint II, Green Street, St. Helier: purchase of St. Helier Day Nursery - P.171/95

THE STATES, adopting a proposition of the Planning and Environment Committee -

- (a) authorised the purchase from the Parish of St. Helier of the freehold of the property known as St. Helier Day Nursery (formerly La Corderie), Rope Walk, Green Street, St. Helier (as shown on drawing No. 483/1) for a consideration of £275,000, for the purpose of establishing a second Centrepoint Resources Centre, with each party being responsible for its own legal fees;
- (b) authorised the Greffier of the States to sign the said drawing on behalf of the States;
- (c) authorised the Attorney General and the
