## **Explanatory Note regarding subordinate legislation tabled at this meeting.**

### **R&O.23/2010.**

This Order amends the Road Traffic (St. Brelade) (Jersey) Order 1990 in relation to parking. It alters the lists of roads where waiting is prohibited, where parking is subject to a 1 hour maximum (with parking disc), and where parking is limited to 12 hours in 24. It also clarifies the provisions on loading and unloading, so that no vehicles can be parked at any time on the roads concerned, except for loading and unloading during limited times (and it alters those times). The opportunity is also taken to correct references to Charing Cross and Le Mont les Vaux.

The Order was made on 19th March 2010 and comes into force on 2nd April 2010.

### **R&O.24/2010.**

This Order –

- (a) imposes a parking restriction on the west side La Grande Route des Sablons in Grouville between a point 10 yards north of its junction with La Sente des Fonds and a point 19 yards further north.; and
- (b) updates a geographical reference in the table of one-way traffic routes in Grouville.

The Order was made on 19th March 2010 and comes into force on 26th March 2010.

### **R&O.25/2010.**

This Order specifies dates and times when the Jersey Motor Cycle and Light Car Club may close the Bouley Bay Hill and Five Mile Road courses to normal traffic and use them for the purposes of motor races and practices.

The Order was made on 19th March 2010 and came into force immediately.

### **R&O.26/2010.**

This Order permits the Jersey Motor Cycle and Light Car Club to hold sand races and practices on various parts of the beaches at Millbrook, St. Ouen's Bay and West Park on various dates in 2010.

The Order was made on 19th March 2010 and came into force immediately.
