Report by Study Group on Benefits to Working Party on Need. Question and answer

Deputy Shirley Margaret Baudains of St. Helier asked Deputy John Le Gallais of St. Saviour, Vice-President of the Finance and Economics Committee, the following question -

"Is it the intention of the Committee to present to the States for debate the recent report of the Study Group on Benefits to the Working Party on Need?"

The President of the Finance and Economics Committee replied as follows -

"The Working Party on Need at its meeting on 19th January completed consideration of the recommendations contained in the report of the Study Group on benefits, having received the comments of various committees and other interested parties on the report. The Working Party has now requested its officers to prepare a draft report to the States for consideration at its next meeting."

Examination fees and independent private schools. Questions and answers

Senator John Stephen Rothwell asked the Connétable of St. Lawrence, President of the Education Committee, the following questions -

Question 1

"Will the President explain to the House why it has been decided that whilst parents of pupils at the Colleges will not in future be required to pay examination fees, this arrangement is not to apply to pupils attending independent private schools, e.g. Beaulieu Convent, De La Salle College?"

The President of the Education Committee replied as follows -

`The grant made by the Education Committee to Beaulieu Convent and De La Salle College already includes an element for the support of payment of examination fees.

As a result of the Committee's decision to remove the charge for examination fees in non fee paying schools and to incorporate charges into the annual fees of Jersey College for Girls and Victoria College, the level of support for examination costs at Beaulieu and De La Salle will be automatically raised to the same level as for Jersey College and Victoria College by 1991. That is to say a pupil in Beaulieu or De La Salle will attract the same support in respect of examination fees as in the two colleges.

The House should understand, however, that it is the governors' prerogative to decide how to spend the grant.

I and some members of the Education Committee had a very constructive meeting with the head teachers of Beaulieu and De La Salle and a representative of the parents on Thursday, 8th February, to see whether there were ways in which the Committee might assist should the governors wish to adopt the policy of the Education Committee in 1990. The governors of the two schools are to consider the matter in the near future."

Supplementary questions and answers

Senator Rothwell - ``Members might find the answer to be very ambiguous and therefore they must try and comprehend what the actual policy is or whether it has changed since the announcement a couple of weeks ago. Do I take it now that although fees are scrapped including the colleges as was announced, that in fact you are now going to compensate by increasing the fees at those colleges?"

President, Education Committee -"Yes. The system that has been for quite some time is that there was in the element of the grant for the non fee paying schools there was always an element that was allowed for for examination fees and whilst we had 'O' levels and 'A' levels the grant allowed was #4 per subject for each pupil. When we considered the matter earlier after the GCSE was introduced the fees for each examination were substantially higher. The Education Committee decided to continue to allow #4 per subject and we considered it recently and thought that as the non fee paying schools pupils don't pay for any other part of their education and it seemed to us that it was putting a great burden on some of the parents to be expected to pay the increased amount. So we decided that really as the education for the non fee paying schools was free in every other aspect we felt that the examination fees should not be charged. That meant that we then decided that in future the grant made to fee paying schools we look at the total cost of what it costs for each pupil to be educated and we then grant up to 50 per cent of the total cost to the fee paying schools and in that amount we are including the examination fees because its two bookkeeping exercises which is costly in administration. For the colleges for instance the Education Committee collects the fees for the school terms and we also then had to bill for the examination fees so we are going to include that as from next year in the whole amount. Now the Committee probably were over generous they decided that having heard all the arguments for doing that they said well let's scrap it this year. Now we met with the heads of both De La Salle and Beaulieu and they understood that up to presently 30 per cent of the grant that we gave them was towards examination fees. Now as has been said and I will repeat, we do not interfere in the way that they run their schools or the charges they make and they have

not been passing on that 30 per cent to the parents so in fact the parents of Beaulieu and De La Salle have been paying the full examination fees and did so even when GCSE was introduced last year so that then parents were paying the whole amount. Now we have said, as I have said in my reply, if these schools decide to adopt the same policy as Victoria College and De La Salle obviously the parents will not be paying the full amount and if the governors of the schools decide to do that we have said that if they state that is their policy we could help them this year because what we are talking about is the difference between 30 per cent and 50 per cent so that it is entirely up to the governors to choose whether they want to continue to charge parents for examination fees or absorb that amount in their school fees."

Senator Rothwell - "I thank the President very much and I am sure that Members have swallowed the clarity in which the President tried to explain the ambiguities contained in the answer. I am still as perplexed as before if not worse. I really can't take this up right now; to say that 30 per cent of the 50 per cent grant was taken up with examination fees seems an extraordinary statement to make. The President appears to have gone to extraordinary lengths to explain what really is a very small problem. Would not the President agree that such a devisive policy is offensive to parents and students and the actual costs involved is about #20,000 in a budget of #50 million. Why can't she simply stand up and say let's scrap the lot, don't charge examination fees, encourage people to take them; they are costing #15 per examination?"

President, Education Committee - `If for instance we were going to scrap education fees we would need to come back to the House to ask the House if they agree that we could increase the grant to the independent fee paying schools. The States decided that the

grant should be at 50 per cent. Now if Senator Rothwell wants us to increase that we would need to come back to the House, and I suggest perhaps that he would like to bring a Proposition to suggest that, but the amount of money we are talking about - we met with the heads of both schools - if they agree that they will adopt the same policy we are talking about probably #2 per examination extra. Now if they want to do that we even said we do believe the amount is so small for this year that we will find the money but as from next year everyone will be treated the same who go to fee paying schools."

Deputy E.J. Becquet - `In view of the reply of the President of Education the second paragraph of her reply to the original question, would she not agree that the parents of children, especially in view of the publicity which accompanied the decision of that Committee not to charge examination fees, would she not agree that parents of children at the colleges had been misinformed if in fact the amount to which they are going to be allowed is going to be incorporated in their rise next year?"

President, Education Committee - ``We have not had any of the parents of Victoria College or the Girls' College questioning it. The point is the total amount will increase, the grant will be larger because the children who are in the non fee paying schools will not be paying for examination fees so the cost to the Education will increase and then when that cost is worked out 50 per cent of the cost for each pupil in secondary education is grant aided to the fee paying schools so in fact there will be an increased grant."

Senator Rothwell - ``The President in reply stated that she had no reaction from the colleges - would that be because perhaps the parents of pupils attending the colleges perhaps have more money than those hard working parents, seriously, there are an awful lot of hard working parents who are furious at the discrimination as a

result of this policy decision?"

President, Education Committee -``That is not the impression we got from the heads. The head teachers of both De La Salle and Beaulieu said that the Evening Post had misreported the whole thing and caused this problem. They were very concerned. They said they understand perfectly that they are in receipt of a grant when it might interest Members to know that the fees currently at De La Salle and Beaulieu are #1,080 and the grant that they receive is #1,086 per pupil. Now as I have said and I will repeat we met both the heads who were going back and were going to call meetings with their governors and they were hoping to be able to come back very quickly to tell us that they could see their way forward so as to treat the parents of their schools exactly the same as the other fee paying schools and if they do that we are able to assist the difference this year but as I repeat next year every pupil in fee paying schools will be treated exactly the same."

Senator B. Brooke - ``If I have a daughter at the Girls' College do I understand that the examination fees for my daughter at the Girls' College will not be billed to me?"

President, Education Committee -"That's right. The grant will allow for 50 per cent, now what the schools decide to do will I hope be that they will not be charging. Obviously there will be some parents who will be concerned if for instance their children are not sitting these examination fees they will be paying slightly more in school fees to accommodate those that do. But I believe that the parents that send their children to the colleges or De La Salle or Beaulieu hope that their children will be sitting exams and so it will be spread over the whole school fees."

Senator Brooke - ``So that if I have a daughter at the Girls' College I will

have an extra added to my school fees to pay for the fees of all children sitting examinations at the Girls' College. Secondly, if I have a daughter at Beaulieu I may or may not be billed for my school fees according to what the governors decide. Whether they decide to take the additional grant and use it for the payment of school fees from the school or else they will decide to bill me for my daughter at Beaulieu and therefore it is up to the parents, teachers of Beaulieu and the Girls' College to see the position with their head teachers. Is that what the position is? It was not clear to me but now if the President would confirm that, I am happy?"

President, Education Committee ``What we are hoping, Senator, is that
the governors both of De La Salle and
Beaulieu will adopt the same procedure
which will apply at the colleges. Now
if they can come back and say that is
their decision we have to be able to
help them this year with the small
amount of money that is involved."

Senator R.J. Shenton - ``The statement by the President is that it has been misinterpreted and interpreted in a way which has caused a great deal of concern Senator Rothwell is right. I believe that the President of Education's policy is heading in the right direction and I think that a statement to the paper not in the public notices but spend a bit of money and get it in a prominent place outlining what is your policy on this matter should be done. My view has always been and I say this to the President, would she not agree that parents who pay fees are in some ways helping the finances of the States because they are paying something out towards to the education. I believe and I ask the President if she will not consider perhaps that that sum rather like BUPA should be allowable for a tax refund, bearing in mind the use that was made of that money. But equally on this matter I share and support her that what she is trying to

do is be fair to both sides and to provide that both sides will pay examination fees and bearing in mind that the grant is based on half of the cost then next year they will get half the cost of those examination fees whether they are at De la Salle, Beaulieu or anywhere else. Is that not right?"

President, Education Committee "Yes Senator, thank you, you have
understood what I have been trying to
explain and I am grateful. When we met
with the teachers we met with a
representative of the parents and he
promised in his newsletter to give the
full explanation to the parents but
certainly I hope that we will be able
to clear this matter up and if we can
get the Evening Post perhaps to
clearly state what our intention is I
will be grateful because I don't think
what was in the Evening Post on Friday
was helpful to anyone."

President, Education Committee

"The percentage of the Island's school pupils attending independent private schools as at 20th January 1990 was 20.74 per cent."
