Members considered the option of finding local experts to assist with a review, and various names were suggested. It was agreed that the Chairman would revisit previous draft terms of reference and circulate ideas prior to discussion at a subsequent Panel meeting. 	The Panel noted that recent incidents had resulted in significant damage to internal furniture and fittings in properties where uPVC windows had ignited during fires; this might raise questions about the appropriateness of uPVC material for replacement windows.	
	Members also noted that following recent increases to planning charges, while there was now an overall cap in place some charges were apparently making a profit for the department. This was considered questionable, and members agreed to raise the matter with the Minister at a forthcoming public hearing.	МО
