**Explanatory Note regarding subordinate legislation tabled at this meeting.**

**R&O 62/2003**

This Order amends the Conservation of Wildlife (Jersey) Law 2000 so as change the status of the feral pigeon (*Columba livia*) for the purposes of the Law from “protected wild bird” to “wild bird”.

The Order was made on 17th July 2003 and comes into force on 24th July 2003.
