# **DRAFT EXTRADITION (DESIGNATED TERRITORIES) (JERSEY) REGULATIONS 200-**

## **REPORT**

---

The purpose of the draft Regulation is to specify the countries and territories to which extradition from Jersey will normally be available, pursuant to the Extradition (Jersey) Law 2004.

The designated territories are divided into two categories. When dealing with an application for extradition to a First category designated territory, the Magistrate may act on information other than evidence. In dealing with applications from Second category territories, the Magistrate must consider the sufficiency of the evidence against a person accused of an extradition offence.

These Regulations are necessary for the proper functioning of the Extradition Law and, therefore, must be made by the States before the Law can be brought into force.

There are no financial or manpower implications for the States arising from these draft Regulations.

## **Explanatory Note**

---

These Regulations specify designated territories of the first category and designated territories of the second category under the Extradition (Jersey) Law 2004.

The Regulations will come into force on the same day as the Law.

**THE STATES**, in pursuance of Articles 6 and 120 of the Extradition (Jersey) Law 2004,<sup>[1]</sup> have made the following Regulations –

---

### **1 Designated territories of the first category**

The territories specified in Schedule 1 to these Regulations are specified as territories in Part 1 of Schedule 1 to the Extradition (Jersey) Law 2004.<sup>[2]</sup>

### **2 Designated territories of the second category**

The territories specified in Schedule 2 to these Regulations are specified as territories in Part 2 of Schedule 1 to the Extradition (Jersey) Law 2004.<sup>[3]</sup>

### **3 Citation and commencement**

- (1) These Regulations may be cited as the Extradition (Designated Territories) (Jersey) Regulations 200-.
- (2) These Regulations shall come into force on the same day as the Extradition (Jersey) Law 2004.
