Explanatory Note

These Regulations amend further the Costs in Criminal Cases (Witnesses' Allowances) (Jersey) Regulations 1973. The purpose of the amendments is to increase allowances payable out of public funds to persons attending at court (that is, the Royal Court, the Court of Appeal or the Magistrate's Court) to give evidence in criminal cases.

The allowances are paid under the following headings -

Regulation 2 professional witness.

Regulation 4 loss allowance to witness who is neither a professional witness nor an expert.

Regulation 5 subsistence allowance to witness who is neither a professional witness nor an expert witness.

Regulation 6 allowance for witness obliged to be away from home overnight.

Regulation 8(3) allowance for hire of vehicle within the Island where public transport not available.

The allowances were last increased in 1999.

Financial/manpower statement

The Committee noted that the additional annual cost to be incurred as a result of the implementation of the new rates would be in the order of £8,000, and there were no manpower implications for the States arising from the Regulations.

THE STATES, in pursuance of Article 6 of the Costs in Criminal Cases (Jersey) Law 1961, $^{[1]}$ as amended, have made the following Regulations -

- 1. In the Costs in Criminal Cases (Witnesses' Allowances) (Jersey) Regulations 1973, [2] as amended, in relation to the Regulation specified in the first column of the Schedule to these Regulations, for the monetary amount specified in the second column of the said Schedule there shall be substituted the monetary amount specified in the third column thereof.
 - 2. The following Regulations shall be repealed -
 - (a) Costs in Criminal Cases (Witnesses' Allowances) (Amendment No. 2) (Jersey) Regulations 1989, [4]
 - (b) Costs in Criminal Cases (Witnesses' Allowances) (Amendment No. 3) (Jersey) Regulations 1993, [5]
 - (c) Costs in Criminal Cases (Witnesses' Allowances) (Amendment No. 4) (Jersey) Regulations 1999.
- 3. These Regulations may be cited as the Costs in Criminal Cases (Witnesses' Allowances) (Amendment No. 5) (Jersey) Regulations 200 and shall come into force on the day following promulgation.
