This Order revokes and replaces a previous Order giving effect to a Community Council Regulation prohibiting the sale, supply and export to Burma/Myanmar of equipment which might be used for internal repression or terrorism and freezing the funds of certain persons related to important governmental functions in that country. The Regulation that the previous Order gave effect to has been amended by a Commission Regulation so as to update the list of persons subject to restrictive measures and this Order gives effect to the Regulation as so amended.

The Order was made on 17th January 2003 and came into force the day after it is made.


