<p><b>15/02/10</b> <b>Item 2</b></p> <p><b>513/25(4)</b></p>	<p><b>1. Public Hearings</b></p> <p>The Sub-Panel received the Health and Social Services Minister for a Public Hearing. The Minister was accompanied by Ms. M. Cabot, Information Governance Manager of Health and Social Services.</p> <p>During the Hearing the Information Governance Manager explained to the Sub-Panel statistics relating to subject access requests that the Department received. The statistics were given to the Sub-Panel at the end of the Hearing, and the Minister for Health and Social Services and Information Governance Manager withdrew from the Hearing.</p> <p>The Sub-Panel received Mr R. Shead, President of the Chamber of Commerce for a Public Hearing. It was explained to the Sub-Panel that the President was not familiar with the Data Protection (Jersey) Law 2005, however that he would be happy to put forward his views on the eight proposed amendments and how they might affect businesses.</p> <p>The Sub-Panel thanked the President and he withdrew from the Hearing.</p> <p>The Sub-Panel received the Minister for Economic Development and Mr J. Mews, Director, Finance Industry Development for a Public Hearing. During the Hearing the Sub-Panel heard that the Minister had not had sufficient time to prepare for the Hearing and subsequently after the Minister had withdrawn from the Hearing, the Sub-Panel requested the Scrutiny Officer to draft a letter to the Minister to request his views on the proposed amendments.</p> <p>The Sub-Panel received Deputy E. J. Noel, Assistant Minister for Treasury and Resources and Mrs. E. Martins, Data Protection Commissioner for a Public Hearing.</p>
