	2. Meeting with Minister for Treasury and Resources – File Note	
513/21 (8)	The Sub-Panel received and discussed the file note from the meeting between the Sub-Panel Chairman and the Minister for Treasury and Resources, which had taken place on the 5th July 2010. The Sub-Panel noted that the Minister had been concerned about deferring the debate of P.73/2010 "Property and Infrastructure Regeneration: States of Jersey Development Company Limited", and it was decided that the review would be completed as quickly as possible.	
	3. Public Hearings	
513/21(8)	The Sub-Panel recalled that the Assistant Minister for Treasury and Resources and Director of Property Holdings had been unavailable to attend the scheduled Public Hearing on 9th July 2010. It was noted that the Minister had intended to attend the Hearing instead of the Assistant Minister for Treasury and Resources however; this had not been accepted by the Sub-Panel. It was decided that the issue would be raised with the Corporate Services main Panel and a letter would be drafted to the Treasury and Resources Minister, on behalf of the Panel Chairman, Senator S.C.
