

It received hard copies of the agreed question plan and discussed further areas of questioning.</p> <p>The Panel received the Chief Minister, Senator T.A. Le Sueur and the Chief Executive, Mr. W. Ogle for a quarterly Public Hearing.</p> <p>The Panel requested that the Hearing would be transcribed within a fast turnaround timescale due to discussions surrounding the Fiscal Strategy Review which had taken place during the Hearing.
