DRAFT POLICING OF PARKS (AMENDMENT No. 6) (JERSEY) REGULATIONS 201-

REPORT

To enable proper policing and management of Moignard Liberation Garden and the Elephant Park, it is necessary to formally designate these areas as 'Parks' by including them under Part 2 and Part 5 (respectively) of the Schedule to the Policing of Parks (Jersey) Regulations 2005 ("the 2005 Regulations").

Listing Moignard Liberation Garden under Part 2 of the Schedule to the 2005 Regulations will make it necessary for dog-owners to ensure that their dogs are on a lead within the confines of the park.

Listing the Elephant Park under Part 5 of the Schedule to the 2005 Regulations will prohibit persons from taking an animal into the park, unless that person is in charge of an assistance dog, or is a police officer or an officer of the Impôts working that dog in the course of his or her duty.

Financial and manpower implications

There are no financial or manpower implications for the States arising from the adoption of these draft Regulations.



Explanatory Note

Regulation 1 adds the Elephant Park in St. Brelade and the Moignard Liberation Garden in St. Lawrence to the areas designated as parks under the Policing of Parks (Jersey) Regulations 2005 (the "2005 Regulations"). The plans of the areas are set out in the Schedule.

The Moignard Liberation Garden is designated as a Part 2 park in the Schedule to the 2005 Regulations, which means that (by virtue of Regulation 5(5) of the 2005 Regulations) a person may only take a dog into that park so long as the dog is kept on a lead. The plan of the Moignard Liberation Garden is set out in Part 1 of the Schedule to these Regulations.

The Elephant Park is designated as a Part 5 park in the Schedule to the 2005 Regulations, which means that (by virtue of Regulation 5(1) of the 2005 Regulations) a person must not take an animal into that park unless the person is in charge of an assistance dog (within the meaning of Regulation 1(1) of the 2005 Regulations), or is a police officer or officer of the Impôts working a dog in the course of his or her duty (see Regulation 5(2) and (3) of the 2005 Regulations). The plan of the Elephant Park is set out in Part 2 of the Schedule to these Regulations.

Regulation 2 provides for the title of the Regulations and for their coming into force 7 days after they are approved by the States.

1 Policing of Parks (Jersey) Regulations 2005 amended

- (1) In Part 2 of the Schedule to the Policing of Parks (Jersey) Regulations 2005³ (the "2005 Regulations"), after the plan showing Harvey Memorial Gardens there is inserted the plan set out in Part 1 of the Schedule to these Regulations.
- (2) In Part 5 of the Schedule to the 2005 Regulations, immediately before the plan showing Howard Davis Park there is inserted the plan set out in Part 2 of the Schedule to these Regulations.

2 Citation and commencement


These Regulations may be cited as the Policing of Parks (Amendment No. 6) (Jersey) Regulations 201- and shall come into force 7 days after they are made.


