REPORT

This Act would bring Article 33 of the Police Procedures and Criminal Evidence (Jersey) Law 2003 into force 7 days after this Act, but only for the purposes of Orders made under Article 107 of the Law.

Article 107 enables the Home Affairs Committee, after consultation with the Finance and Economics Committee to apply provisions of the Law to investigations by the Agent of the Impôts into matters assigned under the Customs and Excise (Jersey) Law 1999.

As it would be applied by such an Order, Article 33 would enable the Agent of the Impôts to designate customs offices as places where arrested persons may be detained.

There are no financial or manpower implications for the States arising from this draft Act.

Explanatory Note

This Act would bring Article 33 of the Police Procedures and Criminal Evidence (Jersey) Law 2003 ('the Law') into force 7 days after this Act is made, but only for the purposes of Orders made under Article 107 of the Law.

Article 107 enables the Home Affairs Committee, after consultation with the Finance and Economics Committee, to apply provisions of the Law to investigations by the Agent of the Impôts into matters assigned under the Customs and Excise (Jersey) Law 1999.
