Explanatory Note regarding subordinate legislation tabled at this meeting.

R&O.28/2007

This Order specifies dates and times when parts of the beaches at Millbrook, West Park and St Ouen's Bay may be closed to normal traffic, and used, by the Jersey Motor Cycle and Light Car Club for the purposes of sand races and practices.

The Order was made on 9th February 2007 and came into force on being made.

R&O.29/2007

This Order specifies dates and times when Bouley Bay Hill and the Five Mile Road course may be closed to normal traffic, and used, by the Jersey Motor Cycle and Light Car Club for the purposes of motor races and practices.

The Order was made on 9th February 2007 and came into force on being made.

R&O.30/2007

This Order prohibits waiting on a small section of La Route des Côtils in Grouville.
The Order was made on 9th February 2007 and comes into force on 16th February 2007.

R&O.31/2007

This Order makes further restrictions on traffic in respect of certain roads in the parish of St. Lawrence as follows –

- (a) it prohibits waiting on parts of La Rue de la Blanche Pierre;
- (b) it closes to through traffic the unnamed road that runs between Sandybrook Lane and La Vallée de St. Pierre;
- (c) it prohibits the use of part of La Rue de Haut and Le Mont Cambrai by wide vehicles; and
- (d) it restricts the length of time allowed for parking on part of Les Charrières Malorey.

The Order was made on 9th February 2007 and comes into force on 16th February 2007.
