"Will the Minister inform Members why no Appointed Day has been lodged for approval to bring into force Articles 30 to 32 and 34 to 48 of the Police Procedures and Criminal Evidence (Jersey) Law 2003, which relate to bail and detention and how many suspects since 2003 have been released pending further police enquires but have failed to return on the prescribed date?"

4. Deputy T.M. Pitman of St. Helier will ask the following question of the Minister for Housing -

"Given that 1(1)(k) residents can be accepted into the Island having negotiated individual tax deals, would the Minister agree to bring forward legislation to provide that, even after such residents have been registered for the obligatory 10 year period, they should be prevented from making multiple investments in the (a)-(h) housing market and potentially impacting upon others seeking to get onto the housing ladder?"

5. The Deputy of Grouville will ask the following question of the Minister for Planning and Environment –

"Given that on 2nd April 2009, the Assembly agreed that the Minister should bring forward a policy that requires planning applications over a certain size to provide a percentage of their build for social need, whether that be social rented, first-time buyer, retirement, sheltered housing or a mix, whichever is the most appropriate to the site, could the Minister confirm when such a policy is likely to be published?"

6. The Deputy of St. John will ask the following question of the Minister for Economic Development –

"Would the Minister advise whether the numbers of travellers by air and sea to Jersey in 2008 has increased, whether this translates to an increase in bed occupancy figures, and outline what measures, if any, he plans to put in place to reverse the decline in Tourism?"

"Would the Minister advise when the United Kingdom was officially informed of the Island's intention to construct an incinerator adjacent to a designated Ramsar site, in accordance with Article 3.2 of the Convention; whether the Ramsar secretariat was officially informed, and what studies, if any, there have been on the anticipated impacts of airborne pollutants from the incinerator on marine habitats and life-forms within the Ramsar site?"

8. Deputy G.P. Southern of St. Helier will ask the following question of the Minister for Social Security –

"In the light of the criticism of the Income Support (IS) system made within the recent draft report commissioned by the Connétable of St Helier, will the Minister now consider an urgent review of the operation of the Household Medical Account component of IS which was the subject of particular attention within the said report?"

9. Senator S. Syvret will ask the following question of H.M. Attorney General -

"Will H.M. Attorney General advise whether discussions have taken place between his Department and those insurers of the States of Jersey who may be expected to fund compensation should any successful claims be made against the States by child abuse survivors and, if so, list the insurers involved, and state what rôle he, or officers of his Department have played in any negotiations concerning compensation, including any putative redress board?"

10. The Deputy of St. John will ask the following question of H.M. Attorney General -

"Following recent events at Westminster, would the Attorney General advise whether members have any protection from investigation by the police within the States building whilst carrying out their business as Ministers, Scrutiny Panel members or backbenchers and if so, outline what

- protection exists and whether a warrant to search members' possessions, lockers, desks and computers within the States building could be issued, by whom and on what grounds?"

This Order exempts certain persons carrying on certain kinds of business from the requirement to be registered under the Proceeds of Crime (Supervisory Bodies) (Jersey) Law 2008 in respect of such business until 19th June 2009. The exemption applies to persons carrying on a regulated business and applies only in respect of business falling within items 4, 5 or 6 of the Schedule to that Law. Persons carrying on a regulated business are, broadly persons carrying on business under the Banking Business (Jersey) Law 1991, the Insurance Business (Jersey) Law 1996, the Collective Investment Funds (Jersey) Law 1988, or the Financial Services (Jersey) Law 1998 ("the regulatory Laws"). Items 4, 5 and 6 of the Schedule refer broadly to certain kinds of business exempt from registration or regulation under the regulatory Laws.

The Order was made on 19th December 2008 and came into force forthwith.

This Order replaces the Community Provisions (Restrictive Measures – Iran) (Jersey) Order 2007. It updates prohibitions and restrictions on trade with Iran, provisions for the freezing of funds of persons connected with Iran and provisions for the reporting of transactions connected with Iran. It also introduces requirements for the provision of information, in the event that Iranian carriers arrive at or depart from the harbours or airport.

The Order was made on 2nd January 2009 and came into force on 8th January 2009.

BIOGRAPHIES

Mr. Martin Paul Magee

Mr. Magee (48) joined the Jersey Electricity Company as Finance Director in May 2002. He moved from Scottish Power Plc, the UK based utility, after 9 years in a variety of senior finance roles at a corporate level, but also as Financial Controller of its telecom subsidiary and the electricity supply and distribution business. He previously worked for 9 years with Stakis Plc. (now part of the Hilton Hotels Group) in a number of positions including Company Secretary and Development Manager within its Leisure Division, as well as spending 2 years in Spair with its hotels business. He is a member of the Institute of Chartered Accountants of Scotland, having qualified in 1984. He was born in Glasgow in 1960 and is married with 2 sons. Mr. Magee served on the previous PAC an will provide a degree of continuity.

Mr. Patrick John Dennis Ryan

Mr. Ryan (60) is Jersey-born and was educated at Victoria College and Elizabeth College, Guernsey. After UK training in mechanical engineering his entrepreneurial career (principally in the motor trade) developed with UK-based companies and then, after his return to the Island in 1979, local companies such as Cleveland Garages, as Managing Director, until its sale in 1988 and then the Freelance Motor Group which he sold in 2002. He remains non-executive chairman of, and shareholder in, the commercial landscaping company Augrès Landscape.

In 2002 he successfully stood as a Deputy in St. Helier No. 1. His States career included the Presidency of th Committee for Postal Administration during the difficult transition towards incorporation between 2002 and 2005, and this first 3 year term also included membership of the Economic Development Committee, where he had responsibility for Competition Law, Consumer Affairs, the Construction Industry and the Financial Services Sector in 2004/5.

After re-election, and for the last 3 years, Mr. Ryan led the Corporate Services Scrutiny Panel as its Chairman, th Panel completing a number of complex reviews into the Fiscal Strategy, including GST, zero/ten and other taxes, as well as more general items such as Bovine Semen Importation, Age of Consent and States Property matters.

Mr. Kevin Keen

Kevin Keen (50) was born and educated in Jersey. After working in the local accounting profession from the age of 16 years, he joined Le Riche Group in 1985 where he was appointed Group Finance Director in 1995 and subsequently Managing Director of the largest division in 2000. He joined Jersey Dairy in early 2003 as Managing Director, and led that business through a period of substantial and successful change before leaving in 2007 to pursue other interests.

He is currently Finance Director of Voisins Department Store and also non-executive director of 3 loca companies, one of which is Jersey Water. In addition, he is actively involved in a number of not-for-profit organisations, including the Jersey Battle of Flowers Association and Family Nursing and Home Care.

"In the light of the critical report recently delivered on the effectiveness and efficiency of the Income Support system, will the Minister now agree to a full and comprehensive review of the 'fitness for purpose' of Income Support this year, as previously proposed, paying particular attention to incentives to work and save; access to GP's; prompt access and greater flexibility over special payments, and the issue of community visitors to protect the vulnerable, and if not, why?"

5. The Chief Minister will table an answer to the following question asked by Deputy G.P. Southern of St. Helier-

"In the light of the Woolworths insolvency, and consequent redundancies, will the Chief Minister inform members what consideration, if any, the Council of Ministers has given to supporting the workers already affected by these redundancies in the short term?

Would the Chief Minister advise what steps, if any, have been, or are to be, taken to establish proper protection for Jersey employees in similar circumstances in the long term; in what timescale does he see these measures being in place, and what intermediate measures, if any, does he envisage being put in place

What research and information, if any, does the Council of Ministers have on the scale of recession in Jersey and potential insolvencies and redundancies in 2009 and beyond?"
