"How many meetings the Jersey Police Authority has held since she became Minister and how many has she attended?"

Explanatory Note regarding subordinate legislation tabled at this meeting.

R&O.28/2016.

This Order amends the EU Legislation (Sanctions – Belarus) (Jersey) Order 2015 to give effect in Jersey to the amendments made to the implemented Council Regulation (EC) No 765/2006 by Council Regulation (EU) 2016/277 of 25th February 2016 (OJ L 52, 27.2.2016, p. 22). The effect of those amendments is to bring to an end completely the freezing measures, which had already been suspended, against persons listed in Annex IV to Regulation (EC) No 765/2006.

The list, in Annex I to Regulation (EC) No 765/2006, of those on whom the freezing measures are imposed continues to have effect.

The Order was made on 8th March 2016 and came into force on 9th March 2016.

R&O.29/2016.

This Order extends the definition of "animals" in the Diseases of Animals (Jersey) Law 1956 to include donkeys and zebras and the definition of "disease" in that Law to include African horse sickness. It also prohibits the use of a vaccine against the disease except in accordance with a licence granted by or on behalf of the Minister for the Environment and revokes an earlier Order dealing with African horse sickness.

The Order was made on 8th March 2016 and came into force on being made.

R&O.30/2016.

This Order prescribes the fee payable upon an application by a person to be approved under the Veterinary Surgeons (Jersey) Law 1999 as a person who may carry out certain dental activities in relation to horses or for carrying out artificial insemination of a domestic animal, a procedure to transfer, or to assist in transferring, embryos between cattle, or the implantation into an animal of a transponder.

The fee that is payable upon such an application for approval is £46.

The Order was made on 15th March 2016 and came into force on 16th March 2016.

R&O.31/2016.

This Order amends the Companies (Transfers of Shares – Exemptions) (Jersey) Order 2014, to add as approved stock exchanges the Luxembourg Stock Exchange and the Johannesburg Stock Exchange (and accordingly to add the laws of South Africa to the definition of relevant laws).

The Order was made on 16th March 2016 and came into force on 17th March 2016.

"Following changes made to the personal tax system over the last 10 years, could the Minister please provide a statement of:

- 1. any actual loss of revenue due to allowances within the marginal relief tax system and the dates at which allowances were changed;
- 2. any actual loss of revenue due to the allowances within the 20-means-20 tax system and the dates at which allowances were changed;
- 3. any actual loss of revenue due to the change in the marginal rate; and
- 4. any actual loss of revenue due to changes in stamp duty?"
- 5. The Minister for Housing will table an answer to a question asked by the Deputy of St. John –

"Would the Minister provide a full list of initiatives led by the government which are currently in place to assist the people of Jersey onto the property ladder, stating whether, in comparison with the former States loan scheme, they have improved the position? Would the Minister also advise whether consideration would be given to re-introducing such a scheme?"

Will he further explain whether he thinks it acceptable that those responsible for making defamatory statements should be defended by the Law Officers Department, Crown Advocates or other advocates at public expense when legal aid is not available for such causes of action and most ordinary individuals cannot afford the legal costs of such action?

Would the Chief Minister also advise whether he agree that all Ministers and States employees should defend at their own cost legal actions brought against them for any alleged defamatory statements made during the course of their employment?"

"Further to the report of the Channel Islands Competition and Regulatory Authorities which ranked JT last among telecom providers for consumer satisfaction, will the Minister, as shareholder representative, state whether this is acceptable, and explain to Members what action, if any, he proposes to take to ensure that this situation is not allowed to continue?"

8. The Chief Minister will table an answer to the following question asked by Deputy M.R. Higgins of St. Helier –

"With regard to the renewal of the Fuel Farm lease, will the Chief Minister set out for Members a detailed chronology of the key actions, decisions and events from January 2012 which led to the renewal of the lease, identifying the Ministers and officers (by title) who were involved at each stage?"

Will she further advise members of the number of persons who have been unemployed for one, 2, 3, 4, 5, 6, 7, 8, 9 or 10 years as well as those who have repeatedly been in and out of employment for whatever reason between 2008 and 2015 after training, work experience and self-employment?"

16. The Minister for Infrastructure will table an answer to the following question asked by Deputy J.M. Maçon of St. Saviour –

"Will the Chief Minister outline the timetable for proposals for an additional waste charge to include –

- Green paper stage;
- White paper stage;
- Scrutiny review period;
- amendments post scrutiny review;
- lodging for debate;
- debate?"
- 17. The Chief Minister will table an answer to the following question asked by Deputy S.Y. Mézec of St. Helier –

"Could the Minister provide a breakdown of plane journeys costing over £1,000 taken by senior civil servants in each States department over the last 5 years?"

24. The Minister for Social Security will table an answer to the following question asked by Deputy G.P. Southern of St. Helier –

"Given that up to 50 cleaning and gardening posts could be made redundant from the Department for Infrastructure, what estimates does the Minister have for any additional Income Support costs, based on a normal distribution by marital status among the workforce and an average claim of £450 per week?

Furthermore, what estimates does the Minister have for any impact on Social Security contributory funding? Can the Minister outline how much less each employee would provide in Social Security contributions if paid at the minimum wage of £7 per hour in alternative employment, and state what additional supplementation would be required and whether this would have a negative annual impact on Social Security contributory funding?"
