## **DRAFT CRIMINAL JUSTICE (MISCELLANEOUS PROVISIONS) (JERSEY) LAW 2016 (APPOINTED DAY) ACT 201-**

### **REPORT**

---

The Draft Criminal Justice (Miscellaneous Provisions) (Jersey) Law 201- ([P.87/2015](#)) was adopted by the States on 20th October 2015. It subsequently received Privy Council sanction on 10th February 2016 and was registered by the Royal Court on 19th February 2016, becoming part of Jersey's Laws Enacted as the Criminal Justice (Miscellaneous Provisions) (Jersey) Law 2016 ("the Law") ([L.1/2016](#)).

The Law increases from £5,000 to £10,000 the jurisdiction of the Magistrate's Court to impose fines. It also reforms the standard scale of fines by fixing –

- (a) level 1 on the scale at 2% of that jurisdiction (£200), and
- (b) level 2 on the scale at 10% of that jurisdiction (£1,000), and
- (c) level 3 on the scale at 100% of that jurisdiction (£10,000).

Level 4 on the standard scale will cease to exist.

The Law also widens the powers of the States to make Regulations amending legislation concerning the jurisdiction of the Magistrate's Court to impose fines, and the standard scale of fines.

This Act would bring the Law into force (with the exceptions listed in Article 1(2) of the Act) 7 days after the Act is adopted.

#### **Financial and manpower implications**

There are no financial or manpower implications for the States arising from the adoption of this draft Act.

## Explanatory Note

---

This Act would bring into force the Criminal Justice (Miscellaneous Provisions) (Jersey) Law 2016 (adopted by the States on 20th October 2015, P.87/2015).

Amendments made by that Law to 4 enactments are not commenced. The amendment to Article 5(1) of the Aerodromes (Administration) (Jersey) Law 1952 is not commenced as it is to be replaced by the amendment made to that Article by the Criminal Justice (Miscellaneous Provisions) (Jersey) Regulations 201- (P.74/2016). The remaining amendments that are not commenced have, since their enactment, been superseded by other enactments, and so are no longer required.

**THE STATES**, in pursuance of Article 5 of the Criminal Justice (Miscellaneous Provisions) (Jersey) Law 2016<sup>1</sup>, have made the following Act –

### **1 Law commenced**

- (1) Subject to paragraph (2), the Criminal Justice (Miscellaneous Provisions) (Jersey) Law 2016<sup>2</sup> shall come into force 7 days after this Act is made.
- (2) The following amendments made by Schedule 1 are not commenced –
  - (a) the amendment of Article 5(1) of the Aerodromes (Administration) (Jersey) Law 1952<sup>3</sup>;
  - (b) the amendments of Article 19(1) and (2) of the Registered Designs (Jersey) Law 1957<sup>4</sup>;
  - (c) the amendment of Regulation 4(8) of the Harbours (Jersey) Regulations 1962<sup>5</sup>;
  - (d) the amendments of Articles 25(2) and 27(2) of the Road Traffic (Jersey) Law 1956<sup>6</sup>.

### **2 Citation and commencement**

This Act may be cited as the Criminal Justice (Miscellaneous Provisions) (Jersey) Law 2016 (Appointed Day) Act 201- and shall come into force on the day after the day it is made.
