| | The Panel noted that the cost estimate which stood at £7,002.54 was based on five people travelling, three Panel members, one Scrutiny Officer and Mr. D. Mason [The latter was advising the Panel on this review and had, in fact, carried out a "dry run" to establish a suitable programme to maximise the use of the time in Vienna at a cost of £1,220 which was included in the cost estimate above.] It was also noted that the estimate non-inclusive of Mr Mason's costs stood at £5782.54 for 5 persons. | |
