Motor Vehicle Registration (General Provisions) (Amendment No. 23) (Jersey) Order 2022.

Minister for Infrastructure.

This Order amends the Motor Vehicle Registration (General Provisions) (Jersey) Order 1993 to allow the Inspector of Motor Traffic to remove a registered vehicle from the register of motor vehicles (“register”) if, after making enquiries, the Inspector receives no information about whether the motor vehicle is in existence and its ownership and whereabouts.

Article 1 is an interpretation provision.

Article 2 replaces and updates existing Article 13 of the Order which makes provision for the Inspector to serve an initial notice on a person recorded in the register as the owner of a vehicle to provide the Inspector with particulars about the vehicle, including whether it still exists, has been permanently removed from Jersey or its owner has changed. The new Article 13 sets out the steps that the Inspector must take if the Inspector does not receive any of the information requested. After a period of not less than 3 months after the initial notice the Inspector must publish a notice in the Jersey Gazette of the recorded particulars of the vehicle and give notice that if the registered owner does not respond within one month, registration of the vehicle may be cancelled. If the Inspector has still not received any of the requested information 12 months after the initial notice, the Inspector may assume that the vehicle has been permanently removed from Jersey, broken up or destroyed and must cancel the registration of the vehicle unless exceptional circumstances apply.

Article 3 replaces and updates existing Article 15 of the Order which deals with amendment of the register if the Inspector thinks that particulars that are in the register may be incorrect or incomplete. The new Article 15 also provides for when the Inspector, having made some enquiries under Article 13 and initially failed to receive any of the requested information, subsequently receives some information upon making further enquiries under that Article. At that point, the Inspector may follow the steps set out in Article 15, to the extent appropriate, in determining whether to amend the register.

Article 4 replaces and updates existing Article 16 of the Order which sets out the circumstances in which the Inspector may cancel and replace a registration document. Like Article 15, the new Article provides for when the Inspector, having made an enquiry under Article 13 and failed to receive any of the requested information, subsequently receives some information upon further enquiry under that Article. At that point, the Inspector may follow the steps set out in Article 16, to the extent appropriate, in determining whether to cancel or replace a registration document.

Article 5 amends Schedule 4A to the Order. Schedule 4A deals with the assignment of a mark-right in respect of a vehicle where the previous owner of the vehicle is a party to the arrangement. The amendments provide for a mark-right of a registration mark to be assigned where the registration of the vehicle to which the registration mark was assigned has been cancelled following lack of any requested information or where a person other than a registered owner confirms that a vehicle has been permanently destroyed or removed from Jersey. In such circumstances, the Inspector may grant a mark-right in respect of that registration mark to another person provided that at least 12 months have elapsed from the date of cancellation. The amendments also make clear that any rights held by a person recorded as the registered owner of the vehicle immediately before cancellation are extinguished.

Article 6 sets out the title of this Order and provides for it to come into force 7 days after the day it is made.

The Order was made on 28th February 2022 and came into force on 7th March 2022.

Sanctions and Asset-Freezing (Implementation of External Sanctions) (Amendment – Russia) (Jersey) Order 2022.

Minister for External Relations and Financial Services.

This Order amends the table in Schedule 1 to the Sanctions and Asset-Freezing (Implementation of External Sanctions) (Jersey) Order 2021, to implement changes in UK sanctions brought about by –

- (a) the Russia (Sanctions) (EU Exit) (Amendment) (No. 2) Regulations 2022 of the UK, which came into force at the start of 1st March 2022;
- (b) the Russia (Sanctions) (EU Exit) (Amendment) (No. 3) Regulations 2022 of the UK, which came into force at the start of 1st March 2022;
- (c) the Russia (Sanctions) (EU Exit) (Amendment) (No. 4) Regulations 2022 of the UK, which came into force at 3 p.m. on 1st March 2022.

Those Regulations each amended the Russia (Sanctions) (EU Exit) Regulations 2019 of the UK (SI 2019/855, as amended). The amendments made by this Order add new duties and prohibitions, from the amended UK Regulations, to the list of duties and prohibitions that it is an offence to contravene. Those duties and prohibitions concern financial services and shipping (the other amendments effected by the UK Regulations took effect automatically as soon as they came into force). The new duties and prohibitions are contained in regulations 16(4A), 16(4C), 16(4E), 17A(1), 17A(2), 57A(1), 57A(2), 57B(4) and 57C(3) of the amended Russia (Sanctions) (EU Exit) Regulations 2019 of the UK.

This Order comes into force immediately after the midnight following its making.

The Order was made on 1st March 2022 and came into force on 2nd March 2022.

Financial Services (Amendment of Schedules to Law) (No. 2) (Jersey) Order 2022.

Minister for External Relations and Financial Services.

The Financial Services (Amendment of Schedules to Law) (No. 2) (Jersey) Order 2022 amends Schedules 1 and 2 to the Financial Services (Jersey) Law 1998 (the “1998 Law”) to provide that pension schemes fall under the definition of investments according to Schedule 1 of that Law. In particular –

Article 1 substitutes paragraph 9A of Schedule 1 to the 1998 Law to provide that pensions schemes (as defined in that paragraph) fall under Schedule 1 rather than only defined benefit schemes. *Article 1* also inserts a note providing that substituted paragraph 9A applies only to the giving of investment advice in respect of a pension scheme, and deletes the note appended to paragraph 10 of the Schedule.

Article 2 deletes paragraph 18 (defined benefit schemes) from Schedule 2 (exemptions) to the 1998 Law.

Article 3 gives the citation and provides that Order comes into force 7 days after it is made.

The Order was made on 3rd March 2022 and came into force on 10th March 2022.

Sanctions and Asset-Freezing (Implementation of External Sanctions) (Russia – Amendment No. 2) (Jersey) Order 2022.

Minister for External Relations and Financial Services.

This Order amends the Sanctions and Asset-Freezing (Implementation of External Sanctions) (Jersey) Order 2021, to implement further changes in UK sanctions Regulations in relation to Russia. In particular it makes it an offence to breach a prohibition on providing financial services to the Russian Central Bank and National Wealth Fund, introduced by the Russia (Sanctions) (EU Exit) (Amendment) (No. 5)



Regulations 2022 of the UK (which came into force at 5 p.m. on 1st March 2022). It also clarifies how the UK Regulations on detention of ships apply in Jersey through the Shipping (Jersey) Law 2002 (in doing so it reproduces a provision about Crimean port directions that is already in the Order).

This Order comes into force immediately after the midnight following its making.

The Order was made on 3rd March 2022 and came into force on 4th March 2022.

Trade Marks (Amendment) (Jersey) Order 2022.

Minister for External Relations and Financial Services.

This Order amends the Trade Marks (Jersey) Order 2000 (“the TM Order”), following the making by the Assembly of the Trade Marks, Registered Designs and Patents (Application Forms) (Jersey) Regulations 2022 (“the Regulations”). The Regulations remove the need for the TM Order to specify the manner and form in which certain applications are made, and instead allow the Judicial Greffier (as registrar) to publish a notice on a website setting out the manner of application (or to provide an online form).

This Order therefore deletes the provisions in Articles 2 and 3 of, and Schedule 1 to, the TM Order that set out the manner and forms for the applications. But Article 2 of the TM Order also set out fees for the applications, so those fees are reproduced (without increase or decrease) by a substituted Article 2.

The Order comes into force at the same time as the Regulations, which will be 9th March 2022.

The Order was made on 8th March 2022 and came into force on 9th March 2022.

R&O.30/2022.

Electronic Communications (Exclusion for Wills and Lasting Powers of Attorney) (Jersey) Order 2022.

Minister for Economic Development, Tourism, Sport and Culture.

This Order will ensure that Articles 9B and 9C of the Electronic Communications (Jersey) Law 2000 (as inserted by the Electronic Communications (Amendment No. 2) (Jersey) Law 202-) cannot be used in relation to the execution of a will.

Article 1 provides that Article 9B of the Electronic Communications (Jersey) Law 2000 does not permit the witnessing of the signature of the testator of a will or any other document that has testamentary effect to be carried out remotely by electronic means. It also provides that Article 9C of that Law cannot be used to authorise someone other than the testator to sign a will or other such document using an electronic signature.

Article 2 provides for the citation and commencement of the Order.

The Order was made on 9th March 2022 and came into force on 11th March 2022.

R&O.31/2022.

Sanctions and Asset-Freezing (Implementation of External Sanctions) (Russia – Amendment No. 3) (Jersey) Order 2022.

Minister for External Relations and Financial Services.

This Order amends the Sanctions and Asset-Freezing (Implementation of External Sanctions) (Jersey) Order 2021, to implement further changes in UK sanctions in relation to Russia, which are made by the Russia (Sanctions) (EU Exit) (Amendment) (No. 6) Regulations 2022 of the UK (which came into force at 5 p.m. on 8th March 2022).



In particular the Order makes it an offence to breach a prohibition on directly or indirectly providing insurance or reinsurance services relating to aviation and space goods, or aviation and space technology, to a person connected with Russia, or for use in Russia. It also makes it an offence for Russian aircraft to overfly, or land in, Jersey.

This Order comes into force immediately after the midnight following its making.

The Order was made on 9th March 2022 and came into force on 10th March 2022.

R&O.32/2022.

Taxation (Enveloped Property Transactions) (Statements) (Jersey) Order 2022

Minister for Treasury and Resources

This Order sets out the information that must be included in statements made under Articles 8 and 9 of the Taxation (Enveloped Property Transactions) (Jersey) Law 202- (the “Law”).

Article 8 of the Law requires a person to deliver a statement to the Comptroller if the person acquires a significant interest in an entity that owns enveloped property. *Article 2* of this Order prescribes the information a statement must contain. The statement must contain information about the entity, about the person or entity from which the interest was acquired, about the enveloped property and about the transaction.

Article 9 of the Law requires an entity to provide a statement to the Comptroller if a relevant transaction takes place in relation to the entity and no statement has been delivered under Article 8. *Article 3* of this Order prescribes the information a statement must contain and the form the statement must take. The statement must contain information about the entity and about the person who acquires a significant interest in the entity. The statement must be made using the electronic form provided by the Comptroller or by an alternative means, if any, provided by the Comptroller.

Article 4 gives the name of the Order and provides that it comes into force on the commencement of the Law.

The Order was made on 11th March 2022 and came into force on 4th April 2022.

- (c) whether any Government policy or procedure determines whether the land, after removal, is deemed suitable for all types of agriculture; and
- (d) whether there is, or has been, any financial assistance available from the Government for the purpose of removing greenhouses or polytunnels?”

3. The Chair of the Privileges and Procedures Committee tabled an answer on 7th March 2022 to the following question asked by Deputy J. M. Maçon of St. Saviour:

“Further to the response to Written Question 54/2022 in relation to hustings arrangements for the elections of June 2022, will the Chair advise –

- (a) the rationale for changing the filming arrangements offered for hustings;
- (b) what consultation, if any, was undertaken in reaching the decision on filming arrangements;
- (c) whether the change was identified as a cost-saving measure;
- (d) whether it is the Committee’s assessment that not offering localised filming for hustings is seen as a reduction of service to the public; and
- (e) why the decision was not brought to the States Assembly for debate?”

4. The Chief Minister tabled an answer on 7th March 2022 to the following question asked by Senator S.Y. Mézec:

“Will the Chief Minister provide –

- (a) the initial budget and timeline for the Government’s new Finance I.T. systems;
- (b) the current forecast of the total spend on these systems and the timeline for delivery;
- (c) the amount of the expenditure to date that there has been on project management; and
- (d) the reasons for any increase, if any, there has been in the forecasted total spend or change in the timeline over?”



5. The Minister for Treasury and Resources tabled an answer on 7th March 2022 to the following question asked by Deputy M.R. Higgins of St. Helier:

“In respect of the States of Jersey’s investment holdings, will the Minister advise Members of the following –

- (a) the extent, if any, that the holdings are directly invested in Russian-based assets;
- (b) the extent, if any, that the holdings are indirectly exposed to Russian-based assets through investments in companies that themselves are directly invested in Russian-based assets (for example, oil and gas companies); and
- (c) the effect any such investments are expected to have on the returns from Jersey investments, both in the short and longer term?”

6. The Minister for Infrastructure tabled an answer on 7th March 2022 to the following question asked by Deputy R.J. Ward of St. Helier:

“Will the Minister state –

- (a) whether there will be review of the contract with the HCT Group (LibertyBus) ahead of any new tendering process and, if so, when that review will take place;
- (b) whether the Minister will be responsible for undertaking any such review or, if not, which Minister shall take responsibility; and
- (c) what tendering process will be used for any new contract?”

7. The Minister for Social Security tabled an answer on 14th March 2022 to the following question asked by Deputy C.S. Alves of St. Helier:

“Further to the Minister’s response in December 2020 to the e-petition entitled ‘Follow Scotland and make period products free for all’ in which it was stated that she *“has, therefore, asked officers to undertake further research on this issue with a view to reporting findings to the States Assembly within the term of this Government”*, will the Minister advise –

- (a) what research, if any, has been conducted into period poverty since the response; and
- (b) if research has been conducted, what data were collected and what the results were?”

8. The Minister for Home Affairs tabled an answer on 14th March 2022 to the following question asked by Deputy C.S. Alves of St. Helier:

“In relation to settled status, will the Minister advise –

- (a) how many applications have been received since 30th June 2021;
- (b) what percentage of these applications have been rejected;
- (c) on what grounds any such applications have been rejected; and
- (d) how many people who are eligible for settled status are predicted not to have applied?”



9. The Minister for Home Affairs tabled an answer on 14th March 2022 to the following question asked by Deputy C.S. Alves of St. Helier:

“Since the introduction of work permits and stricter immigration controls following Brexit, will the Minister advise –

- (a) how many people, if any, have had to be removed from the Island for being in breach of these controls; and
- (b) what procedure was followed in the lead-up to the removal?”

10. The Minister for Treasury and Resources tabled an answer on 14th March 2022 to the following question asked by Senator K.L. Moore:

“Will the Minister inform the Assembly what sum it has been agreed to pay the accountants who are providing an audit of the Co-Funded Payroll Scheme?”

11. The Minister for Treasury and Resources tabled an answer on 14th March 2022 to the following question asked by Deputy K.F. Morel of St. Lawrence:

“Will the Minister advise the Assembly of the number and value of Russian assets (whether equities in Russian companies, Russian government or corporate bonds or any other type of asset related to Russia, and whether traded on Russian or other exchanges) held in the Common Investment Fund on both 21st February 2022 and 1st March 2022; and whether any of these assets were linked to U.S., E.U. or U.K. sanctioned entities or individuals?”

12. The Minister for Health and Social Services tabled an answer on 14th March 2022 to the following question asked by the Connétable of St. John:

“Further to his statement in the States on 1st March 2022, will the Minister advise how many rehabilitation beds will be available in Samarès Ward from July to December 2022?”

13. The Minister for Health and Social Services tabled an answer on 14th March 2022 to the following question asked by the Connétable of St. John:

“Will the Minister advise how many rehabilitation patients were in Samarès Ward for each of the 12 months prior to its closure (including stroke patients, neurological patients, orthopaedic patients or any other patients using the ward for rehabilitation) and how many other occupants, if any, were there during this period?”

14. The Minister for Health and Social Services tabled an answer on 14th March 2022 to the following question asked by the Connétable of St. John:

“Will the Minister advise –

- (a) how Jersey has been rated for Junior Doctors in the Wessex region for each of the last 6 years;
- (b) how many applications have been received from Junior Doctors in each of the last 6 years;
- (c) whether there has been any warning that our continued membership of the Wessex Junior Doctor scheme is at risk; and
- (d) whether he will publish the latest Foundation School visit feedback report?”



15. The Minister for External Relations and Financial Services tabled an answer on 14th March 2022 to the following question asked by Deputy R.J. Ward of St. Helier:

“Will the Minister advise what registers of ownership of Jersey property and other assets, if any, are being used to enforce sanctions against Russian citizens identified as close to the Putin regime; and if no such registers exist, how are sanctions being enforced?”

16. The Chief Minister tabled an answer on 14th March 2022 to the following question asked by Deputy R.J. Ward of St. Helier:

“Will the Chief Minister advise what access, if any, has been given since 4th July 2021 to the current leader of the Jersey Alliance party to government buildings, including Broad Street, and to government officers?”

17. The Minister for External Relations and Financial Services tabled an answer on 14th March 2022 to the following question asked by Deputy K.F. Morel of St. Lawrence:

“Will the Minister advise the Assembly the reasons why, despite having the legal ability to do so, he has chosen not to implement E.U. sanctions against Russia in addition to those U.K. sanctions which have been implemented by the Government of Jersey; and will he state, given the decision not to implement such E.U. sanctions, what risk there is that there are individuals and entities which will not have any Jersey-based assets frozen or their ability to trade via Jersey reduced, despite being subject to E.U. sanctions?”

18. The Minister for the Environment tabled an answer on 14th March 2022 to the following question asked by Deputy M. Tadier of St. Brelade:

“Further to concerns I have raised about the wall surrounding Field B139 in St. Brelade (Parcq du Pont Marquet), has either the Minister or his officers inspected the wall and, if so, has it been assessed as being in an acceptable state of repair and safe under the relevant legislation; and if it has been assessed as being not safe and in an acceptable state, what steps will he take to ensure that action is taken by the owner or their agents to repair the wall?”

19. The Chair of the Privileges and Procedures Committee tabled an answer on 21st March 2022 to the following question asked by Deputy G.P. Southern of St. Helier:

“Given the Code of Conduct for Elected Members require that they should act solely in the public interest, will the Chair advise members –

- (a) what investigations, if any, have been undertaken into the actions of the Deputy of Grouville and Deputy Wickenden in lodging amendments to the Draft Bridging Island Plan that proposed re-zoning fields G403C, G403D and part of G432A for housing;
- (b) if no investigations have been undertaken, why not; and
- (c) whether the issue of “reversionary ownership” of land should be referred to the Commissioner for Standards?”



20. The Minister for Children and Education tabled an answer on 21st March 2022 to the following question asked by Deputy L.M.C. Doublet of St. Saviour:

“Following the Assembly’s adoption of ‘Legal parent status and parental responsibility for same sex parents’ (P.26/2022), will the Minister update members on whether legislation to remove the discrimination regarding the legal parent status and parental responsibility for same sex parents in Jersey will be lodged in time for consideration by the current Assembly; and, if so, when will he lodge the relevant Draft Law?”

“In relation to the Our Hospital project, will the Assistant Chief Minister explain –

- (a) how it was decided which officers would take part in the short-listing process and what consideration was given to their length of residence in the Island;
- (b) what consideration the Our Hospital Political Oversight Group (the “OH POG”) gave to the comments from the Senior Planning Officer regarding the planning application.
- (c) whether 2 fields to the north of Warwick Farm had been offered to the States and what assessment the OH POG made of how soon work could begin on Warwick Farm, when considering the site for the Hospital;
- (d) how the OH POG considered, in light of the Planning Officer's comments, the mass and height of the proposed development at Overdale;
- (e) what consideration was given by the OH POG to the roadworks that would be needed to provide access to the Overdale site, compared with what had been assessed in that regard in relation to Warwick Farm as a possible site; and
- (f) in light of the implementation of the Jersey Care Model, whether it is the OH POG’s assessment that Island needs a general hospital rather than an acute hospital?”

“Will the Chair –

- (c) indicate which meetings were in person and which were held remotely via Teams?”

“Is it the Government’s intention to use additional funds arising from the underspends in 2021 to provide additional funding to sponsored charities who have seen a decrease in funding, including the Jersey Women's Refuge?”

24. The Minister for Social Security tabled an answer on 21st March 2022 to the following question asked by the Connétable of St. Martin:



“What actions have been undertaken by the Government to review its long-term support for the Jersey Women’s Refuge, both in respect of annual grants and support for the recruitment of additional staff for the charity?”

25. The Minister for Health and Social Services tabled an answer on 21st March 2022 to the following question asked by Deputy L.M.C. Doublet of St. Saviour:

“Will the Minister state –

- (a) the level of grant, if any, provided by the Government to the Jersey Women’s Refuge in 2018, 2019, 2021 and 2022 (to date);
- (b) the estimate, if any, the Minister has undertaken of the proportion of overall expenditure incurred by the Jersey Women’s Refuge that was covered by the Government grant in each of those years;
- (c) what assessment, if any, he has made of the adequacy of the Government grant to the Jersey Women’s Refuge, in light of the services offered by the Refuge that support the Government’s strategy to tackle domestic violence; and
- (d) with reference to the response to Oral Question 297/2019, in which he indicated a wish to see an improvement in the Refuge’s funding situation in 2021, what steps, if any, he took to bring about that improvement?”

26. The Minister for Treasury and Resources tabled an answer on 21st March 2022 to the following question asked by Deputy L.M.C. Doublet of St. Saviour:

“Will the Minister commit to ensuring that departmental underspends from 2021 are utilised to make additional funding available to Jersey Women’s Refuge in 2022?”

The report states that discretion may be exercised to allow for a longer speech than 15 minutes where the member speaking is designated as the ‘main respondent’ to the debate.
