**Explanatory Note regarding subordinate legislation
tabled at this Meeting**

R & O 9457

The purpose of this Order is to increase the earnings limit above which a Class 1 insured person's earnings shall be disregarded in calculating his or her Class 1 contributions to £2,272 a month.

The Order was made on 26th October 1999 and comes into force on 1st January 2000.

R & O 9458

This Order increases the fee for the registration, or renewal of registration, of a lodging house to £9.40, with effect from 1st January 2000.

The Order was made by the Housing Committee on 18th October 1999 and comes into force on 1st January 2000.

R & O 9460

The purpose of these bye-laws is to amend the Building Bye-laws (Jersey) 1997 to increase the fees payable with applications for permits.

The bye-laws were made on 28th October 1999 and come into force on 1st January 2000.

R & O 9461

The purpose of this Order is to amend the Island Planning (Fees) (Jersey) Order 1997 to increase the fees payable with applications for permission to develop land.
