This Order increases the fees charged under 3 regimes administered by the Minister for Economic Development, Tourism, Sport and Culture. The fees are increased by 2% which is 0.7% below the rate of RPI(X) as of June 2017.

Article 1 amends the Places of Refreshment (Registration) (Fees) (Jersey) Order 2008 so as to increase the fee for an application for registration, or the renewal of registration, of premises as a place of refreshment under Article 4(1) of the Places of Refreshment (Jersey) Law 1967. That fee was last increased with effect from 1st January 2017.

Article 2 amends the Tourism (General Provisions) (Jersey) Order 1990 so as to increase the fees for registrations or renewals under Article 9(1) of the Tourism (Jersey) Law 1948. Those fees were last increased with effect from 14th October 2016.

Article 3 amends the Weights and Measures (Testing Fees) (Jersey) Order 2003 so as to increase the fees for testing, weighing or measuring equipment under Article 12(3) of the Weight and Measures (Jersey) Law 1967. Those fees were last increased with effect from 1st January 2017.

Article 4 provides for the title by which this Order may be cited and states when the provisions come into force. Article 2 comes into force 7 days after the Order is made and the remaining provisions of the Order come into force on 1st January 2018.

The Order was made on 14th December 2017 and came into force in accordance with Article 4.

# R&O.132/2017.

Long-Term Care (Benefits) (Amendment No. 5) (Jersey) Order 2017.

This Order further amends (by Articles 2, 3, 4(a) and (b) and 5) the Long-Term Care (Benefits) (Jersey) Order 2014. The overall effect of these amendments is to uprate by approximately 1.5% the value of long-term care benefit comprising weekly standard care costs of long-term care. A minor amendment is also made to Article 10 of that Order (by Article 4(c)) to reflect the position that such costs are accumulated towards the care costs cap at the same rate whether the care is provided in a care home, a group home, or a person's principal residence.

Article 1 of this Order is an interpretation provision and Article 6 gives the title by which it may be cited and provides for it to come into force on 1st January 2018.

The Order was made on 15th December 2017 and came into force on 1st January 2018.



#### R&O.133/2017.

Infrastructure (Driver and Vehicle Standards – 2018 Fees) (Jersey) Order 2017.

This Order increases the fees charged by Driver and Vehicle Standards (part of the Department for Infrastructure) from 1st January 2018 by an average of just under 2.5% (the fee increases being rounded to the nearest pound). The fee for the compulsory basic training course, however, is increased by *Article 5* by 3.3% (representing a cost of living increase).

The Order was made on 19th December 2017 and came into force on 1st January 2018.

#### R&O.134/2017.

EU Legislation (Sanctions – Russia) (Amendment) (Jersey) Order 2017.

Article 1 of this Order amends the EU Legislation (Sanctions – Russia) (Jersey) Order 2014 so as to give effect in Jersey to Council Regulation (EU) 2017/2212 of 30 November 2017 (OJ L 316/15, 1.12.2017) amending Regulation (EU) No 833/2014 concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine. The effect of the amendment is to permit technical assistance, financing or financial assistance related to the sale, supply, transfer or export and the import, purchase or transport of hydrazine in concentrations of 70% if the hydrazine is destined for tests and flights in the framework of the ExoMars 2020 space mission. Such technical assistance, financing or financial assistance would otherwise be prohibited by Article 4 of Regulation (EU) No 833/2014.

Article 2 gives the title by which this Order may be cited and provides for it to come into force on the day after it is made.

The Order was made on 19th December 2017 and came into force on 20th December 2017.

#### R&O.135/2017.

Long-Term Care Services (Health and Social Services Charges) (Amendment No. 5) (Jersey) Order 2017.

*Article 1* of this Order further amends the Long-Term Care Services (Health and Social Services Charges) (Jersey) Order 2014, to increase by approximately 1.5% the charges payable for the provision of long-term care services in a care home or group home.

Article 2 gives the title by which this Order may be cited and provides for it to come into force on 1st January 2018.

The Order was made on 19th December 2017 and came into force on 1st January 2018.

#### R&O.136/2017.

Environment (2018 Fees) (Jersey) Order 2017.

This Order uprates (by between 0.71% and 2.50%) certain fees chargeable under various enactments relating to the environment.

Article 1 amends the Animal Welfare (Licence Fee) (Jersey) Order 2008 so as to uprate (by between 1.14% and 2.50%) various licence fees prescribed by that Order. Those fees were last increased on 1st January 2017.



Article 2 amends the Artificial Insemination of Domestic Animals (Bovine Semen) (Jersey) Order 2008 so as to uprate (by between 0.71% and 2.47%) various approval, inspection and licence fees prescribed by that Order. Those fees were last increased on 1st January 2017.

Article 3 amends the Community Provisions (Bovine Embryos) (Fees) (Jersey) Order 2011 so as to uprate (by between 1.60% and 2.15%) fees prescribed by that Order for approvals, certificates and inspections. Those fees were last increased on 1st January 2017.

Article 4 amends the Community Provisions (Welfare of Animals during Transport) (Fees) (Jersey) Order 2014 so as to uprate (by between 1.43% and 2.22%) fees prescribed by that Order for authorizations, issuance of certificates of competence and certificates of approvals. Those fees were last increased on 1st January 2017.

Article 5 amends the Dangerous Wild Animals (Jersey) Law 1999 so as to uprate (by 2.36%) the fee chargeable for a licence under that Law. That fee was last increased on 1st January 2017.

*Article 6* amends the Endangered Species (CITIES) (Fees) (Jersey) Order 2012 so as to uprate (by between 2.31% and 2.50%) fees prescribed by that Order in respect of permits, certificates commercial licences. Those fees were last increased on 1st January 2015.

*Article* 7 amends the EU Legislation (Aquatic Animal Health – Fees) (Jersey) Order 2016 so as to uprate (by between 1.80% and 2.33%) fees prescribed by that Order for authorizations, inspections and registrations. Those fees were last increased on 1st January 2017.

*Article* 8 amends the EU Legislation (Veterinary and Zootechnical Checks – Trade with Member States) (Fees and Expenses) (Jersey) Order 2016 so as to uprate (by between 1.57% and 2.08%) fees and expenses prescribed by that Order for certificates and inspections. Those fees were last increase on 1st January 2017.

*Article* 9 amends the High Hedges (Application Fee) (Jersey) Order 2008 so as to uprate (by 2.29%) the application fee chargeable to assess the impact of a high hedge. That fee was last increased on 1st January 2017.

*Article 10* amends the Pet Travel Scheme (Fees) (Jersey) Order 2015 so as to uprate (by between 2.07% and 2.50%) fees prescribed by that Order for approvals and authorizations. Those fees were last increased on 1st January 2017.

# Article 11 –

- (a) amends Article 2 of the Planning and Building (Fees) (Jersey) Order 2008 (the "Development Fees Order") so as to uprate by 2.50% the maximum aggregate fee payable in respect of multiple applications for planning permission. That fee was last increased on 1st January 2017;
- (b) amends Article 2A to uprate (by 1.96%) the fee prescribed by that Order for each application to remove or vary a condition of planning permission. If there are more than 6 such applications, the fee is the equivalent of the total fees payable in respect of 6 applications. This fee does not apply in respect of an application to remove or vary a condition of planning permission granted under a Development Order (as defined in Article 1(1) of the Planning and Building (Jersey) Law 2002) or where the permission is subject to a condition that the development, to which the permission relates, must be begun before the expiration of a specified period;
- (c) amends Article 3 of the Development Fees Order so as to uprate (by 2.22%) the fee payable for a completion certificate;
- (d) amends the table in Schedule 1 to the Development Fees Order relating to the application fees for planning permission so as to uprate those fees (by between 1.69% and 2.47%);
- (e) amends the table in Schedule 2 to the Development Fees Order in respect of the application fees for building permission so as to uprate those fees (by between 1.42% and 2.50%); and
- (f) amends the table in Schedule 2 to the Development Fees Order in respect of appeals against refusal or deemed refusal of application for planning permission so as to uprate those fees (by 2.50%).

The fees in Article 2 and Schedules 1, 2 and 3 of the Development Fees Order were last increased on 1st January 2017 and the fee in Article 2A of that Order was introduced on that date.

Article 12 amends Plant Health (Field Inspections – Fees) (Jersey) Order 2014 so as to uprate (by 2.47%) the fee per vergée for inspecting *Narcissus* bulbs for infestation by stem and bulb eelworm. That fee was last increased on 1st January 2017.



Article 13 amends the Sea Fisheries (General Fees) (Jersey) Order 2010 so as to uprate (by 2.50%) the fee prescribed by that Order for licences and permits. Those fees were last increased on 1st January 2016.

Article 14 amends the table in Schedule 1 to the Waste Management (Fees) (Jersey) Order 2008 so as to uprate (by between 1.75% and 2.50%) various licence, consignment note and registration fees. Those fees were last increased on 1st January 2017.

Article 15 provides for the title of this Order and for it to come into force on 1st January 2018.

The Order was made on 20th December 2017 and came into force on 1st January 2018.

# R&O.137/2017.

Income Tax (Actuarial Equivalents) (Jersey) Order 2017.

This Order revokes and replaces the Income Tax (Actuarial Equivalents) (Jersey) Order 2002 (Article 4) and prescribes the manner for determining the actuarial equivalent of –

- (a) income from securities purchased by a trust for the purposes of Article 131E(4)(a)(i) of the Income Tax (Jersey) Law 1961 (*Article 2*); and
- (b) certain income payable for life for the purposes of Article 131F(3)(d) of the Income Tax (Jersey) Law 1961 (Article 3).

Article 5 sets out the title of this Order and provides for it to come into force the day after it is made.

The Order was made on 22nd December 2017 and came into force on 23rd December 2017.

#### R&O.138/2017.

Income Tax (Minimum Retirement Capital) (Jersey) Order 2017.

This Order sets out -

- (a) under *Article* 2, the method for determining the threshold for relevant capital for the purpose of determining an individual's entitlement to minimum retirement capital in accordance with Article 131FA of the Income Tax (Jersey) Law 1961 (the "Law" as defined in *Article* 1);
- (b) the amount and nature of relevant capital for the purposes of Articles 131FA and 131FB of the Law (*Article 3*); and
- (c) the relevant capital factor (for the purpose of calculating an individual's minimum retirement income) under Article 131FB of the Law (*Article 4*).

Article 5 sets out the title of this Order and provides for it to come into force 7 days after it is made.

The Order was made on 22nd December 2017 and came into force on 29th December 2017.

## R&O.1/2018.

Immigration (Control of Entry Through Republic of Ireland) (Jersey) Order 2018.

This Order is made by the Minister for Home Affairs in pursuance of section 9 of the Immigration Act 1971 ("the 1971 Act") as extended to Jersey with modifications made by the Immigration (Jersey) Order 1993 and the Immigration (Jersey) (Amendment) Order 2017 ("the 2017 Order in Council") which was registered by the Royal Court on 3rd November 2017, and came onto force on 10th November 2017.

The Common Travel Area ("the CTA") is established as a matter of Jersey law by virtue of section 1(3) of the 1971 Act as extended *viz*:



"(3) Arrival in and departure from the [Bailiwick of Jersey] on a local journey from or to [the United Kingdom, the Bailiwick of Guernsey, the Isle of Man] or the Republic of Ireland shall not be subject to control under this Act, nor shall a person require leave to enter the [Bailiwick of Jersey] on so arriving, except insofar as any of those places is for any purpose excluded from this subsection under the powers conferred by this Act; and in this Act the [Bailiwick of Jersey] and those places, or such of them as are not so excluded, are collectively referred to as 'the common travel area'."

There is a power by Order, in the United Kingdom and in Jersey, to impose certain restrictions and conditions on non-British citizens otherwise travelling lawfully within the CTA. The power to impose restrictions and conditions vests in the Secretary of State in the United Kingdom; but the corresponding power in Jersey vested partly in the Minister for Home Affairs and partly in the Lieutenant-Governor until the 2017 Order in Council came into force. Since then the corresponding power in Jersey has vested fully in the Minister in the same way as it vests fully in the Secretary of State in the United Kingdom.

The purpose of this Order is to repeal the Immigration (Control of Entry Through Republic of Ireland) (Jersey) Order 2015 which was made jointly by the Lieutenant-Governor and the Minister for Home Affairs before the 2017 Order in Council came into force, and to re-enact equivalent provisions in the name solely of the Minister for Home Affairs, in accordance with the 2017 Order in Council.

The Order was made on 8th January 2018 and came into force on 15th January 2018.

#### R&O.2/2018.

Immigration (Removal Directions) (Jersey) Order 2018.

This Order is made by the Minister for Home Affairs in pursuance of section 10 of the Immigration and Asylum Act 1999 ("section 10") as extended to Jersey, with modifications and exceptions, by the Immigration and Asylum Act 1999 (Jersey) Order 2003, as amended by the Immigration (Jersey) (Amendment) Order 2017 ("the 2017 Order in Council").

Section 10 provides that a person who is not a British citizen may be removed from Jersey in accordance with directions given by an immigration officer, if certain conditions are met. Directions under section 10 may be given only to persons falling within a class prescribed by Order; and that such directions may impose any requirements of a kind prescribed by Order. The power to make Orders for these 2 purposes vested in the Lieutenant-Governor under the Immigration and Asylum Act 1999 (Jersey) Order 2003; and the relevant prescribed classes and prescribed conditions were laid down in the Immigration (Removal Directions) (Jersey) Order 2004 ("the 2004 Order") made by the (then) Lieutenant-Governor.

The 2017 Order in Council now provides for the Order-making function under section 10 to vest in the Minister for Home Affairs. The purpose of the draft Order is therefore to repeal the 2004 Order, and to reenact equivalent provisions in the name of the Minister for Home Affairs, in accordance with the 2017 Order in Council.

The Order was made on 8th January 2018 and came into force on 15th January 2018.

### R&O.3/2018.

The Law Society of Jersey (Disciplinary Proceedings) Rules 2018.

The Law Society of Jersey (Amendment No. 4) Law 2017 ("the amending Law") was registered by the Royal Court on 27th July 2017. The amending Law has yet to be brought into force by the States.

One of the purposes of the amending Law is to revise and improve the procedures in The Law Society of Jersey Law 2005 for dealing with complaints of professional misconduct against advocates and solicitors. Another purpose is to make provision for the recognition and disciplinary control of legal services bodies.



The amending Law made fresh provisions for the Superior Number of the Royal Court to make Rules in connection with the procedures to be followed when complaints of professional misconduct are made. These Rules have been made pursuant to those provisions.

The Rules consist of 5 Parts.

Part 1 consists of Rule 1 which contains definitions for the purposes of the Rules.

Part 2 consists of Rules 2 and 3 setting out initial procedures in relation to a complaint once a *prima facie* case has been established.

Part 3 consists of Rules 4 to 7 relating to procedures upon the reference of a complaint to a disciplinary committee.

Part 4 consists of Rules 8 to 14 relating to hearings and evidence.

Part 5 consists of Rules 15 to 17 which make miscellaneous provisions including the citation of the Rules.

The Rules were made by the Superior Number of the Royal Court on 10th January 2018 and (under Rule 17) are expressed to come into force on the same date as the amending Law (which has yet to be brought into force by Act of the States).

1. The Minister for Treasury and Resources will table an answer to the following question asked by Deputy J.A.N. Le Fondré of St. Lawrence –

"Within the last 5 years, has the States, or any States-owned entity such as the Ports of Jersey, made any form of charge for any vessel under their control assisting another vessel, including taking such vessel under tow?

If so, will the Minister identify, by year, the number of occasions and the total amount charged in each year?"

2. The Chief Minister will table an answer to the following question asked by Deputy G.P. Southern of St. Helier –

"Further to his statement to the Assembly on 11th December 2017, will the Chief Minister –

- (a) define the "certain economic substance tests [undertaken] prior to the approval of new regulated entities" by the Jersey Financial Services Commission and which contribute evidence that "Jersey is a jurisdiction of substance";
- (b) explain what "concerns were highlighted by the [E.U.] Code Group that Jersey did not satisfy [the Group's] Criteria 2.2" regarding fair taxation and the attraction of profits without real economic activity;
- (c) outline his understanding of the mechanisms which could be regarded by the Code Group as enabling, or permitting, breaches of Criteria 2.2 and explain what changes to the Island's "regulatory and legal framework and additional accounting and reporting obligations" he consequently has under consideration in order to eliminate concerns over Criteria 2.2; and
- (d) commit to publish revised GDP calculations for 2015/2016 to show the full scale of profits recorded by companies associated with the Island, so that the scale of the difference between GNI and GDP as a result of the relocation of profits to the Island for which there is no locally-associated economic activity can be identified?"
- 3. The Chief Minister will table an answer to the following question asked by Deputy G.P. Southern of St. Helier –

"Further to the responses to written questions 1(504) and 1(632), will the Chief Minister –

- (a) publish the report commissioned in 2017 from the Jersey Financial Services Commission (J.F.S.C.) indicating the total amount of profits reported for 2015 by regulated companies subject to tax at 0%; and if not, why not;
- (b) give a breakdown of the profits of the 6,000 companies covered, between those incorporated locally and those resident but incorporated elsewhere; and explain how estimates of £2.1 billion of profits subject to 0% tax, and of £1.2 billion of profits subject to higher rates of tax, were made;
- (c) advise whether 4,100 (9%) of the 45,000 companies considered resident in Jersey are trading, with 91% of companies therefore falling outside the tax system (albeit evidence for this is not available in 87% of cases); and



- (d) advise whether around 1,250 (2.8%) of companies linked to Jersey pay tax; whether, of total personal income tax, more than £179 million (44%) arise from the distribution of profits from Jersey companies; and
- (e) provide an estimate of any revenue lost as a result of profit deferral for tax purposes by local companies and state what measures he is considering to address this?"
- 4. The Chief Minister will table an answer to the following question asked by Deputy G.P. Southern of St. Helier –

"Is it the case that, prior to 2017, Jersey authorities did not seek, and could not therefore gather, information on the profits made and tax paid by some 87% of companies either registered in, or associated with, the Island? If so, will the Chief Minister explain how it can be claimed that the Island is fully co-operative on transparency through the automatic sharing of information and that it can be known what profits can be linked to genuine economic activity?

Is it the Chief Minister's assessment that, in order to satisfy the substance test contained in the E.U. Code Group's criteria 2.2, the Jersey government should –

- (a) require all companies incorporated in, or associated with, the Island by way of a permanent establishment to file a set of accounts and tax return with its tax authority annually; and
- (b) ensure that those companies will be presumed to be taxable in Jersey unless they can provide evidence that they have declared their profits and have been, or will be, assessed for tax in another place;

and, if not, will he outline what alternative proposals he has under consideration which will satisfy the E.U. Code Group's criteria?"

5. The Minister for Social Security will table an answer to the following question asked by Deputy G.P. Southern of St. Helier –

"Given the definition of zero-hours contracts from the Jersey Advisory and Conciliation Service (JACS) that they are "arrangements where people agree to be available for work 'as and when' required but that no particular number of hours or times of work are specified" and that "these contracts are also used by Temporary Staff Agencies that supply temporary staff to other organisations but where there is no guarantee that work will be available", will the Minister advise –

- (a) whether this definition applies to zero-hour contracts used by her Department and whether her Department continues to recruit staff from employment agencies for whom there is a "mutuality of obligation" (in that the both employer and employee expect regular hours to be required and supplied, albeit sometimes on a short term 6-monthly basis);
- (b) if so, whether she has undertaken any assessment of the appropriateness of continuing to use zero-hour contracts for these placements and whether she has reviewed on a regular basis the terms of the zero-hour contracts of such staff, as recommended by JACS; and
- (c) what hourly rate these staff receive and how that compares with other employees doing similar tasks, along with any further differences in terms and conditions?"



The Minister for Social Security will table an answer to the following question asked by Deputy G.P. Southern of St. Helier -

"In respect of promoting additional pension saving by the Island's workforce, will the Minister advise -

- (a) what progress, if any, she has made in developing policy in this area in the last 18 months and, if none, why;
- (b) whether she or her officers have had meetings during this period with the Minister for Treasury and Resources or his officers where this was an agenda item and, if so, will she release any notes / minutes of such meetings;
- (c) given that "developing stakeholders" was a target for 2017, what meetings have been held with organisations such as the Institute of Directors, the Chamber of Commerce, insurers, actuaries or others, and will she release the notes / minutes of any such meetings and state what new targets have been set for 2018;
- (d) whether her Department has done further research on the results from the 2015 Jersey Annual Social Survey on pension provision, including on what proportion of the workforce (by age and by income quintile) has additional pension provision or will be reliant on States support; and
- (e) when she expects to bring forward proposals for workplace / stakeholder pension provision to match developments in Guernsey and the U.K.?"
- The Chief Minister will table an answer to the following question asked by Deputy S.Y. Mézec of St. Helier -

"Will the Minister provide a breakdown of how the eGov budget has been spent, including how much on which projects?

Will he also provide details on what further digital projects have not been completed, if any, and the estimated budget required to complete these projects?"

The Minister for Social Security will table an answer to the following question asked by Deputy S.Y. Mézec of St. Helier -

"Will the Minister provide the details of how many self-employed Islanders are paying Class 2 Social Security contributions within in each of the following income bands; and will she further outline how much revenue is raised in each income band from those earners?

"Will the Minister provide a list of approved medicinal cannabis products that he will make available in Jersey; and will he also confirm that existing products such as 'Sativex', and any new products, will be made available on free prescription where prescribed by a G.P. or from the General Hospital, and if not, why not?"

10. The Minister for Home Affairs will table an answer to the following question asked by Deputy M. Tadier of St. Brelade –

"Specifically, what problems have been identified, if any, with the transportation of what will be approved medicinal cannabis products to Jersey, and has there been a delay in their transportation? If there has been a delay, what steps have been taken to make sure these products can be brought to the Island without further delay? What dialogue has taken place between the Minister and the Minister for Health and Social Services in this regard in the past two months?"

11. The Minister for Economic Development, Tourism, Sport and Culture will table an answer to the following question asked by Deputy M. Tadier of St. Brelade –

"Will the Minister give consideration to supporting Visit Jersey's recent campaign to attract more winter visitors to the Island by –

- (a) ensuring that more Jersey Heritage sites are kept open over the winter months, even once a week, to ensure that sufficient activities are available to tourists;
- (b) reducing or scrapping airport fees for incoming flights during certain winter months; and
- (c) attracting a well-regulated casino to operate in the Island?

If not, why not?"

12. The Minister for Health and Social Services will table an answer to the following question asked by Senator S.C. Ferguson –

"Since the launch of the LEAN initiative within Health and Social Services, will the Minister advise, to date –

- (a) how much has been spent in total on LEAN initiative;
- (b) how much LEAN costs annually;
- (c) how much has been saved as a result of LEAN projects on an annual basis;
- (d) how many projects have been completed;
- (e) how many projects are currently in progress;
- (f) how many Chief Officers, senior managers and consultants have been involved and whether a senior manager or senior consultant has been involved in every project?"
- 13. The Chief Minister will table an answer to the following question asked by Senator S.C. Ferguson –

"How many attempts, if any, were made to obtain access to inappropriate or pornographic websites from computers linked to the States system during 2017?"



14. The Chief Minister will table an answer to the following question asked by Deputy M.R. Higgins of St. Helier –

"Will the Chief Minister advise –

- (a) how many public servants were removed or transferred from their positions in the Health and Social Services Department after being named in the Independent Jersey Care Inquiry Report;
- (b) what roles they undertook within the department;
- (c) how many of them were subsequently reinstated in their former role or in a new role involving children or vulnerable people; and
- (d) explain in complete detail the nature of the investigation into these individuals including who carried out the investigation and the process that was used throughout?"
- 15. The Chairman of the States Employment Board will table an answer to the following question asked by Deputy M.R. Higgins of St. Helier –

"Will the Chairman advise -

- (a) how many men and how many women are employed in the public sector;
- (b) how many employees receive equal pay for equal or comparative work;
- (c) if there is a disparity between men and women's pay, what the percentage disparity is, giving examples;
- (d) if there is a disparity, what it would cost the States of Jersey to pay men and women the same wage rate for equal or comparative work?"
- 16. The Chief Minister will table an answer to the following question asked by Deputy M.R. Higgins of St. Helier
  - "Will the Chief Minister advise members whether the material collected by the Independent Jersey Care Inquiry that has been given to Jersey Archive will be open for examination by the public and, if there are different release dates for some of the information, evidence what those release dates are?"
- 17. The Chief Minister will table an answer to the following question asked by Deputy M.R. Higgins of St. Helier
  - "With regard to the European Union's requirement for companies and, if applicable, trusts and foundations, to have real substance within the jurisdictions in which they reside for tax purposes, will the Chief Minister advise members –
  - (a) if the E.U. has advised the relevant Jersey authorities how they have defined the 'substance test', and if so what that test is; and
  - (b) if the E.U. does not have a common test, what test Jersey is proposing to use in this regard; and
  - (c) what knowledge he has of the test being used by Guernsey and the Isle of Man?"
