DRAFT RÈGLEMENT (200-) (ABROGATION) SUR LES PORTEFAIX

REPORT

Background

The Law Draftsman and Law Officers maintain an on-going review of Jersey law in order to ensure that any legislation that may be unnecessary or have fallen into disuse may be considered for removal from the Statute Book. The Règlement has come to light as a result of this review.

Considerations

The Règlement is very outdated. The penalty for operating as a porter within the Port of St. Helier is set at£1, the penalty for carrying the effects of more than one passenger at a time without the permission of a port officer is 2s 6d and the limit on the charges for porterage being 1s and 2s 6d.

Prior to discussion in 2004, the last correspondence on the matter shows an agreement, in 1966, that the Harbour Master would license porters on behalf of the Connétable of St. Helier, pending an amendment to the Règlement transferring the licensing function to the Harbour Master. No amendment ever appears to have been made.

The matter has been raised with the Connétable of St. Helier. He has confirmed that in his opinion the parish does not require the Règlement.

The fact is that the Règlement has fallen into disuse and accordingly the Harbours and Airport Committee believe it can be repealed without any detrimental effect.

Financial and manpower implications

There are no financial or manpower implications arising from this draft legislation.

Explanatory Note

These Regulations repeal the Règlement (1959) sur les Portefaix.

1 Repeal

The Règlement (1959) sur les Portefaix [5] is repealed.
